#### 7.3.1 Presentation on Body Worn Cameras

Inspector Jim Butler, HRP provided a presentation with respect to Body Worn Cameras. Commissioner Walker thanked Inspector Butler for his presentation and requested question of clarification from members of the Board.

In response to a question from Councillor Adams, Insp Butler advised that disclosure of the body worn cameras to the public would be part of a proposed governance model. With respect to the usage of body worn cameras in private residences, Insp. Butler advised that Officers would likely need to obtain consent for filming.

In response to question from Commissioner Parris, Insp. Butler advised that training with respect to cultural intelligences would likely appear in a proposed governance model and would also form part of the training component.

In response to a question from Commissioner Graham, Chief Blais advised that there are several issues that present with respect to the storage of data captured by body worn cameras, both in a technical sense and the legislative requirements involved with respect to the storage of data. Chief Blais noted that HRP continues to liaise with other jurisdictions who are working on the same policy development issues.

In response to a question from Commissioner Craig, Chief Blais advised that the Board has a role to play with respect to the potential development of policy surrounding body worn cameras. He further advised that HRP has the necessary budgetary resources to continue its work in this regard.

In response to a follow up question from Commissioner Craig, Acting Chief Superintendent Denis Daley advised that the RCMP has previously completed a two year feasibility study in which body worn cameras were piloted by RCMP members in the communities of Indian Brook First Nation and Windsor. He advised that the RCMP's experience had raised similar issues as noted in the presentation pertaining to privacy concerns and the storage of data. He advised that the RCMP is continuing its work in this regard.
