1. CALL TO ORDER

Councillor Dalrymple, Interim Chair, called the meeting to order at 10:02 am in the Halifax Hall, Main Floor, City Hall, 1841 Argyle Street, Halifax.

Round table introductions were made. The Chair acknowledged the presence of Councillors Craig and Nicoll.

2. APPROVAL OF MINUTES – May 23, 2013

MOVED by Councillor Fisher, seconded by Ms.Klenavic, that the minutes of May 23, 2013 be approved, as circulated. MOTION PUT AND PASSED.

6.2 Presentation – Traffic and ROW policies, procedures, standards – *Traffic* and ROW

Mr. Taso Koutroulakis, Acting Manager, HRM Traffic & ROW, gave a presentation to the Committee on Traffic and ROW policies, procedures and standards. Staff informed members that all crosswalks, policies, procedures and standards are governed by the *Nova Scotia Motor Vehicle Act* (MVA). Staff gave the Committee a definition of "crosswalk" as defined by the MVA.

Staff informed the Committee of s.90(1) of the NSMVA, as it pertains to crosswalks and its' authority to establish, designate and maintain or cause to be maintained at highways, crosswalks at intersections, highways and at other places as may be deemed

necessary. Staff also explained s.125(1) of the MVA pertaining to pedestrian and vehicle rights of way.

Discussion took place with questions and answers, including the following:

- How do we determine high risk areas, and be proactive instead of reactive.
- What are the spacing guidelines? NSMVA states what guidelines to use when it comes to painting lines and also depending on the situation where the crosswalk is located.
- Crossing times.
- · Legality of marked and unmarked crosswalks.
- Block access to roadways when a crosswalk is a few feet away.
- Promote walking and active transportation.

Staff closed the presentation by suggesting that it would be beneficial to have HRM Corporate Communications give a presentation on the recent HRM Pedestrian Safety campaign. Staff indicated that citizen education is best for crosswalk safety. The Chair thanked staff for the presentation.

The Committee requested that at the next meeting Mr. Koutroulakis explain how crosswalks are determined.

6.3 Presentation – Crosswalk Statistics – Halifax Regional Police

A copy of the presentation is available online and on file.

Staff Sgt. David Reynolds, Halifax Regional Police, gave a presentation on crosswalk statistics for 2013. Staff stated that proper statistics are not easy to obtain due to most crosswalk violations are reported to NSMVA.

Staff Sgt. Reynolds reviewed 2013 statistics collected to date, with regard to violations to s. 125 & 126 of the *Nova Scotia Motor Vehicle Act*. He also reviewed injury accidents by area.

Councillor Fisher left the meeting at 11:30 a.m.

Staff Sgt. Reynolds indicated that there have been no fatalities associated with crosswalks so far in 2013, and that in 2012 there were three.

The Committee discussed the statistics with staff, noting the following comments and questions by Committee members:

- Enforcement of cars not yielding to pedestrians
- Why is ticketing by police a judgement call?
- Are there trends regarding the time of year accidents happen?
- Negative scare tactic ads

- Violators are receiving more tickets
- Processing data from different departments is the biggest problem in which to maintain accurate statistics

Staff indicated that solutions to crosswalk safety still remain with education and awareness. Dr. Habib indicated to the Committee that work is now being completed from NSMVA, HRP and RCMP in HRM. Dr. Habib agreed to make a presentation on the work being completed at an upcoming meeting. The Chair thanked staff for the presentation.
