9. 1.1 Halifax Explosion 100th Anniversary Grants Program Recommended Awards: Fiscal Year 2015-16

The following was before the Committee:

A staff recommendation report dated January 19, 2016

Ms. Peta-Jane Temple, Team Lead, Tax, Grants, and Special Projects, explained the application scoring process to the Committee and provided a brief background on the members of HRM staff chosen to evaluate the applications. She provided an overview of each of the recommended grants and responded to questions of clarification from Committee members regarding the funding policy, the qualifications of applicants, strategies for risk management, and the required documentation for successful applicants.

Committee members commented, in response to recommended grant 6. Symphony Nova Scotia - Interpretation, that it would provide a lasting legacy if a recording of the concert was made, but that a live streaming of the event could potentially discourage actual attendance.

In response to recommended grant 7. St. Paul's Anglican Church – Ceremonial Event, Committee members discussed the importance of being sensitive to the wishes of family members of the victims of the Halifax Explosion. During this discussion the point was raised that that different faiths and different denominations of faith were important distinctions at the time of the Explosion and that it may not be appreciated by living family members to have all survivors memorialized in a single faith-based service.

In consideration of recommended grant 8. Halifax Community Planning and Design Association/PLANifax Production Co-Operative Limited – Educational, Committee members noted that the Hydrostone development was not universally welcomed and was the subject of controversy for at least ten years following its construction. Committee members remarked on the importance of this project providing a careful representation of the history of this district.

10. It was noted that recommended grant 10. Halifax Camerata Singers – Interpretation would perform at the First Baptist Church on Oxford Street and that St. Mark's Baptist, as listed in the staff report, may be a typo.

MOVED by Ms. Jessup, seconded by Ms. Gruszecki

THAT the Halifax Explosion 100th Anniversary Advisory Committee recommend that the Grants Committee recommend Regional Council approve:

1. 10 awards as detailed in the Discussion section of the report dated January 19, 2016 for a combined total of \$90,760 from Account M311-8004 Community Grants Program.

The Committee discussed the possibility of the national poet laureate overshadowing any potential work done by the municipal poet laureate.

In response to questions of clarification from Committee members, Mr. Jamie MacLellan, Community Developer, Parks and Recreation commented that it would be appropriate for HRM staff to contact Mr. Clark and express the interest of the Committee in his potential commemorative work on the Halifax Explosion.
