7.4.1 Appointment of HAC representative to the Urban Design Task Force

The Chair advised that Mr. Butler is no longer able continue as the representative on the Urban Design Task Force, due to increased demands on his time. The Chair asked if there was anyone else who wanted to sit on the Task Force as the Committee's representative.

Mr. Terauds volunteered to be the Committee's representative. The Chair thanked Mr. Terauds and noted that Mr. Butler would provide him his information on the Urban Design Task Force. The Chair also asked the Legislative Assistant to follow-up and notify appropriate staff in regard to the change in representation.

8.1 H00194: Request for approval of alterations to 782 East Chezzetcook Road, East Chezzetcook

A staff report dated November 21, 2006 was submitted.

Ms. Randa Wheaton, Planner II, outlined the application by Ms. Francesca Rogier for approval for substantial alterations to a municipally registered heritage property at 782 East Chezzetcook Road, East Chezzetcook. In her remarks, Ms. Wheaton explained that as part of a restoration project, the applicant is proposing to repair the deteriorating foundation walls under the addition to the house; and to create a two-car garage, which involves excavating under the building and under an existing deck. She added that his will involve substantial digging, and the removal of the existing retaining wall and replacement with concrete clad in natural field stone from the area. Mr. Wheaton pointed out that the project will also change the existing driveway from the front of the building to the side, and it will be partially hidden. This will provide a better view of the heritage house.

Ms. Wheaton responded to questions.

MOVED by Mr. Butler, seconded by Mr. Shakotko that the Heritage Advisory Committee recommend approval of the alterations to 782 East Chezzetcook Road as proposed in the November 21, 2006 staff report. MOTION PUT AND PASSED.
