# 7.1.1 Case H00370: Application to consider 7962 Highway #7, Musquodoboit Harbour, as a Municipally Registered Heritage Property

A staff report dated November 20, 2012 was submitted.

For the information of the new councillors on the Committee, Ms. Holm reviewed the process for applications for registering heritage properties.

Ms. Collette Bishop-Greene, CBG Heritage Research Services provided the presentation outlining the history and architectural features of 7962 Highway #7 Musquodoboit Harbour which was originally an elementary school and is now used as a community gathering place owned by the Old School Community Gathering Co-op Ltd. and who is the applicant for the registration.

Ms. Bishop-Greene and Ms. Holm responded to questions.

The Committee reviewed the application, evaluating it against the HRM Criteria for Registration of Heritage Buildings and scoring it as follows:
