- 7.1 STAFF

7.1.1 Case 19329: Development Agreement Amendment, 930 and 932 Bedford Highway, Bedford

The following was before the Heritage Advisory Committee:

• A staff recommendation dated January 28, 2015.

Ms. Jacqueline Belisle gave a presentation on the proposed changes to the facades of the Tim Hortons restaurant located at 930 and 932 Bedford Highway. This property abuts the Moirs Mill tourism centre, located at 920 Bedford Highway, which is a municipally, provincially and federally registered heritage property. She explained that the existing development agreement for the Tim Hortons building contains specific requirements pertaining to the site's design and external appearance. Ms. Belisle explained that the original agreement from 1989 was revised in 2000 to allow for the addition of a drive-through window. She provided illustrations of the proposed additions of a stone parapet, red siding and gooseneck lighting and informed the Committee that no one attended the Public Information Meeting on the proposed changes and that staff did not have any concerns with the amendments to the development agreement. In her remarks, Ms. Belisle advised that the criteria in which the Committee is to review the proposal against is Policy Z-3 subsections 5.x and 6.vii of the Bedford Municipal Planning Policy and Policy Ch-16 of the Regional Plan.

Ms. Belisle and Ms. Holm responded to questions.

The Chair opened the floor for debate. No one expressed any concern with the proposal. There was general consensus that the proposed revisions would improve the appearance of building.

MOVED by Mr. Cooke, seconded by Ms. Van der Leest that the Heritage Advisory Committee recommend that North West Community Council:

- 1. Give Notice of Motion to consider the proposed amending Development Agreement as set out in Attachment A of the November 26, 2014 staff report to allow for changes to the front façade of the Tim Hortons Building at 930 and 932 Bedford Highway, and schedule a public hearing;
- 2. Approve the proposed amending Development Agreement as set out in Attachment A of the November 26, 2014 staff report to allow for changes to the front façade of the Tim Hortons building at 930 and 932 Bedford Highway; and
- 3. Require the agreement be signed by the property owner within 120 days, or any extension thereof granted by Council on request of the property owner, from the date of final approval by Council and any other bodies as necessary, including applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.
