The meeting was called to order at 2:28 p.m., and adjourned at 3:21 p.m.

The Chair called the meeting to order at 2:28 p.m. in Halifax Hall, City Hall.

- 9.1 Staff:
- 9.1.1 Case H00413: Request to Register 2263 Brunswick Street, Halifax as a Municipal Heritage Property

The following was before the Heritage Advisory Committee

• A staff recommendation report dated November 16, 2015.

Ms. Shilo Gempton, Heritage Planner, provided the staff presentation on the request by Regional Council to initiate a heritage registration of St. Patrick's Church, 2263 Brunswick Street as a municipal heritage property, on behalf of the Roman Catholic Episcopal Corporation. Ms. Gempton explained that this application corrects an administrative error that occurred in 1982 when the property was to be registered as a heritage property, but by mistake, the adjacent property—the Rectory—had been registered. She noted that this error came to light earlier this year when the Roman Catholic Episcopal Corporation decided to sell St. Patrick's Rectory and found out that it had been registered as a municipal heritage property instead of the Church. Ms. Gempton advised that when the evaluation was carried out on the Church in 1982, the criteria was different, therefore staff are recommending the Committee review the

application and evaluate it based on the current criteria. Ms. Gempton lead the Committee through the scoring evaluation. The Committee scored the property as follows:

THAT the Heritage Advisory Committee recommend that Regional Council:

- 1. Set a date for a heritage hearing to consider the heritage registration; and
- 2. Approve the registration of 2263 Brunswick Street, as shown on Map 1, as a municipal heritage property.

Councillor Hendsbee suggested that it may be helpful to include the PID numbers in addition to the civic numbers when recommending registration, as it could prevent a similar issue from occurring in the future.

The Chair requested that when the application goes forward for registration, that staff include the PID number along with the civic number.

9.2 SCHMIDTVILLE STAKEHOLDER STEERING COMMITTEE

9.2.1 Update

Ms. Janet Morris provided an update from the Schmidtville Stakeholder Steering Committee. She advised that subcommittees have been established to consider streetscape improvements and heritage grants and each will be establishing a public meeting to get public input. She added that the committee is

concerned about a recent amendment to the Heritage Property Act that has a provision that a property in a heritage district can be deregistered and demolished if it is determined the property owners cannot afford to maintain the heritage building.

Mr. Jacob Ritchie addressed the Committee and advised that last May the Province approached the municipality with a set of amendments for review. He noted that in 2008 the Municipality had proposed changes to the Heritage Property Act, but these were not reflected in the most recent amendments the Province put forward. He indicated that the amendments are before Law Amendments but staff cannot address the Law Amendments Committee without Council direction. Mr. Ritchie added that the Municipal Solicitor has been previously given direction by Council to speak to the Law Amendments Committee, but it was in relation to previous matters.

Mr. Ritchie advised that staff have carried out a review internally on Bill 118, amendments to the Heritage Property Act and can provide this information to the Committee, as a way to better understand the proposed changes to the Act..

That staff provide their review of Bill 118, amendments to the Heritage Property Act to the Committee for the Committee's information only.

Further to Ms. Morris' update from the Schmidtville Stakeholder Steering Committee, Mr. Ritchie advised that the Committee are discussing three issues and have formed subcommittees. The issues are: finance incentives for property owner; streetscape design, and density and building forms. He added that in January each subcommittee will be hosting a public meeting. Staff will forward the meetings dates to the Heritage Advisory Committee and he extended an invitation to all attend.

9.3 APPOINTMENT OF HERITAGE ADVSIORY COMMITTEE MEMBER TO THE OLD SOUTH SUBURB STAKEHOLDER STEERING COMMITTEE

The Chair explained that Ms. Van der Leest was the Committee's appointee to the Old South Suburb Stakeholder Steering Committee, and that she has decided not to re-offer to serve on the Heritage Advisory Committee, therefore, another appointee needs to be chosen to be the Committee's representative on the Old South Suburb Stakeholder Steering Committee.

A brief discussion ensued, and it was agreed to defer this matter to the January meeting.
