Correspondence received in the Clerk's Office on August 24, 2016 from Ms. Peggy Cunningham,
 PhD, Save Young Avenue Group, in regard to Campbell/Fram Property: 825 Young Avenue.

At 3:07 p.m. Ms. Camaño entered the meeting.

In response to a question whether additional information on this topic had been submitted, the Chair advised that no other information had been submitted for the Committee. He added that Alan North of the Save Young Avenue Group had contacted him directly with regard to the application for heritage

registration for 825 Young Avenue and he explained the process and the Committee's role in this regard to Mr. North.

Ms. Morris advised that she had circulated to the Committee and staff via e-mail information on 825 Young Avenue, and she suggested that, in the absence of a staff report, staff provide an oral report and the Committee could use the information she circulated to evaluate and score the property.

The Chair explained that this was not possible as the Committee's Terms of Reference and Administrative Order 1 are clear in how the Committee is to deal with such matters, and that the Committee requires a staff report with recommendation in order to deal with an application for heritage registration.

In response to a question, Ms. Maggie Holm, Planner III advised that an application for heritage registration of the property has been submitted to staff and it is in the que with other applications and workload priorities. She added that if it was the wish of Council to have this particular application addressed ahead of others, Council would have to provide that direction to staff.

The Chair noted that given the Committee's mandate, it was limited in what it could do in regard to advancing the application for registration of 825 Young Avenue. He suggested that if Committee members felt there was urgency to this matter, then, as in the situation of 851 Young Avenue, the Committee could put forward a recommendation to Regional Council that it consider expediting the application.

In his remarks he noted that the Centre Plan will have a focus on heritage conservation districts and cultural landscapes. He added that staff anticipates the Centre Plan will elevate the conversation around heritage. Mr. Ritchie also noted that staff are working at speeding up the processes around heritage conservation districts and cultural landscapes, advising that the process for creating a heritage conservation district currently is too long and should be able to be completed in under a year.
