4.1 H00161 - Application for Registration of 5660 Fenwick Street Halifax

C A staff report dated March 7, 2005, was before the Committee for its consideration.

Ms. Alfreda Withrow, Research Consultant, presented the report to the Committee and responded to questions of the Committee.

It was noted that

- there is a small addition to the back of the house.
- there are three similar homes next to 5660 Fenwick Street, Halifax that have not been modified, to maintain continuity may have to flag as potential streetscape

Mr. Clarence Butler commented that if the application is approved the neighbouring houses may follow.

It was suggested that a letter and application form be sent to the other residents.

MOVED by Councillor Sloane, seconded by Mr. Clarence Butler, that the Heritage Advisory Committee provide support for Application #112 at 50% of cost up to \$5,000 with paid receipts. MOTION PUT AND PASSED UNANIMOUSLY.
