# 4.3 Blue Mountain – Birch Cove Lakes Regional Park (staff information report to be circulated at meeting)

The following was before the Board for review:

- Submission from Burkhard Plache, Brent Fancott, Keith Vaughan, Allan Robinson
- A copy of the motion approved during the October 18, 2011 session of Regional Council requesting a staff report on the potential impact of the recent sale of lands on the Birch Cove Lakes Blue Mountain Wilderness Park

Mr. Paul Morgan, Planner, Planning and Infrastructure, provided an overview of the October 12<sup>th</sup> information report, explaining that part of the Bedford Waters Advisory Board's mandate is to make recommendations on the Birch Cove Lakes Watershed; therefore, Halifax Watershed Advisory Board is not requested to make recommendations. He informed the Board of the public meeting scheduled October 26,

2011. All Councillors have been informed of the meeting and that the Board members were welcome to attend.

Mr. Regan requested that future information/staff reports on the Birch Cove Lakes Regional Plan be forwarded to the Halifax Watershed Advisory Board for their information.

# 5.1 Case 17056: Application by Kim Huskilson to amend the Land Use By-law for Planning Districts 14/17 (Shubenacadie Lakes) to consider larger buildings for agricultural use (*Deferred September 21, 2011*)

A staff memorandum dated October 11, 2011 was before the Board for review.

Mr. Tyson Simms, Planner, Planning and Infrastructure, delivered a presentation on Case 17056 to the Board, noting a correction to 10.9 (a) (i) in the proposed Land Use By-Law amendments, which should be *50 acres*. Mr. Simms then introduced a staff proposal for a Land Use By-Law Amendment to add a third category of agricultural uses permitted within the Rural Residential and Rural Estate Zones, to cover private riding barns. He also responded to questions on the effects of this amendment in terms of future uses of the land, particularly in the event of a change of ownership.

The Board briefly raised a number of issues concerning storm water management, well location and the number of buildings permitted on the lot but accepted that these could not be added under the Land Use By-Law amendment.

MOVED by Mr. Thomas, seconded by Mr. Regan that the Halifax Watershed Advisory Board recommend to Marine Drive, Valley and Canal Community Council that with respect to Case 17056:

1. The proposed Land Use By-law Amendments, as outlined in Attachment D of the staff memorandum dated October 11, 2011, be approved with the addition of the word "solely" as follows:

"Riding Arena, Private -- Means a building used by the owners or occupants of the site on which the building is located solely for the training and exercising of their horses and is not used for commercial purposes, horse shows, rodeos or similar events to which there is a fee to participate or use the facilities."

2. The wording in the proposed Land Use By-law Amendments be changed, as presented by HRM staff, from 435,600 square feet to 50 acres.

The Chair informed the Board that she had attended the Halifax Water Technical Conference #2 on October 4, 2011. She gave a brief summary of the meeting and circulated a handout from the Conference titled "Key Messages".
