5.7 Burnside Extension

The Committee discussed the Burnside Extension and wondered if there will be a long term plan for the increase in traffic on Glendale from Cobequid Rd to the end of Glendale. It is felt this could cause issues with the transit system and the buses returning into the flow of traffic due to increased volume.

8.1 Commuter Rail

The North West Transit Advisory Committee recommends, to North West Community Council that prior to funds being spent on a feasibility study for the commuter rail, determine what CN Rail will charge the end service provider for use of the rails, as this is one of the more significant costs they will encounter.

MOVED by Mr. Cox, seconded by Mr. Scott that end service provider costs from CN Rail be determined prior to conducting a feasibility study. MOTION PUT AND PASSED.
