# 4.1 Project 00953 Wind Energy Facilities in HRM

A staff report dated February 2, 2011 was before the Committee for consideration.

The Chair read the recommendations as presented by staff from Project 00953.

MOVED BY Mr. Pettipas, seconded by Mr. Dykeman, that the Regional Plan Advisory Committee recommend that Halifax Regional Council:

- Give First Reading and set a public hearing date to consider amendments to the Regional MPS and the Community LUBs to create policy and regulations (typical examples are set out in Attachments "A and B" of the February 2, 2011 staff report) for the purpose of regulating Wind turbines in the Halifax Regional Municipality.
- 2. Adopt the amendments to the Regional MPS and Community LUBs as provided in Attachments A and B respectively of the February 2, 2011 staff report.

#### MOTION PUT AND PASSED.

Councillor Lund brought forward the suggestion that staff consider the implications of this plan on wilderness protected areas and the possibility of wind turbine installations on crown land.

# 7.1 5-Year Regional Plan Review Preliminary Scope and Process (verbal)

Staff provided a verbal presentation of the 5-Year Regional Plan Review, and requested feedback from the Committee. The following comments, concerns and questions were noted:

- Mr. Dykeman requested an indication of how much progress has been done in the past five years, and how the progress was measured. Staff are working on providing more detailed and measurable information from base line data, but it does not currently exist.
- Mr. Pettipas warned against using the term Greenbelt too loosely because there
  are few similarities between the way other cities and Halifax are developing
  greenbelts.
- The appropriate use of the term 'cost avoidance' versus the term 'cost saving was discussed at length.
- Mr. Dykeman pointed out that the data indicates that more business offices are being built in the suburbs, which could be interpreted as beneficial. Mr. Fillmore suggested that HRM must do a better job at encouraging densification.
- Mr. Pettipas recommended that once baseline data is in place, the review of the Plan in 5 years will provide significant data.
- Mr. Morley requested that Staff review any circumstances, including economic issues such as taxes, and not just development and construction issues.
- Brief discussion ensued on the possible elimination of rural centres from the visioning process. Councillor Hendsbee suggested that those areas of MetroX development would meet the greatest demand for growth.
- Committee members and staff discussed the need for a more robust communications plan to support this next phase of public engagement.
- The environmental impact of storm water and the problematic definition of wetlands was identified. Councillor Lund noted that wet lands that feed into rivers and streams require better management.
- The question of who reviews the regional plan and offers a second opinion was raised. Committee members requested staff hire a consultant to review.

Mr. Dykeman left the meeting at 4:42pm.

# MOVED BY Mr. Pettipas, seconded by Ms. Newcombe, that the 5-Year Regional Plan be reviewed by an independent consultant. MOTION PUT AND PASSED.

The Chair recognized committee members, Ms. Newcombe and Ms. MacLeod, as this was their last meeting, and thanked them for their contribution.
