## 6. DISCUSSION AND PRESENTATION

## 6.1 Managing Advertising Signage Provincial Highway 333

Ms. Holly Richardson made a presentation to the Committee on Managing Advertising Signage on Provincial Highway 333. Ms. Richardson gave the Committee an overview and options for the pilot project and how it came to be.

Overview:

- Signage clutter
- HRM and Communities wants solutions for the problems
- Public Highways Act Amended in 2011
- Working with St. Margaret's Bay Regional Tourist Association, Business and Community Representatives
- Options and costs explored
- Support for Uniform Directional Signs

Option:

- 1. Uniform directional Signs
- 2. Promotional Advertising Signs
- 3. No Signs

Ms. Richardson informed the Committee that these options were presented to Council and they decided in principal that they go with Option 1. The Committee was also informed that The Transportation Standing Committee will move to fine tune Option 1. The TSC is still awaiting approval from the province in regards to changes in the Bylaws. The TSC final report should come to Regional Council in September 2013 and then community consultations will begin.

Ms. Richardson answered questions from the Committee. The Chair had concerns regarding signage from the Municipality of Chester. Ms. Richardson stated that by-laws are being developed with the ability to extend signage in the future. Ms. Richardson also informed the Committee that HRM wants sustainability, cost neutral. She reminded members that this is a pilot project modelled after PEI's signage management.
