Mr. Gord Helm, Manager, Solid Waste Resources, provided an update to the Committee.

Following a brief discussion, the Committee requested the following changes be made to the November 26<sup>th</sup> letter:

- delete the last sentence of the last paragraph; the sentence should end with generation comparisons
- add the following closing paragraph: In recognition of your staff confirming that the 300 kg target is a Provincial target, HRM staff would welcome the opportunity

to assist and work with your staff and RRFB in the development of a practical and fair per capita kg/pp target per region, which HRM would then incorporate into its diversion message and education programs.

MOVED by Councillor Rankin, seconded by Councillor Karsten, that the Solid Waste Resource Advisory Committee recommend that Halifax Regional Council request that the Mayor sign and forward the November 26, 2010 letter, as amended, to Honourable Sterling Belliveau, Department of Environment.

A letter from Mr. Jack Mitchell, Chair, Community Monitoring Committee (CMC), dated September 9, 2010 was before the Committee for review.

Councillor Rankin provided an overview of the CMC's September 9<sup>th</sup> letter. He suggested forwarding the letter to Council and request that Council engage in discussions with CMC. He further noted that the Western Common has also requested that Council begin engagement with CMC.

MOVED by Councillor Rankin, seconded by Councillor Hum, that the Solid Waste Resource Advisory Committee forward Community Monitoring Committee's September 9, 2010 letter to Halifax Regional Council and request consideration be given to engaging discussions with the Community Monitoring Committee.

Councillor Karsten questioned why this letter was before the Committee when it is addressed to Mayor Kelly and Regional Council.

MOVED by Councillor Hum, seconded by Councillor Nicoll, that the motion be amended to include direction to staff to provide a report.

Mr. Gord Helm, Manager, Solid Waste Resources, further noted that staff was forwarded a copy of the letter via email and this matter is under review by the Executive Management Team (EMT).

#### 9.1 Diversion Opportunities – Amendments to By-law S-600

A staff report dated November 22, 2010 was circulated to the Committee.

Mr. Gord Helm, Manager, Solid Waste Resources, provided an overview of the November 22, 2010 staff report.

The Committee entered into discussion.

In response to a question raised by Councillor Uteck respecting solid waste collection for multi unit properties, Mr. Helm advised that staff has met with multi unit property owners to ensure compliance is being met. He noted that garbage shoots have been locked off and residents are required to deposit their materials in the waste room.

Mr. Helm further noted that clear bags are an incentive and would increase compliance 15-20%.

MOVED by Councillor Karsten, seconded by Councillor Hum, that Solid Waste Resource Advisory Committee recommend that Halifax Regional Council initiate the process to amend By-law S-600 respecting the following:

1. Reduce the garbage bag limit from 6 to 4 bags/containers for residential collection services:

- 2. Specify the use of clear bags for garbage for the residential and ICI sectors(s) including one opaque or black bag; and
- 3. Specify commercial multi-unit property owners provide occupants with a kitchen counter top mini bin.

Councillor Uteck requested the motion to be split.

In response to concerns raised by the Committee, Mr. Helm advised that education would be part of the process.

Councillor Fisher requested that *opaque* be removed from the motion, providing examples of various types of clear/white bags such as kitchen catchers, to which the Committee agreed.

The motion before the Committee read as follows:
