#### **5.1 10%** Challenge

A memorandum from Laurie Lewis, Diversion Planning Coordinator, regarding the above, was before the Committee for its consideration.

Ms. Laurie Lewis, Diversion Planning Coordinator, reviewed the 10% Challenge Campaign which will be officially launched on Wednesday, September 15, 2004, the details of which were contained in the memorandum before the Committee. Ms. Lewis noted the goal of the campaign is to thank residents who have done a good job and to target those that are not participating in the programs nor source separating. Councillors have also been invited to issue a challenge to their communities.

Mr. Jim Bauld, Manager, Solid Waste Resources, noted he will be emceing the press conference and will acknowledge the dedication of the Committee in overseeing the development and implementation of the strategy.

Mr. Bauld then reviewed some of the display information that will be used at the campaign launch. Councillor Rankin suggested a presentation, similar as the one made today, be provided to Regional Council.
