9.1 TAXIS VERSUS LIMOUSINES

Mr. Hindle will clarify through the solicitor's office whether the By-law should be interpreted to mean \$57.50 should be charged for an hour and any part of that hour **or** what is charged should equate to an hourly charge, i.e., \$28.75 would be charged for a one-half hour trip.

MOVED BY Mr. Richards and seconded by Ms. Coffey the minimum of \$57.50 an hour will be charged pending clarification from the solicitor's office. MOTION PUT AND PASSED

In reponse to a question, it was noted that the airport has \$53.00 as its fare that is posted. It is also listed as \$53.00 in the Limousine contract price list for the Airport.
