## 2.1 Case 00634 - Rezoning Application - 1226 Cole Harbour Road, Cole Harbour

A report from the Harbour East Planning Advisory Committee, dated December 14, 2004, was before Council.

MOVED by Councillor Younger, seconded by Councillor Karsten, that the Harbour East Community Council refuse to approve the rezoning of 1226 Cole Harbour Road from P-2 (Community Facility) Zone to R-2 (Two Unit Dwelling) Zone.

The reasons cited for the refusal were as outlined in the staff report and that the sewage treatment plant is at capacity and cannot support further development; therefore, the proposed rezoning would lead to an increase in density that may have an adverse effect on the plant.

### 2.2 Case 00642 - Amendments to Heritage Hills CDD, Eastern Passage

A report from the Harbour East Planning Advisory Committee, dated December 14, 2004. was before Council.
