Ms. Hanita Koblents, Planner, presented the staff report.

MOVED by Councillor McCluskey, seconded by Councillor Kent, that Harbour East Community Council:

- 1. Approve, by resolution, the non-substantive amendment to Can-Euro Investments Ltd's development agreement with the Municipality for a multi-unit residential building at 10 Horizon Court, as shown on Attachment A of the October 18, 2006 staff report (the amending development agreement) to allow for changes to a requirement to consolidate all lots.
- 2. Require the amending agreement to be signed within 120 days or any extension thereof granted by council on request of the applicant from the date of final approval by Council and any other bodies as necessary whichever approval is later, including applicable appeal periods, otherwise, this approval will be void and obligations arising hereunder shall be at an end.

- 12.1 <u>Case 00905 Substantive Amendment to Development Agreement -</u> Willow Ridge (Parcels B&C, Woodland Avenue)
- A report dated October 18, 2006, on the above noted was before Council.

## 12.2 <u>Case 00966 - Amendment to Russell Lake West Development</u> Agreement

A report dated October 27, 2006, on the above noted, was before Council.

MOVED by Councillor Karsten, seconded by Councillor McInroy, that the Harbour East Community Council enter into the amending agreement, presented as Attachment A to the October 27, 2006 staff report, which would:

- 1. Grant Clayton Developments Ltd. an extension from October 31, 2006 until December 31, 2006 to complete primary services associated with the extension of Baker Drive to the new interchange at Mount Hope Avenue and Highway 111 (the Circumferential Highway);
- 2. Give the company until July 1, 2007 to complete all other required work associated with this road extension in accordance with the terms of the Russell Lake West development agreement provided that financial security for completion of the work is provided in a form and amount acceptable to the Development Officer;
- 3. Require the amending agreement be signed within 120 days or any extension thereof granted by Council on request of the applicant from the date of final approval by Council and any other bodies as necessary whichever approval is later, including applicable appeal periods, otherwise, this approval will be void and obligations arising hereunder shall be at an end.

#### 12.3 Election of Chair and Vice Chair

MOVED by Councillor McCluskey, seconded by Councillor McInroy, that Councillor Kent be appointed as Vice Chair. MOTION PUT AND PASSED UNANIMOUSLY.

# 12.4 <u>Item 4.1.5 Installation of Speed Bumps or Two Sets of Stop Signs at Kingston Crescent and Birchwood Terrace and at Frederic Street and Birchwood Terrace</u>

Councillor McCluskey stated that since her request she has been receiving calls from residents who are seeking the status of the request. The Councillor requested the request be resubmitted and a report be brought forward for the December meeting.

#### 14. PUBLIC PARTICIPATION

Mr. McInnis, Dartmouth, spoke in support of the petition submitted by Councillor McCluskey and outlined the history of the proposed development.

Mr. Ernie Brennan, Ketch Harbour, commented that Dartmouth was being rapidly developed.

Mr. Don Mason, Dartmouth, spoke in support of the petition and opposition to the proposed development.

Mr. Dan Britton, Dartmouth, noted the holes in the fence along the Circumferential Highway by Penhorn Mall have not been fixed. He noted that in the area of Tantiling Crescent and Valkyrie Drive the walkways have shrubs growing through the fence and across the walkway. He noted the light at Sabra Court is completely blocked by a tree and the trees are growing over the chain link fence and make it dark for anyone using the pathway. Further, the ground is broken making for an uneven walking surface. He stated the trees and shrubs need to be cleared.

Ms. Marjorie Gibbons, Dartmouth, spoke in support of the petition presented by the residents of Admiralty Place.
