10.3.1 Canal Greenway and Sullivans Pond Banook Studies

Mr. Rudy Vodika, Coordinator, Real Property Policy, provided a presentation on the Canal Greenway and Sullivans Pond/Banook Study. Mr. Peter Bigelow regrets that he is unable to attend the Harbour East Community Council due to illness.

Canal Greenway Phase II - Coordinated Open Space Development Plan

MOVED BY Councillor McCluskey, seconded by Councillor McInroy, that Harbour East Community Council:

- 1. Approve the Canal Greenway Phase II Coordinated Open Space Development Plan as the preferred direction for the public lands associated with the Starr Property.
- 2. Forward this information to Regional Council to inform their discussions with respect to the five year Capital Plan.

Councillor McCluskey asked if there was any discussion with Sobeys regarding a land exchange. Mr. Vodika advised that this was not discussed specifically for the park area, although there was some previous dialogue with Sobeys as they contemplated the use of their property. HRM staff will continue land discussions with Sobeys.

Councillor Younger stressed the need to have the architectural features exposed. Mr. Vodika replied that the site will be kept open and it will be properly landscaped.

Councillor Younger noted that there are members of Shubie Canal Commission attending Community Council this evening.

Sullivans Pond Banook Masterplan Report

Councillor Younger questioned if there are plans for cost sharing through the sewer project. Mr. Dunphy, Director, Community Development, advised that this would be cost recovery and that the sewer is primarily in Burnside. The trail project is factored in the cost recovery.

- 13.1 <u>Case 00951: Development Agreement for 155 Ochterloney Street Downtown</u>
 Dartmouth

A report dated February 14, 2008 was before Council.

This is an application by Heritage Credit Union for a development agreement to permit a drive-through Automated Bank Machine at 155 Ochterloney Street, Downtown Dartmouth.

MOVED BY Councillor McCluskey, seconded by Councillor Barkhouse that Harbour East Community Council:

13.2 Highfield Park and Pedestrian Overpass

Mr, Dave McCusker, Manager, Regional Transportation, presented the staff report to Council. One of the alternative directions before Council is an overpass at the Burnside location. Mr. McCusker advised Council that one overpass could be built this year, with the remaining two in future years.

Councillor McInroy added that the highway in question is a provincial highway and should fall under Provincial jurisdiction.

Upon discussion, Council agreed that the best alternative at this time is to build the overpass at Burnside Drive.

Correspondence was received from Mr. Sean Patrick O'Boyle, Chair of Buses, Bikes and Carpools Committee, Greater Burnside Business Association, endorsing three overpasses being built across Highway 111.

MOVED BY Councillor Smith, seconded by Councillor McInroy that Harbour East Community Council:

- 1. Endorse a strategy which would result in three pedestrian overpasses being built, the first priority being an overpass at Burnside Drive location.
- 2. Any cost savings from #2 (425 x1/2-400K) should be allocated to future overpass construction or tail development on Burnside Drive.

Mr. Tim Olive, Executive Director of the Downtown Dartmouth Business Commission, provided a presentation objecting to any change in the height restriction in Dartmouth Crossing. The DDBC requests that Harbour East Community Council follow the recommendation of senior planning staff and deny the application to amend the MPS and LUB to accommodate the height restriction application.

Mr. Shalom Mandeville, Founder of Soil Water Conservation provided an update regarding shallow lakes.

Mr. David Paske that he would like to see a restored or replica canal boat be put on the trolley at the Shubie Canal.
