### 10.1.1 <u>Case 01128: Non-Substantive Amendment - 51 Oceanview School Road,</u> Eastern Passage

A report dated, May 21, 2008, was before Council. Mr. David Lane, Planner gave a brief presentation. Councillor Barkhouse enquired as to what would happen if the property was sold or the land use changed. Mr. Lane responded that if the property was sold the new

owner would inherit the development agreement. If they wanted to change the land use, it would have to come back to Council for approval. Councillor Barkhouse wanted clarity on if there was a future expansion of the buildings or a change in use on the property, could Council consider some kind of buffering measures on the property? Mr. Lane advised that staff can and shall consider buffering measures for any future amendments to the development agreement.
