Require the agreement be signed within 120 days, or any extension thereof granted by Council on request of the applicant, from the date of final approval by Council and any other bodies as necessary, including the applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.

Councillor Karsten advised Council that he supports this proposal adding that there has been great commercial growth in this area. He stated that the sign works with the lay of the land, and that the pylon sign will enable business owners to better promote and advertise their business.

Councillor Karsten commended the Developer, Mr, Tony Maskine of Blue Basin

Investments, stating that he has and continues to work well with HRM to ensure that the developments work for both HRM and for Blue Basin Investments.
