#### 10.3 Presentations

# 10.3.1 Shubenacadie Canal Commission – Development of Dartmouth Greenway

Correspondence and a summary report from the Shubenacadie Canal Commission dated November 2, 2011 was before Community Council. An additional submission from Mr. Billard was also circulated to members.

Mr. Allan Billard, Director, Shubenacadie Canal Commission, presented to Community Council. He reviewed a timeline and history of volunteer, HRM staff, and professional consultant engagement on the project over the past decade.

Mr. Billard indicated that the Shubenacadie Canal Commission has been developing a fundraising program, and collecting community funding for this project, which they intend to form part of the Trans Canada Trail. He reviewed an artists' rendering of the

proposed canal greenway, and also reviewed current and proposed site plans for the land.

Mr. Billard acknowledged members of the Shubie Canal Commission in attendance at this meeting including Mr. Cameron Ells, Chair, and Councillor Barry Dalrymple.

MOVED by Councillor Fisher, seconded by Deputy Mayor Karsten, that Harbour East Community Council recommends that Halifax Regional Council:

- 1. Reconvene the existing working committee of senior staff, the Canal Commission and technical consultants to finalize the design and cost elements required to develop the Turbine Chamber, the Tail Race and the Cradle/Marine Railway on the Dartmouth Inclined Plane, including the area of the Pine Street Extension (currently known as Irishtown Road); and
- 2. That provision be included in the 2012-13 Capital Budget for completion of the redevelopment of the Pine Street Extension (currently known as Irishtown Road) into a turning circle, thereby allowing for the interpretation of these historic elements on the Dartmouth Canal Greenway.

Community Council discussed the project further at this time, with Mr. Billard responding to questions.

- 1. Approve, by resolution of Council, the amendments to the Stage II development agreement for King's Wharf to amend provisions regarding land use and building design, as set out in the proposed amending agreement included as Attachment A to the October 20, 2011 report; and
- 2. Require the agreement be signed by the property owner within 120 days, or any extension thereof granted by Council on request of the property owner,

from the date of final approval by Council and any other bodies as necessary, including applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.

Mr. Dickey responded to questions of clarification from Community Council.
