- A Planning Advisory report, dated October 12, 2000, on the above noted, was before Community Council

- First Reading was given at a Special Council session held on October 17, 2000

Mr. Mitch Dickey, Planner, advised the amendment had been initiated by planning staff after it was discovered that the current zoning on Lot 35 Silver Court did not allow for the placement of a mobile dwelling. He advised the current zoning on the property is RA (Rural Area) which does not permit mobile dwellings on any lot where a mobile dwelling did legally exist prior to April 27, 1998. He noted the developed lots in the area are all mobile dwellings.

In response to Councillor Greenough, Mr. Dickey advised all other lots are developed with mobile homes on them noting, this is the last lot to be developed.

In response to Councillor Sarto, Mr. Dickey advised when the new plan being put in place, the rezoning this lot was an oversight.

Councillor McInroy called three times for those wishing to speak either in favour of or against the application. Hearing none, the following motion was placed on the floor.

Moved by Councillor Hetherington, seconded by Councillor Greenough, that the public hearing close. MOTION PUT AND PASSED UNANIMOUSLY.

Councillor Hetherington questioned whether the Community Council had the right to overturn a ruling by the development officer. Mr. Barry Allen, Municipal Solicitor advised he would have to investigate and clarify whether the Community Council has the authority to grant this approval.

Councillor Hetherington advised he would support an amendment to the motion stating that the approval was subject to a receipt of the legal opinion.

The mover and seconded agreed to the suggested change.
