- 10.4 Case 00319: Request for amendments to the Dartmouth, Eastern passage/Cow Bay, and Cole Harbour/Westphal Municipal Planning Strategies and Land use By-Laws with respect to commercial vehicles parked in residential areas
- A memorandum from Maria Jacobs, Planning Technician, dated February 21, 2001, on the above noted, was before Community Council.

Ms. Maria Jacobs, Planning Technician, overviewed the options presented in the memorandum.

Councillor Cooper noted that  $\frac{1}{2}$  and  $\frac{3}{4}$  ton vehicles was acceptable in the community. It was also understood that things like buses, large fuel oil delivery vehicles, tow truck, cube vans, etc. were not considered by the community to be acceptable in the community. He stated those that are used personally or a small home business vehicle which may be a  $\frac{3}{4}$ 

or  $\frac{1}{2}$  ton vehicle would be acceptable in the community.

Councillor McInroy suggested Option 1, 3 and 4 would address all concerns. He suggested Community Council does not need to look at curb and shipping weight.

Councillor Warshick noted that what Community Council is looking at is cube vans and vehicles with attachments such as trailers but not those trailers that would be used to tow jet skis and recreational vehicles such as snowmobiles.

Councillor Cooper suggested vehicles such as cube vans and larger vehicles are the ones that complaints are normally receive about. The ½ and 3/4 ton vehicles don't seem to pose a problem.

Councillor Hetherington questioned what would happen in an apartment building that is zoned commercial but one of the tenants has an eighteen wheeler. In response, Mr. Roger Wells advised this would apply to commercial vehicles in residential zones.

Councillor Hetherington requested staff look at this type of situation.

MOVED by Councillor McInroy, seconded by Councillor Cooper, that the Harbour East Community Council would like to see regulations affect registered vehicles which would be those with yellow license plates, those in excess of 5 tons with the exception of  $\frac{1}{2}$  ton and  $\frac{3}{4}$  vehicles. Further vehicles such as cube vans and those with attachments such as commercial trailers be excluded. MOTION PUT AND PASSED UNANIMOUSLY.

Mr. Allan Sullivan and Ms. Judy Balch, representatives of Nova Scotia Power, made a presentation to Community Council addressing the issues of street lighting, tree trimming and building and maintenance of power lines.

In response to Councillor Warshick, Mr. Sullivan advised he would provide the stats on price stability as well as the cost per kilowatt hour in comparison to other provinces.

Councillor Cooper noted that lights that are out are still being paid for even though, in some instances, they are not replaced for long periods of time. He noted there are 23 lights out in the Portland Street area from the Circumferential Highway to Caldwell Road.

In response to Councillor Smith, Mr. Sullivan advised he would provide an answer to the question of how many hours natural gas has been burnt since the Tufts Cove plant has been hooked up.

Councillor Hetherington requested information on how much is saved per bulb is HRM changes them versus the power corporation doing it.

Councillor Hetherington stated there are a lot of areas where the bulbs are not getting replaced. He stated it is not the responsibility of the Councillor or residents to check which lights are out and report them. The Councillor noted that there is no preventative maintenance carried out on transformers and they are not replaced until they blow.
