9.1 Presentations

9.1.1 GoPlan Presentation

Councillor Hendsbee acknowledged the presence of Mr. Brooke Taylor, MLA.

Mr. Alan Taylor, Transportation Planner, with the aid of overheads, presented the GoPlan proposal to Community Council.

Councillor Snow suggested a parking lot be developed in Kearney Lake where people can park their cars and take the bus downtown. In response, Mr. Taylor advised a park and ride lot has been approved for 1997 at the intersection of Kearney Lake Road and the BiHi.

Councillor Hendsbee stated some of the priorities should be to widen the #7 Highway from Little Salmon River to the Forest Hills Parkway with a middle lane, develop the Burnside to Sackville extension, and develop the Old Miller Road which includes the Ring Road between Cherry Brook/Westphal to Lawrencetown.

Councillor Dooks suggested clarification be provided with regards to what the relationship will be with the Province when dealing with road issues.

Mr. Brooke Taylor questioned the costs associated with each component in the GoPlan.

Mr. Peter Beech stated he feels public consultation should start at an earlier stage, not present the public with a "fait accompli".

Mr. Paul Pettipas stated his area is considered part of the urban core and asked whether there were any plans to extend Metro Transit into his area. He suggested it would be counter productive to widen the roads when the aim is to have people use public transportation. He suggested it would be more feasible to take that money and, instead of widening Bayers Road, extend transit into the outlying areas and into the core making it possible for people to take the bus into town.

Councillor Hendsbee thanked Mr. Taylor for his attendance and presentation.
