# 12.3 <u>Correspondence dated February 23, 1999 from Carl Yates, General Manager, Halifax Regional Water Commission re: Watermain Extensions — Portobello Road Area</u>

Correspondence, dated February 23, 1999, from Carl Yates, General Manager, Halifax Regional Water Commission was before Community Council.

Councillor Snow stated he felt it was incumbent upon on the members of the Community Council to put forward a motion through Regional Council that it will never be feasible for residents in the rural areas to have water hookup due to the associated costs.

MOVED by Councillors Snow and Dooks that HRM be notified that the Community Council wants it known to the general public that there is no help from tax dollars for infrastructure money. Further a copy be forwarded to the Water Commission and the MLA s and MP s for the Marine Drive area. MOTION PUT AND PASSED.

Councillor Snow advised he was providing the crier with a contribution and suggested the Marine Drive Councillors avail themselves of his services for functions in their districts.

#### 14. PUBLIC PARTICIPATION

Mr. Paul Pettipas, Chairman, LWF Ratepayers Association, on behalf of Mr. Herman Pye, questioned whether any response had been received regarding the question of hunting in the area of the Keltic Gardens Subdivision. In response, Councillor Hendsbee advised no formal response had been received from the Department of Natural Resources only that it has been referred to the staff representing the Musquodoboit Valley.

Mr. Pettipas questioned whether any paving petitions have gone into Keltic Gardens during this year. In response Councillor Hendsbee advised there have been none at the present time but there will be one going forward for the Robinson Lake Road, going up the hill. Mr. Pettipas requested the petition be copied to him to enable him to pass this information on to interested parties in the subdivision.

Mr. Pettipas advised in 1997 the new section of Keltic Gardens roads had been deeded over to the Department of Transportation noting, there were four drainage right—of—ways. He stated his assessment notice for this year contained four drainage right—of—ways. He stated he asked a Mr. Hessian from the Department of Transportation why they were not done and advised the Community Council that Mr. Hessian stated his and 34 other roads have not been registered at the Registry of Deeds and advised they would all be done by January 1, 1999. He stated he was contacted by the assessment department who advised him that as long as he could prove that they had been deeded over, it would be taken out of his name. Two days later he was informed this could not be done. He stated not only is the maintenance of the roads faulty but DOT is not taking over the maintenance of these roads. He said if someone queried why his road was not being paved, DOT could technically say it was not their road.

Mr. Pettipas expressed concern in that if one of the people living there tried to sell their home and a title search was undertaken the results would show there was no deed of that public road noting, this covers approximately a mile of roadway.

MOVED by Councillors Dooks and Snow that a letter be sent to the Minister of Transportation with a copy to Mr. Hessian, Mr. Kulvinder Dhillon, Mr. Ken Meech asking the provincial government an explanation for the status and question as to why the titles to certain roadways and drainage easements have not been officially assumed by the province. MOTION PUT AND PASSED.

Councillor Hendsbee noted the Keltic Gardens subdivision be sited as an example.

Councillor Hendsbee introduced Mr. Jay Tofflemire and Mr. Garth McIsaac advising the building was a surplus school building which the community was converting into a community centre.

Mr. Tofflemire referenced sports field rates and queried what the rate was for the field attached to this

facility. In response, Councillor Hendsbee advised the field, as a C class, would be charged \$7.00/hr for adult use and \$3.50/hr for minor use. On question as to who would be administering the policy, Councillor Hendsbee advised the community organization can be responsible for the bookings and collection of fees with the monies going towards the operational and maintenance costs of the field. He advised if HRM collects the fees they will retain an administrative charge. He advised the service levels such as responsibility for grass cutting has to be clarified.
