14. PUBLIC PARTICIPATION

Mr. Ed Grace, 85 Beaumont Drive, Lower Sackville, questioned if there was any update pertaining to agenda item 4.1.7 - Sackville Waters Advisory Board.

Councillor Harvey indicated that he hadn't heard anything further and he requested the Legislative Assistant to follow up and provide a status report for the next meeting.

Mr. Ed Grace advised that it was his understanding that Porter Dillon completed a capacity study for the Mill Cove Sewage Treatment Plant and this has not yet been presented to Council. He urged Council to follow up with staff on this report.

The Chair advised that staff will be requested to forward this report as soon as possible.

Mr. Walter Regan, representing Sackville Rivers Association, expressed appreciation to Councillor Harvey for helping with the recent clean-up efforts of Sackville River.

In response to Mr. Regan, Councillor Harvey noted that a follow-up was done on the five trees that were in the River. Also, he pointed out that the lumber and treehouse could be dealt with through the appropriate by-law; and the abutting property owner of the land where the tree fell is responsible for the tree. He suggested that the Department of Environment and Labour should take an interest in fact that the waterway is being blocked.

Mr. Regan questioned if there was any update on the matter of 60 Acres - Second Lake.

Councillor Harvey advised that there was nothing new to report, other than correspondence received acknowledging this Council's motion on the matter. Councillor Goucher advised that he would arrange a meeting with Minister Peter Christie, Minister David Morse, Councillor Harvey and himself.

Mr. Regan requested an update on the Shopping Cart By-law. Councillor Harvey advised that it should be prepared by September.

Mr. Regan advised that in the Sackville Drive Streetscape Plan, it was identified that culverts should be removed and a bridge placed. He questioned if this could be put in the budget for next year or the year after. Councillor Harvey advised that Council could advance it as a suggestion for staff to consider at budget time. He added that it could go forward to Public Works as a suggestion based on the Sackville Drive Streetscape and Secondary Planning Strategy Study, as a capital item, i.e Bridge on Sackville Drive over the Little Sackville River.

Mr. Walter Regan announced that Sackville Rivers Association is having a fundraising auction on September 10.

Mr. Regan noted that several rain events have resulted in a lot of silt in the Little Sackville

River. He added that he is aware HRM staff have been looking into the problem and questioned if something could be done as soon as possible.

Councillor Harvey pointed out that the source of the problem has not yet been determined. He suggested that a follow up concern be forwarded to Alex Quinn, Planning and Development Services, advising of the ongoing siltation problem, and question whether or not staff can identify the source and take appropriate steps.

Mr. Regan advised that his group is in the process of setting up a recycling program at the Community Centre and they thought HRM would supply materials in this regard. He explained that in his research, he determined that HRM buildings are exempt from the recycling bylaws and found this surprising. Mr. Regan questioned why HRM would require everyone else to recycle but exempt themselves from this process. As well, Mr. Regan advised that he had heard that schools were also exempt from recycling. Councillor Harvey indicated that he was also surprised to learn that HRM didn't have to follow the recycling bylaws. The Chair indicated that they would follow up with staff for a response.

Mr. Ed Grace referred to agenda item 4.1.9 Policy P-71, Beaver Bank, Hammonds Plains and Upper Sackville MPS and questioned if he could receive a copy of the policy and recommendations.

Councillor Harvey advised that the Legislative Assistant would forward a copy to him.
