- A staff report dated March 9, 2001 submitted by Paul Dunphy, Director of Planning and Development, was redistributed to members of Community Council.
- Correspondence from Hugh Pullen, President, Peninsula South Community Association in opposition to an automatic renewal of the Development Agreement without public consultation, was distributed to members of Community Council.

Mr. Gary Porter, Planner, noted that this Development Agreement was approved a number of years ago and has been the subject of past extensions. He went on to note that the owner has changed and that work had begun on the building. However, the owner has made application for a ground floor commercial component and will be coming to Community Council for an amendment to the Development Agreement.

A brief discussion and questioning of staff ensued.

MOVED by Councillor Blumenthal, seconded by Councillor Sloane that Peninsula Community Council amend the Development Agreement for Case 00351, 1079 Queen Street, to extend the completion date to May 30, 2004.
