8.2.1 <u>Variance No. 13422: Appeal of the Development Officer's decision to approve an application for a Variance - 1211 Queen Street, Halifax</u>

C A staff report dated December 29, 2006 on the above noted was before Community Council.

Mr. Andrew Faulkner, Development Officer, reviewed the report with Community Council, noting that this is an appeal of the Development Officer's decision to approve an application

for a variance from the side yard and lot area requirements of the Halifax Peninsula Land Use Bylaw to permit a conversion from a single family dwelling to a duplex.

Mr. Faulkner clarified that the actual area of the property is 1650 square feet, and not 1855 square feet as previously notified. He indicated that this was a Nova Scotia Property Online error and notification to area residents was corrected when the error was detected.

Mr. Faulkner responded to questions of clarification of Community Council, noting that the proposed renovations will not change the footprint of the home.

The Chair opened the appeal hearing and called for speakers.

Mr. Elliott MacNeil, Property Owner

Mr. MacNeil addressed Community Council, noting that he is contributing to improving his neighbourhood by updating one of the last homes on the street to be renovated. He indicated that his property is also one of the only single unit homes on the street, and therefore adding a unit to the basement would fit with the other properties on the street. Mr. MacNeil advised that he contacted Councillor Sloane and a concerned neighbour to explain is plans for the property. He clarified that the variance he is seeking is to change the roof profile of the home to create more room in the upstairs residence, which he will be occupying. Mr. MacNeil distributed a letter of support from a neighbour, for the information of Community Council.

The Chair called three times for any further speakers.

Hearing none, it was MOVED by Councillor Sloane, seconded by Deputy Mayor Uteck, that the appeal hearing be closed. MOTION PUT AND PASSED UNANIMOUSLY.

MOVED by Councillor Sloane, seconded by Deputy Mayor Uteck, that Peninsula Community Council uphold the decision of the development officer to approve the variance. MOTION PUT AND PASSED UNANIMOUSLY.
