### 4. Transitional Reports (Councillor Kelly)

### 5. Establishment of a Grants Committee

### 6. Establishment of Pension Committee

THAT Council authorize staff to bring forward as quickly as possible proposed terms of reference pertaining to the establishment of a Pension Committee.

### 7. Social Services Delivery - UPDATE

That the Information Report dated January 12, 1996 received from the Commissioner of Community Services be tabled.

### 8. Council Support Services

THAT Council appoint an ad hoc committee made up of five members of Council representing a cross-section of Council to work with the Director of Administrative Services to develop a recommendation for the type and level of support services to be provided by the HRM to Councillors.
