The meeting was called to order at 1:00 p.m., and recessed at 3:14 p.m. Council reconvened in at 3:30 p.m. Council recessed at 5:27 p.m. and reconvened at 6:00 p.m. Council moved into an In Camera session at 7:35 p.m. and reconvened at 8:14 p.m. Council adjourned at 8:19 p.m.

11. REPORTS

11.1 CHIEF ADMINISTRATIVE OFFICER

During the approval of the order of business, Council agreed to deal with items 11.2.3 and 11.3.2 at this time.

11.2.3 Case 18686: Amendments to Extend the Central Water Service Boundary from Lucasville Road to McCabe Lake North, Middle Sackville

The following was before Council:

• A recommendation report dated June 5, 2015 was submitted from the Chair of North West Community Council; with an attached staff recommendation report dated April 21, 2015.

MOVED by Councillor Johns, seconded by Councillor Hendsbee

THAT Halifax Regional Council direct staff to prepare amendments to the Regional Municipal Planning Strategy (MPS) and Regional Subdivision By-law as required for public hearing by extending a single line water service boundary along the service road extending to a point sufficient to service all of the McCabe Lake North Lands with the addition of a parcel of HRM-owned lands designated for a park and ride facility located near the subject area as generally shown on Maps 1 and 2 of the staff report dated April 21, 2015.

Councillor Johns advised that he was requesting Council vote against the motion, as he would like to discuss the matter with staff and return to Council with a revised motion following that discussion.

Based on his expressed intent, the Municipal Solicitor suggested that the best approach would be for the Councillor to table the motion pending that determination.

MOVED by Councillor Johns, seconded by Councillor Mason

THAT the motion be tabled.

MOTION TO TABLE WAS PUT AND PASSED UNANIMOUSLY.

11.3.2 Connector Road – Lucasville Road to Larry Uteck Drive

The following was before Council:

- A recommendation report dated May 29, 2015 submitted from the Chair of the Transportation Standing Committee, with an attached staff recommendation report dated April 1, 2015.
- Map of the area submitted by Councillor Johns

MOVED by Councillor Johns, seconded by Councillor Whitman

THAT Halifax Regional Council:

- 1. Retain the existing Table 4-1 from the 2014 Regional Plan as the basis for the Road Network Functional Plan without adding the Connector Road Lucasville Road to Larry Uteck Drive; and
- 2. Direct staff to liaise with Halifax Water to evaluate the feasibility and desirability of constructing a new public roadway parallel to Hammonds Plains Road if and when the existing water transmission main is being considered for replacement or major rehabilitation.

Councillor Johns noted that he was asking Council to defeat the motion, and that he had an alternate motion to bring forward. With the aid of a map of the area in question, Councillor Johns explained that his proposal for a connector road would enable traffic to come directly from Highway 101 onto Larry Uteck, Boulevard, and it would run parallel with the Hammonds Plains Road. In addition to providing a direct route from Highway 101 to Larry Uteck Boulevard, it would alleviate some of the traffic congestion currently experienced on the Hammonds Plains Road. Councillor Johns advised that the motion he would like to bring forward is to request that this connector road be added to the project list as 'future potential'. He pointed out that having its status as 'future potential' does not commit Council to the project other than having staff recognize that it is on the list.

Councillor Whitman advised that he was supportive of a connector road as this would alleviate the traffic congestion issues at this end of the Hammonds Plains Road.

Councillor Rankin expressed concern noting that the staff report addresses the risk on the part of the Halifax Water Commission, and he added that the Water Commission states that they do not have a need

to replace the water line that would be impacted by the connector road. Councillor Rankin pointed out that the cost to replace the water line is in the millions of dollars. Councillor Rankin indicated that he could support the idea of staff working with the Water Commission so that the project does not get lost, but that he could not support the motion Councillor Johns was proposing to bring forward.

Councillor Watts advised that she could not support Councillor Johns proposed motion. She explained that Council has had a major discussion around the Road Network Functional Plan, and this would be a significant change and cost to the Plan.

In response to questions, Mr. Bob Bjerke, Director, Planning and Development explained that public consultation is the next phase in the Road Network Functional Plan, which staff will be carrying out this fall. He advised that staff could include Councillor Johns proposed connector road in the consultation. He cautioned that if Council wished to amend Table 4.1 of the Regional Plan, it would involve a Municipal Planning Strategy amendment, and staff would want to carry out a network-wide review.

The Municipal Solicitor advised that an alternative motion would be out of order.

Councillor Johns advised that he would be agreeable to deferring this matter at this time, and that the connector road be included in the public consultation on the Road Network Functional Plan.

On the advice of the Municipal Solicitor, Councillor Johns advised that he would move to table the motion.

THAT the motion be tabled until the public consultation on the Road Network Functional Plan has been completed.

Councillor Mason advised that he has received concerns in regard to this matter and that he believed a supplementary report outlining the two main areas of concern would provide understanding on how the process will work. He added that the two points he would like clarification on are: acquisition of archival records from private sources; and roles and responsibilities of various staff around the municipal decision making regarding municipal archives.

Councillor Whitman advised that he was supportive of a supplementary report and added that he would like the report to also address the 'pros' and 'cons' of the proposed changes.

At this time the Mayor left the Council Chamber and the Deputy Mayor assumed the Chair.

Councillor Watts indicated she supported a supplementary report and that she felt the cost implications should be addressed in the report.

Mr. Darrell Joudrey, Planner 1 and Ms. Kelly Denty, Manager of Development Approvals responded to questions.

Mayor Savage returned to the Council Chamber and assumed the Chair.

Councillor Watts questioned whether specifics like density caps, and the number of bedrooms per unit were clearly identified in the development agreement. She advised that Halifax and West Community Council deals with a lot of development agreements and there doesn't seem to be consistency in the language used in Development Agreements. Councillor Watts explained that, in going forward, it would

be very helpful if staff could be consistent in the language they use so that when the public reviews the agreement, they have a clear idea of what to expect.

In response, Ms. Kelly Denty advised that the development agreement contains the required language as noted by Councillor Watts. She advised that staff are always looking to standardize their documents and will take this suggestion into consideration.

Councillor Dalrymple explained the reason for the area rate is that Frame Subdivision has obtained some water frontage and the residents wish to build a raft and a small dock to provide access to the lake.

He noted that there will be an amendment brought forward to the proposed Development Agreement section 3.6.9 to replace the phrase "notwithstanding the above" with "notwithstanding 3.6.8.," through a supplemental staff report to Halifax and West Community Council.

Responding to questions of clarification from Council, Mr. Sampson noted: that although no further renovations to the exterior have been proposed, the Development Agreement would allow for minor additions; that the agreement would establish the existing building as conforming, subject to clause 3.4.1; that there is no density cap on the proposed building aside from what is physically allowed by the size of the building with 33% of units containing two or more bedrooms; and that there must be a combination of underground and surface parking including bicycle parking but no set minimum number of spots.

Mr. John Traves, Municipal Solicitor noted that changes to the Development Agreement, including the number of parking spaces, should be addressed at Halifax and West Community Council.

The Mayor opened the public hearing and invited the applicant to come forward to address Council.

Mr. Cesar Salah, W.M. Fares Group addressed Council representing the applicant. He noted that the construction on the proposed development, if approved, is intended to begin this summer.

Mayor Savage read the rules of procedure respecting public hearings and invited members of the public to come forward and address Regional Council. The Mayor called three times for anyone wishing to speak; there being none, it was MOVED by Councillor Karsten, seconded by Councillor McCluskey

THAT the public hearing close.

Mayor Savage noted that it was Council's direction to provide \$300,000 per year in 2014 and 2015, with an option for 2016, subject to conditions. The Mayor suggested that with the 2015 event being held in two weeks, Council should honour its commitment.

Ms. Denise Schofield, Manager Program Support Services indicated that staff recommend, due to the tight timelines and previous commitment from Council, that any adjustment to the level of funding from HRM should be considered in 2016, which is the optional year.

Mayor Savage assumed the Chair.

In response to a suggestion that the motion be amended to restrict funds provided by the municipality from being used for event management fees, Mr. John Traves, Municipal Solicitor indicated that the most straightforward and enforceable way to restrict the use of the grant would be to word the motion such that only particular expenses are reimbursed.

In response to a request for clarification, Ms. Schofield noted that the contract would indicate that funding may only be used to reimburse actual expenses excluding salaries. She advised that the initial request was for \$200,000 from the municipal and provincial governments.
