Mr. Bob Bjerke, Director Planning and Development, responded to concern regarding part two of the recommendation. He stated that the Civic Addressing Policies prevented against segmenting streets. He stated that changes to the traffic configuration had created a continuous street along Gottingen and the southern portion of Rainnie Drive, prompting the decision to rename that portion.

MOVED by Councillor Mosher, seconded by Councillor McCluskey

THAT Halifax Regional Council request part two be deferred pending consideration of an entirely different name to the southern portion of Rainnie Drive.

Councillor Mason stated he would be voting against the deferral. He highlighted that the recommendation was consistent with policy.

A number of Councillors noted the importance of the report and voiced support for the recommended actions and provision of further assistance to incoming refugees.

Councillor Adams requested the recommendations be voted on separately. He asked what would be the baseline number of refugees referenced in recommendation one. Ms. Maggie MacDonald, Managing Direction Government Relations and External Affairs responded that the request would be to consider an increase in the overall percentage but the number of refugees was yet unknown.

The question was called for on part one of the motion

That Halifax Regional Council:

1. Authorize on-going discussion and advocacy with the federal government in support of receiving an increased number of refugees to Halifax;

14.1.10 Halifax Regional Fire & Emergency Operational Staffing

The following was before Council:

- A staff recommendation report dated November 24, 2015
- A staff presentation dated November 24, 2015.
- A extract of minutes from Regional Council May 12, 2015

Chief Doug Trussler, Fire and Emergency Services, presented regarding Halifax Regional Fire & Emergency Staffing as described in the staff report dated November 24, 2015. This presentation is available on file and online. Chief Trussler outlined the background, recommendations, findings, and described two additional staffing deployment and apparatus assignment options for Council's consideration. The Chief recommended Option 2, itemizing the benefits and stating the importance of maintaining four person engine and aerial crews.

The Clerk noted that the rules have been waived regarding number of times members of Council are allowed to speak.

MOVED by Councillor Mason, seconded by Councillor Walker

THAT Halifax Regional Council:

- To improve the effectiveness and safety of fire protection and to crew apparatus, per Council's motion of May 12, 2015:

 a) convert Station 4 (Lady Hammond) to an E Platoon station;
 b) convert Station 11 (Patton Road) to a Volunteer station; and
 c) convert Station 13 (King Street) to an E Platoon station.
- 2. Authorize staff to increase the HRFE's career firefighter complement from 413 positions to 423 positions, by close of fiscal 2017/2018.

3. Endorse the consolidation of equipment, career personnel and volunteer personnel in urban, suburban and rural fire stations, to more effectively and safely deliver fires services, as detailed in Table 2 of the report dated November 24, 2015.

Councillor Mason stated support for the motion in terms of resources and meeting the recommended safety standard of the National Fire Protection Association (NFPA) for four person engines and Occupational Health and Safety. He stated that the motion would keep the stations open as requested by Council and address concerns raised by residents to ensure adequate response via the E Platoon stations.

In response to questions from Deputy Mayor Whitman, Chief Trussler stated:

- 15-25 new volunteers were anticipated to be recruited at Station 4 (Lady Hammond) and Station 13 (King Street) and would be active within a year.
- As of November 4, 2015, Black Point Station has 12 volunteers with 3 qualifying as active firefighters, active being defined as having attended 25% or more of Emergency calls.
- There would be little to no change in service level standard to Stations 4 (Lady Hammond) and 13 (King Street) with the E Platoon versus full-time firefighters.
- There were 5 active firefighters living nearby Station 11 (Patton Road) and a recruitment drive would also be held.

Deputy Mayor Whitman requested an update regarding the Memorandum of Understanding (MOU) with Lunenburg County. Deputy Chief Holland, Fire and Emergency Services, responded that Hubbards Commission was currently reviewing taxation and financial information, which was being done at the request of the Commission. Regarding Ecum Secum, Deputy Chief Holland responded that discussions have begun with respective division commanders in Ecum Secum, Enfield, and Mount Uniacke.

In response to a question regarding deployment of volunteers at Patton Road, Chief Trussler stated that Station 11 (Patton Road) was considered a career firefighting station and volunteers are required to live within six minutes travel time of the station. Chief Trussler highlighted the overlap of Station 11's area with Station 10. Councillor Johns stated concern that areas like Station 11 (Patton Road) had difficulty in recruiting the requisite 15 volunteers to make the station viable. He requested an opportunity to further discuss Station 11 (Patton Road) with Fire management staff.

MOVED by Councillor Johns, seconded by Deputy Mayor Whitman

THAT this matter be deferred pending further discussion regarding Station 11 – Patton Road with Senior Fire staff.

Council discussed the length of time of the deferral. Council agreed to a friendly amendment that the deferral return no later than the first Council meeting of the New Year. Regarding the scope of the deferral, the Municipal Solicitor indicated that the recommendations could not be dealt with separately as it was an integrated recommendation and the deferral would apply to all three recommendations. The Chief confirmed the recommendations could not be separated.

Discussion ensued on the deferral, with certain Councillors voicing support and others stating they would not support the deferral because of the broader implications.

In response to a concern regarding staffing at Station 11 (Patton Road), Chief Trussler responded that Station 10 would provide volunteers to Station 11, and in addition that Station 11 (Patton Road) area was already covered by Station 10. He stated that if Council wished, he could retain two full time firefighters at the Patton Road station until a base of volunteers were recruited, in addition to discussing the staff plan further with the district Councillor.

Deputy Mayor Whitman highlighted that a viable station was defined as having 15 active volunteer firefighters. He stated concern that there were only 5 volunteers in the vicinity of Station 11 (Patton Road). Councillor Johns highlighted the difficulty in staffing volunteers at Station 11 (Patton Road), stating

that the two full-time firefighters were required for that reason. He voiced concern that removal of those firefighters from Station 11 (Patton Road) would be against Council's previous direction to keep all stations open. He requested there be four full-time firefighters deployed at Station 11 (Patton Road).

The Municipal Solicitor responded to concerns around the process of introducing changes to the report before Council as previous direction was given by Council. He stated that the report before Council further clarified previous direction as it sought to describe how the stations would be staffed.

The motion to defer reads:

THAT this matter be deferred pending further discussion regarding Station 11 – Patton Road with Senior Fire staff, to return no later than the first Regional Council meeting of 2016.

14.1.8 Snow Clearing Service Outside of the Municipal Service Boundary

MOVED by Councillor Hendsbee, seconded by Councillor Walker

1. THAT Halifax Regional Council not expand the snow clearing service to roadways outside the Urban Core Services Boundary.

MOVED by Councillor Hendsbee, seconded by Deputy Mayor Whitman the motion be amended to add:

2. THAT Halifax Regional Council direct staff to explore a winter service agreement with the Province of Nova Scotia that may include the following streets in Lawrencetown: Greendale Drive 318m; Moore Drive 454m; Lahey Drive 636m; Maple Drive 690m (in total 2.098 km).

And in reciprocal, the Province of Nova Scotia be asked to provide winter ice control and snow removal service to the following streets in Porters Lake: Alps Road (extension) 1,780m; Sugarwood Court 950m; Big Bear Loop 255m; Dewberry Drive 215m (in total 3.200 km).

Mr. Bruce Zvaniga, Director Transportation and Public Works, stated that he was familiar with the proposed amendment and it was consistent with the winter service exchange agreement in place.

Councillor Rankin proposed a friendly amendment: '**THAT Halifax Regional Council direct staff to** explore a winter service exchange agreement with the Province of Nova Scotia where operational efficiencies may be gained in the estimation of staff...'. He stated that this would be preferable over agreements being dealt with on a case by case basis by Council. Councillor Rankin's suggestion was accepted as a friendly amendment.

A number of Councillors disagreed with the motion, stating concern for the process of determining which roads are serviced by the Municipality and also concerns regarding services leapfrogging certain streets and not fulfilling operational efficiencies. Deputy Mayor Whitman requested further information regarding the process of how certain roads could be taken over by the Municipality based on population. Mr. Zvaniga responded that he could provide that information at a later date.

The motion now reads:

- 1. THAT Halifax Regional Council not expand the snow clearing service to roadways outside the Urban Core Services Boundary.
- THAT Halifax Regional Council direct staff to explore a winter service exchange agreement with the Province of Nova Scotia where operational efficiencies may be gained in the estimation of staff, that may include the following streets in Lawrencetown: Greendale Drive 318m; Moore Drive 454m; Lahey Drive 636m; Maple Drive 690m (in total 2.098 km). And in reciprocal, the Province of Nova Scotia be asked to provide winter ice control and snow removal service to the following streets in Porters Lake: Alps Road (extension) 1,780m; Sugarwood Court 950m; Big Bear Loop 255m; Dewberry Drive 215m (in total 3.200 km).

Deputy Mayor Whitman confirmed the approach would be to request the Province to increase or match standards to the Municipality and that the Municipality would be responsible for the incremental cost of achieving those standards.

Discussion ensued on the proposal, with Councillors stating concern for the ambiguity of the amendment, specifically the unknown financial implications to be incurred to the Municipality. Other Councillors voiced support for the motion, stating that the aim would be to discover the implications and costs to create a similar level of service. Deputy Mayor Whitman accepted as friendly amendment **THAT Halifax Regional Council request a staff report to consider requesting the Province adopt roadway snow and ice clearing level of service standards used by Halifax for 2016/17, and beyond, for HRM owned roads outside the Urban Core Service Boundary and direct staff to include the required funds for consideration in the 2016/17 Operating Budget.**

A number of Councillors voiced concern that the amendment was out of order. In response, the Municipal Solicitor stated that the amendment was in relation to the subject matter of the report.

The motion now reads:

MOVED by Councillor Hendsbee, seconded by Councillor Walker:

- 1. THAT Halifax Regional Council not expand the snow clearing service to roadways outside the Urban Core Services Boundary.
- THAT Halifax Regional Council direct staff to explore a winter service exchange agreement with the Province of Nova Scotia where operational efficiencies may be gained in the estimation of staff, that may include the following streets in Lawrencetown: Greendale Drive 318m; Moore Drive 454m; Lahey Drive 636m; Maple Drive 690m (in total 2.098 km).

The Municipal Solicitor clarified for the record that passing recommendation one would not negate recommendations two and three. He stated that the amendments did not run contrary but qualified recommendation one. The Municipal Solicitor suggested a friendly amendment that recommendation one read **Not expand** *municipal* **snow clearing service** so as to distinguish it from recommendation two and three which dealt with Provincial services. Council accepted the friendly amendment.

As the recommendations were separated, the question was now called on part one of the motion:
