In response to Councillor Hendsbee, Mr. John Sheppard, Manager, Environmental Management Services, advised servicing for Station Road is intended to be designed and developed in concert with the Hubbards servicing plan which will be a public system.

In response to Councillor Johns, Mr. Sheppard advised Station Road was designated as a low priority, priority four, because HRM does not have responsibility with respect to sewage problems on private systems. The priority rating process that was approved by Council was clearly defined to apply to capital projects with capital funding provided by HRM and was also clearly defined to apply to external funding. From that point of view, the priority rating process would not support external funding to priority four projects.

Councillor Hum suggested the funding be outside the MRIF funding program and placed the following motion.

MOVED by Councillor Hum, seconded by Councillor Meade, that the funding be outside the MRIF funding program. MOTION PUT AND PASSED.

MOVED by Councillor Meade, seconded by Councillor Sloane, that the Mayor write to the Federal and Provincial governments, with a copies to MLA's Judy Streatch and Gerald Keddy, to seek funding outside the MRIF Program for sewer upgrades to be cost shared with property owners with no cost to HRM for sanitary sewer treatment at Station Road, Hubbards.
