# 9.1.5 Request for Proposal 04-028, Underground Utilities Feasibility Study

Ms. Dale McLennan, Director of Financial Services, noted the funding sources identified on page 4 does not allow for applicable taxes. She advised the intent is to take the net taxes from the \$60,000 equally from the funds identified.

Zone. It is the intention that this amendment would stay in effect on a temporary basis until such time as an amendment to By-Law O-103 is adopted giving the Chief Director of the Fire Service the authority to authorize the issuance of Burning Permits for the open air burning of trees, wood, shrubs, bushes and brush in the event of natural disasters or other similar circumstances.

Mr. McLellan, Chief Administrative Officer, advised that during this process the current Bylaw remains in effect and must be followed.
