#### 10.1.1 <u>Tender 06-120 - Supply of One (1) New Rescue Pumper</u>

# Regional Council approve the application for permanent encroachment of a proposed balcony in the street right of way at 73 to 79 Alderney Drive, Dartmouth.

During discussion, the following concerns were expressed by members of Council:

- The current alignment of Alderney Drive,
- There may be a liability issue as Alderney Drive is narrow,
- The close proximity of the posts to the curb could pose a safety issue,
- There is a potential for objects to be dropped or fall onto the street,
- Noise may become an issue,
- This is a substantial change in the appearance of Downtown Dartmouth,
- This is a severe safety hazard as there is potential for the pillars to be hit and/or damaged from snow removal vehicles.
