1. INVOCATION

The meeting was called to order at 6:00 p.m. with the Invocation being led by Councillor Hum.

2. SPECIAL COMMUNITY ANNOUNCEMENTS & ACKNOWLEDGEMENTS

Councillor Murphy thanked the students and parents who participated in the beautification and cleanup of his district during the last three weeks.

Councillor Johns advised the annual Sackville Relay For Life was held at Met Field on June 4th. He extended congratulations to those who participated in the Sackville clean up.

Councillor Rankin noted an unveiling ceremony had been held at the Fairbanks Centre at Shubie Park on June 2nd by Regional Trails.

Councillor Karsten noted there will be a street naming of a small portion of Jayden Drive to Sarto Drive on Monday, June 18th at 1:00 p.m. in recognition of former Councillor Condo Sarto.

Councillor Kent advised an unveiling ceremony had been held of the Kerry Lee Dickson Memorial Park on Ocean View School Road in Eastern Passage.

Councillor Younger advised that there will be a walk from Morash Park to St. Thomas Moore Parish on Caledonia Road in celebration of the 25th anniversary of the East Dartmouth Boys and Girls Club and East Dartmouth Community Centre project on Saturday, June 16th at 9:00 a.m. He further advised that Churchill Drive will be named Roleika Drive in memory of a student.

Councillor Snow noted the RCMP will be making a presentation on internet safety and bullying at the Lockview High School on Thursday, June 14th at 6:30 p.m.

Councillor Mosher issued an invitation to the Ecole Chebucto Heights Elementary School funday to be held on Saturday, June 16th.

Councillor McCluskey thanked those who participated in the Downtown Dartmouth clean-up and advised that the paddling and kayaking trials will be held at Lake Banook on Saturday and Sunday.

Councillor Fougere recognized the citizens and staff who organized and were a part of bike week.

Councillor Sloane thanked those who participated in the Clean Sweep held in Downtown Halifax.

Ms. Hanita Koblents, Planner, presented the report to Council.

In response to Councillor McCluskey, staff advised there will be public information sessions associated with the process prior to it coming back to Council.

MOVED by Councillor Younger, seconded by Councillor Kent, that Regional Council:

1. Initiate an amendment to the Dartmouth Municipal Planning Strategy to permit uses not otherwise permitted in the zone or designation, by development

agreement, for Municipally Registered Heritage Properties.

9. PUBLIC HEARINGS

9.1 Project 00856 - By-Law D-300, Respecting Derelict Buildings

- An extract from the May 1st and 8th Regional Council minutes was before Council.
- A supplementary report dated June 4, 2007, on the above noted, was before Council.

Mr. Ed Thornhill, Manager, Permits and Inspections, presented the report to Council.

Council recessed at 6:58 p.m. Council reconvened at 7:01 p.m.

Mayor Kelly called for those wishing to speak either in favour of or in opposition to the proposed By-Law.

Ms. Amy Moonshadow, Halifax, expressed concern with the definitions as abandoned does not necessarily mean unused. She suggested hearings be held in the neighbourhoods where the properties in question are located. She suggested a grants program be examined to assist low income families with regeneration of their properties.

Ms. Eva Curry, Halifax Coalition Against Poverty, expressed concern that the proposed Bylaw will have a negative impact on low income residents as the By-law will give power to deal with buildings that are below code.

Ms. Angela Weale, Halifax, stated there is a thin line between affordable and derelict housing and, in her opinion, there is a bias in this legislation towards tearing down rather than fixing up. She suggested building owners be given incentives to repair their buildings and prevent them from becoming derelict in the first place.

Mr. Rod MacNeil, Halifax, noted some of the definitions in the By-law are not clear and noted

sections where he would suggest tightening of the wording to reflect the intent. He suggested that instead of expropriation the properties be put up for sale similar to a tax sale.

Mayor Kelly called three times for any additional speakers. Hearing none, the following motion was placed.

MOVED by Councillor McCluskey, seconded by Councillor Sloane, that the public hearing close. MOTION PUT AND PASSED UNANIMOUSLY.

MOVED by Councillor Smith, seconded by Councillor Karsten, that Regional Council approve By-Law D-300 Respecting Derelict Buildings as included in Attachment "A" of the June 4, 2007 staff report.

A motion by Councillor Smith to amend the By-Law to add as one of the criteria "a building that has been boarded up for two years or more" was ruled out of order.

Deputy Mayor Uteck referenced Section d, page 4 and placed the following motion.

MOVED by Deputy Mayor Uteck, seconded by Councillor Sloane, that the word "unattended" be replaced by the word "vacant" under Section 2(d) page 4. MOTION PUT AND PASSED UNANIMOUSLY.

Ms. Donovan, Municipal Solicitor, advised the definition of Vacant would be added as Section 2(h) and would read:

"Vacant" means a building which is not occupied by person authorized by the owner of the property".

MOVED by Councillor Hendsbee, seconded by Councillor McCluskey, that Section 2 (g) be amended such that the owner would be as they appear on the assessment role and/or registry of deeds. MOTION PUT AND PASSED.

A motion by Councillor Hendsbee to the requirement for 120 days be changed to 180 days was lost as there was no seconder to the motion.

The amended motion was now before Council.

MOVED by Councillor Smith, seconded by Councillor Karsten, that Regional Council approve By-Law D-300 Respecting Derelict Buildings as included in Attachment "A" of the June 4, 2007 staff report with the following amendments:

- 1. that the word "unattended" be replaced by the word "vacant" under Section 2(d) page 4.
- 2. The definition of Vacant would be added as Section 2(h) and would read: "Vacant" means a building which is not occupied by a person authorized by the owner of the property.
- 3. Section 2 (g) be amended such that the owner would be as they appear on the assessment role and/or registry of deeds.

MOTION PUT AND PASSED UNANIMOUSLY.

Council recessed at 8:00 p.m. Council reconvened at 8:10 p.m.

9.2 <u>Case 00895 - Halifax Municipal Planning Strategy and Peninsula Land Use By-Law Amendments for 2594 Agricola Street, Halifax</u>

- An extract from the May 15th Regional Council minutes was before Council.
- A staff report dated May 8, 2007, on the above noted, was before Council.

Ms. Randa Wheaton, Planner, presented the report to Council noting only the plan amendments were before Council at this time. She advised the development agreement public hearing would be held by Peninsula Community Council.

Councillor Sloane noted there was a time frame with respect to the funding and requested planning staff forward a letter to the Province advising the delay was on the part of HRM. Mr. Roberto Menendez, applicant, addressed Council advising:

- The development will be located on Agricola Street,
- The design is unique and has different elements that make it fully affordable,
- Ten units are reserved for community services,
- The design is functional and fully accessible,
- There are three barrier free units.
- The first level will be in stone and tile.
- The encroachment is nine feet above street level and is only eighteen inches,
- There will be air conditioning provided in commercial units,
- Windows, which can be opened, will only be able to be opened four inches,
- The top level will have access to four deck areas.

Mayor Kelly called for those wishing to speak either in favour of or in opposition to the

proposed By-Law.

Mr. Mick Owen, Halifax, stated he was in favour of the proposed amendment as it will see the property developed but he is not in favour of the type of development proposed.

Mr. Scott Montgomery, Halifax, stated new development needs to respond to local context and to reinforce a coherent urban structure. He stated the project has merit noting, other buildings in the neighbourhood have commercial uses on the premises; there is a major bus route along North Street; and, this development will contribute to a sustainable neighbourhood.

Mr. Pete Lavelle, Halifax, expressed concerns about the underground parking exiting onto North Street and suggested the exit be to Agricola Street.

Mayor Kelly called three times for any additional speakers. Hearing none, the following motion was placed.

MOVED by Councillor McCluskey, seconded by Councillor Younger, that the public hearing close. MOTION PUT AND PASSED UNANIMOUSLY.

MOVED by Councillor Sloane, seconded by Councillor Fougere, that Regional Council adopt the amendments to the Halifax Municipal Planning Strategy and Peninsula Land use By-Law as contained in Attachment "A" of the staff report dated February 16, 2007. MOTION PUT AND PASSED UNANIMOUSLY.

8.2 <u>Councillor McCluskey - Civic Addressing Process</u>

Councillor McCluskey stated staff have gone beyond the intent of the Administrative Order which states Council shall establish a civic address public safety committee to advise on public safety issues. She stated the direction given in the Administrative Order and the Bylaw differs. She noted changes to street or road names are to be discouraged unless there are recognized difficulties with the existing name. She noted an owner may request a change but has to pay for it when there is no public safety issue.

She stated that although it is very clear that a street be renamed only if there is unanimous support for the proposed change she does not believe this is happening. The By-law states that consideration should be given to safety concerns or confusion created for emergency and other municipal services. The Councillor stated she does not see a need for putting some residents through the expense of changing street names.

The Councillor stated she was requesting a staff report on how much involvement was there by the committee. If there is a street with historical significance associated with the name, the

street not be changed.

MOVED by Councillor McCluskey, seconded by Councillor Murphy, that staff provide a presentation and report to Council on the civic addressing process.

Councillor Younger questioned whether the committee met. He noted the By-law and policy say opposite things, the By-law says it must be numbers and the policy says it can be letters as part of an address identification.

Mr. Dan English, CAO, advised staff have completed a report which will be coming forward at a future meeting.
