The meeting was called to order at 6:00 p.m. with the Invocation being led by Councillor Rankin.

At this time Council observed a "Moment of Silence" in memory of Dr. Louis W. Collins, former civic historian for the City of Halifax, Mr. Max Hartley, former member of the Halifax Regional Police, and Mr. Roy Bowbridge, retired firefighter.

2. SPECIAL COMMUNITY ANNOUNCEMENTS & ACKNOWLEDGEMENTS

Councilor Wile congratulated the HRM firefighters on their win at the Firefighters Challenge.

Councillor Sloane noted there were seven first place finishes for HRM.

Councillor Johns thanked the RCMP, Metro Transit and HRM employees who assisted with the April Wine concert held in Upper Sackville.

Councillor McCluskey congratulated Councillor Snow on her 2nd place win in the Beaver Bank Community Fundraiser. She congratulated the paddlers who participated in the National Canoe/Kayak Championships in Ottawa.

Councillor Fougere noted the local kickoff for Arthritis Month will be held on September 5th at noon in the Horticultural hall of the Public Gardens.

Councillor Smith announced the annual Scotia Court barbecue and dedication ceremony of the Demetreous Beals Memorial Basketball Court will take place on Thursday, September 6th with rain date being Friday, September 7th. He further noted the Dartmouth North Community Carnival will be held on September 8th at the Boys and Girls Club beginning at noon.

Councillor Hum congratulated the Dunbrack girls soccer team on winning the provincial championships.

Councillor Snow advised the Waverley Gold Rush Days will be held on Sunday, September 9th.

Councillor Murphy noted twenty three concerts had been held throughout the Municipality over the last three months. He advised that the Lou Goddard field in District 11 will be dedicated at 1:00 p.m. on Sunday, September 9th.

Councillor Sloane commended staff and volunteers who participated in Summerfest 2007.

Councillor Kent noted Mr. Ian Kent of Eastern Passage has been chosen as a member of the 2008 Korean Para Olympic table tennis team.

Councillor Smith noted Black & MacDonald and community members had undertaken upgrades to the Doug Knickle park and field on July 8th.

Councillor Streatch noted that the annual Musquodoboit Fifty Mile Yard Sale will be taking place on Saturday the 8th and Sunday the 9^{th.}

9. <u>PUBLIC HEARINGS</u>

9.1 <u>By-Law S-604, An Amendment to By-Law S-600, Respecting Solid Waste</u> <u>Resource Collection and Disposal</u>

- An extract from the Draft August 7, 2007 Regional Council minutes was before Council.
- A report dated July 31, 2007, on the above noted, was before Council.

Mr Jim Bauld, Manager, Solid Waste Resources, presented the staff report to Council and clarified the following;

- HRM will provide the signage with property owners being responsible for the placement of signage on commercial bins,
- Red and yellow bags are not recommended to be used for household waste as they are the colours used by hospitals for medical waste,
- The By-Law would have to be amended to introduce the use of tags,
- Apartment buildings of less than six units are eligible for residential collection services,
- There is regular monitoring of waste from commercial businesses and if they are not in compliance, a summary offence ticket is issued as well as an information session

is held with the tenants.

Mayor Kelly called for those wishing to speak either in favour of or in opposition to the proposed Administrative Order.

Mr. Donald Wright, Dartmouth, noted some of the bag limits in other cities in Canada. He suggested that staff should visit every apartment and condo building to ensure there is a program in place and tenants are aware of their responsibilities. He urged council to continue refining the system.

Mayor Kelly called three times for any additional speakers. Hearing none, the following motion was placed.

MOVED by Councillor McCluskey, seconded by Councillor Younger, that the public hearing close. MOTION PUT AND PASSED UNANIMOUSLY.

MOVED by Councillor Karsten, seconded by Councillor Fougere, that Council approve By-Law S-604, Respecting Amendments to By-Law S-600, Solid Waste Resource Collection and Disposal By-Law.

Councillor Mosher noted the majority of residents are complying and HRM has to make it as easy as possible to encourage people to recycle, compost and divert from the landfill. She stated there is a need for a good public relations campaign. She noted there is single sort recycling in other cities and requested staff provide a memo to all Councillors on this matter.

Councillor Younger stated the ability to address tags quickly without going to a public hearing should be a part of the By-Law and placed the following motion.

MOVED by Councillor Younger, seconded by Councillor McCluskey, that the By-Law be further amended by adding a new section #7 to read as follows "Council may by administrative order establish fees and a process whereby residential properties may purchase tags or similar means to allow such properties to exceed the refuse bag limit".

Councillor Rankin expressed concern that the use of tags would create a two tier system.

Council recessed at 7:20 p.m. Council reconvened at 7:40 p.m.

Councillor Fougere stated Council needs to recognize the amendment does not mean Council

is endorsing people having more than six bags of garbage but allows for a mechanism in the by-law that would enable HRM, at some future point, to enable a tag system.

Councillor Karsten noted clear bags are used in other municipalities and stated that he would like to see the possibility of clear bags being added as the preferred next step.

AMENDMENT DEFEATED.
