1. INVOCATION

The Mayor called the meeting to order at 6:00 p.m. with the Invocation being led by Councillor Meade.

2. SPECIAL COMMUNITY ANNOUNCEMENTS & ACKNOWLEDGEMENTS

Councillor Murphy indicated that on November 15, 2008 the 6th annual North End Dance would be taking place; advising that tickets were on sale at the Halifax Forum Box Office and that all proceeds go back to community groups.

Councillor Sloane requested that the Mayor write a letter on Council's behalf to Mr. Waye Mason of the Halifax Pop Explosion to thank him and the Festival's volunteers for a job well done.

Councillor Johns indicated that he had attended the laying of the cornerstone for the new Nova Scotia Freemasons lodge on Coronation Street in Fairview on October 25, 2008; noting that it had been attended by Freemasons from all over the province.

As it was the final meeting of the current Council; Deputy Mayor Adams thanked all Councillors and acknowledge the members that would not be returning. He thanked them for four years of debate, challenges and successes; noting that they were all great people. He stated that the contributions of Councillors Snow, McInroy, Murphy, Fougere and Meade would be remembered.

The exiting Councillors were then given an opportunity to give their closing remarks to Council:

Councillor Snow stated that she had given 100 percent to her position and had done her job with honour, passion and dignity; noting that she was proud of what Council had accomplished over the past four years. She indicated that she had performed her role with honesty and no hidden agendas and that she had the upmost respect for her fellow Councillors as the general public had no idea how hard they worked. She stated that she would miss them both as colleagues and friends. Councillor Snow advised that she had respect for HRM staff for their loyalty and dedication. She stated that it had been a pleasure and that she looked forward to continuing to work in her communities. In closing, she encouraged everyone to lend a helping hand to the new Councillor for District 2.

Councillor McInroy expressed his deep gratitude to his wife, Noreen, and his children, Jennifer, Becky and Rob as well as the members of his extended family for all of their support over the years. He stated that he was humbled and honoured by the amount of times that the residents of Cole Harbour had elected him. To his colleagues on Council; he stated that he appreciated the opportunity to have served with them as they had achieved many things together. In closing, he extended his best wishes and gratitude to everyone.

Councillor Murphy acknowledged his gratitude to Councillors Meade and McInroy for all of the hard work they had put into their positions. He stated that his campaign motto had been, 'getting the job done' and that he believed that he had during his term as seven playgrounds had been constructed, a community police office had opened and the Bloomfield Centre had been saved from closure; all with Council's help. He hoped that his commitment and energy had helped over the past four years and stated that he would continue to watch over and care for his community; noting that municipal government was the closest level of government to the people. He acknowledged Councillor Snow; stating that she was a wonderful person that came from a legacy of commitment in her neighbourhood. He then stated that it had also been a pleasure working with Councillor Fougere with whom he had done a great deal of neighbourhood work. In closing, Councillor Murphy wished to thank his committed campaign team.

Councillor Fougere indicated that Councillors McInroy, Walker, Harvey, Rankin and Deputy Mayor Adams were the only remaining members from when she had started her career at City Hall a decade ago. She stated that she was the only woman on Council at that time and wished to thank her fellow Councillors for their support. She noted that it had been a wonderful ten years and wished to especially thank HRM staff for all that they do. Councillor Fougere also wished to thank her husband and children who had spent their teenage years with their mother on Council and their father as a police officer. Upon taking a look back at some of the interesting things that Council had engaged in over the past ten years; Councillor Fougere noted that her first Council day had lasted for twelve hours as it was the day that Bishop's Landing was approved. She stated that it was the first time that she had ever seen a citizen spit at a Councillor which gladly did not happen again. Councillor Fougere also recalled the Swiss Air Tragedy, Hurricane Juan and White Juan as well as climbing to the top of the McDonald Bridge and wheelchairing around downtown Halifax. In closing, Councillor Fougere stated that it had been a pleasure meeting some of the most exceptionally wonderful as well as awful people and she thanked the residents of District 14 for their support as well as everyone with whom she had worked.

Councillor Meade stated that he had been the first staff person who Councillor Fougere had met; noting that he had given her a 'how to be a good Councillor' card which she still had. He advised that it had been great working with 65 Councillors as a staff member for the City of Halifax and the HRM from 1971-1999 and as a Councillor from 1999 to present. He thanked

the call centre for answering so many calls on Councils behalf as well as HRM staff. He thanked Councillor Rankin for taking over the Prospect area in 2004 as well as his District for voting him in five times. Councillor Meade thanked Ms. Brenda Murphy-Jollimore and Ms. Linda Johnson as well as his wife Marilyn and his children, Matthew and Sarah. In closing, he wished the new Council all the best.

MOVED BY Councillor Walker, seconded by Councillor Snow that Halifax Regional Council award RFP No. 08-084, Operation of Materials Recovery Facility, to Waste Management in reference to the proposal submitted in response to the RFP, for the operations of the MRF from April 1, 2009 to March 31, 2014, at the per tonne rate and

other pricing as outlined in their response to the RFP, subject to the drafting and signing of an Agreement containing the terms and conditions of the RFP, and as outlined in the attached staff report dated September 16, 2008. Funding is from Operating Account number R330 and is outlined in the Budget Implications section of the attached staff report dated September 16, 2008.

Councillor Snow left the meeting at 6:30 p.m.

Mr. Jim Bauld, Manager of Solid Waste Resources, advised that the key variance between the top two scoring components, Miller Waste Systems and Waste Management, worked out to be approximately \$63,000 which staff considered to be quite reasonable considering the additional services which Miller Waste Systems was offering. He stated that even with the potential of HRM beginning to recycle number 3, 5 and 6 plastics there would still be a net reduction.

A discussion ensued with Mr. Bauld responding to questions. He advised that any potential additions to the contract would still be subject to staff analysis and approval by Council in 2009/10. With regards to employment; he noted that Waste Management planned to downsize while Miller Waste Systems planned to expand.

At Council's request for clarification; Ms. Mary Ellen Donovan, Municipal Solicitor, advised that if the current motion was defeated two thirds majority of Council would be required to move a motion to suspend the Rules of Order to put a motion forward to award Miller Waste Systems the contract as there had already been a negative vote taken.

MOTION DEFEATED.

MOVED BY Councillor Hendsbee, seconded by Councillor Johns that the Rules of Order be suspended. MOTION PUT AND PASSED.

MOVED BY Councillor Karsten, seconded by Councillor McCluskey, that Halifax Regional Council award RFP No. 08-084, Operation of Materials Recovery Facility, to the highest scoring proponent Miller Waste Systems, for the operations of the MRF from April 1, 2009 to March 31, 2014, at the per tonne rate and other pricing as outlined in their response to the RFP, subject to the drafting and signing of an Agreement containing the terms and conditions of the RFP, as outlined in the staff report dated September 16, 2008. Funding is from Operating Account number R330 and is outlined in the Budget Implications section of the staff report dated September 16, 2008, MOTION PUT AND PASSED.
