1. INVOCATION

The Mayor called the meeting to order at 6:02 p.m with the Invocation being led by Councillor Hendsbee.

2. SPECIAL COMMUNITY ANNOUNCEMENTS & ACKNOWLEDGEMENTS

Councillor Sloane acknowledged that the IWK's 100th anniversary will be celebrated on Sunday, December 20, 2009, at 2 p.m. A Christmas Carol starring Jeremy Webb will be held December 21, 2009 at 6 p.m. at the George Dixon Centre. Free admission.

Councillor Hendsbee acknowledged that HRM's very own municipal singers will be performing for a judging competition at 2 p.m on December 16, 2009 in front of City Hall. These winter lights competitions are being held across the country. He indicated that a basket ball tournament will be going on in East Preston the weekend of December 19, 2009. It is called the Out Home Community Basketball Challenge. Teams from various streets from the community of East Preston, in collaboration with the East Preston Boys and Girls Club, and the young men in the Community will be playing. This will be held Saturday and Sunday, December 19, and 20 with a dance being held December 19 at the Recreation Centre. Net proceeds will be going to the underprivileged kids in the community. He reminded residents of the New Years Eve festivities at the Grand Parade Square December 31, 2009 and the New Years Day Levy on January 1, 2010 starting at 9 a.m. at City Hall.

Councillor Mosher acknowledged that Council Wile, Walker and herself were part of the first meeting of the former Chester Rail Way Trail executive group. This group is moving forward to becoming a society and at that time, the meetings will be open to the public. Membership will also be open to the public. Councillor Mosher, on behalf of herself and Councillor Adams announced that the second Annual Holiday Charity Bowl is being held at the JL Illsley High School on December 17, 2009 at 1:30 p.m. It is JL Illsley High School Judges vs the Eastern Shore Schooners. Cost will be \$2.00.

Councillor Adams announced that he will be opening a new 1.2km trail on the MacIntosh Run. He further acknowledged that he and Councillor Mosher opened another new foot bridge over the MacIntosh Run which runs over the Herring Cove Road to the Captain William Spry Centre on December 14, 2009. He encouraged anyone to try the new skate board park adjacent to the Captain William Spry Centre. Councillor Adams also announced that on Monday, December 14, 2009 at 5 p.m. the Herring Cove Sewage Treatment plant began operating.

Councilor Streatch indicated that there was a Christmas Concert at the Middle Musquodoboit Education Centre, December 15, 2009 at 7 p.m.

Councillor Streatch retired from the meeting at 6:30 p.m.

Councillor Blumenthal thanked the community for coming out December 14, 2009, to help celebrate the Jewish festival of Hanukkah and the lighting of the 4th night of the candle. He reported that Highland Park would be holding their second Christmas luncheon on December 17, 2009. Ward 5 will also be holding their Christmas luncheon at 12 noon on December 17.

Councillor McCluskey wished the Mayor, Members of Council, staff and residents of HRM a Merry Christmas, and a Happy New Year. She also advised Council that this would be the last night of Council for Ms. Geri Kaiser, DCAO, Corporate Services and Strategy as she was retiring effective December 31, 2009

Councilor Wile congratulated Park West School for holding their first tree lightening ceremony on December 14, 2009. Justin Verge, a grade primary student, had been selected to do the honour of turning the switch.

Councillor Lund acknowledge the St. Margaret's Lions Club for holding their annual Christmas tree sale. Money from the sale of the trees goes to people in need. The club under the direction of Mr. Jim Swim started originally with 600 trees and at last tally had only 8 remaining.

Councillor Fisher reminded residents that the Pancake breakfast with Santa is coming up on Saturday, December 19 at the East Dartmouth Community Centre from 9 a.m. till noon. This breakfast is in support of the East Dartmouth Boys and Girls Club and the Rotary Club.

Councillor Outhit advised that he will be cutting the ribbon at the Bedford South School. Parents raised over \$100,000 for the playground.

Councillor Dalrymple congratulated the Fall River Lions Club for selling their 400 Christmas trees. On December 17, 2009, the Club will be getting together for packing and loading food boxes along with turkeys and hams to go out for the Christmas season.

A petition containing 54 names was submitted by Councillor Steve Streatch from the Northwest Cove Cottage Association to have an access road built from Hwy #7, starting

at Jeddore, Halifax County and to cover approximately five kms. to Northwest Cove on Lake Charlotte.

10. <u>REPORTS</u>

10.1 CHIEF ADMINISTRATIVE OFFICER

10.1.1 Unsolicited Proposal - Harbour Ferry

This matter was dealt with after Item 10.1.2. See page 11.

10.1.2 Case 01327 - 26 Bridge Street, Bedford

- A staff report dated November 13, 2009 was before Council
- Correspondence from Ms. Jen Macleod regarding the petition previously submitted were also before Council.

Councillor Outhit requested a staff presentation before he would put the motion on the floor.

Mr. Miles Agar, Planner I reviewed the presentation with Council noting that this is an application by the Terrain Group Inc. to enter into a development agreement at 74 Union St, Bedford with an access across 26 Bridge Street Bedford proposed. He noted that the development agreement falls under the jurisdiction of the Northwest Community Council while the consideration of a different access route is the jurisdiction of Regional Council. Regional Council must authorize the initiation of a plan amendment process for the Bedford MPS and LUB.

Mr. Agar reviewed the current zoning of the lands in question, acknowledging that most of Union Street is zoned Residential Comprehensive Development District (RCDD) and was developed through Development agreement except this small parcel of land. He advised that limiting the access to 74 Union St will limit the development options available.

Mr. Agar concluded his presentation and answered the questions of Council as follows:

- as the zoning for 26 Bridge currently stands, it does not permit a driveway or private road access across the property in order to enable development
- according to the Bedford MPS there must be adequate open space
- Initiating the process to consider amending the Bedford MPS and LUB to include 26 Bridge Street, will allow staff and the public to consider 26 Bridge St as an incorporated piece in the overall development
- the type of access would be limited to a private driveway not a public road due to insufficient frontage onto both properties

- the number of townhouses would be considered via the development agreement which would fall under the jurisdiction of Northwest Community Council
- in order to include 26 Bridge Street in the townhouse development the zoning would need to be changed to RCDD
- the proposal does not require two accesses for fire services

Deputy Mayor Johns clarified that what is being asked tonight is only that staff be authorized to initiate the process to consider amending the Bedford Municipal Planning Strategy and Land Use By-law and that there would be further opportunities for Council to debate the other issues.

Further discussion ensued with the following highlights noted:

- the is no opportunity to appeal Council's decision to the Nova Scotia Utility Review Board
- if the process is initiated by Council tonight, it would take a minimum of a year to complete the process
- regardless of the decision of Council, 74 Union Street can proceed by way of development agreement with approval from Northwest Community Council

Ms. Thea Langille, Supervisor, Planning Applications, Central Region provided clarification that the proposal for 74 Union Street does not have any as of right abilities, this proposal requires a public process and it does require a decision of the Community Council. She further advised Council that this process is in the very early stages. Information is available on the website and staff have received various phone calls from residents, signage is available on the property notifying residents of this application. Direction to proceed would need to be given by Council to hold a formal public information meeting.

MOVED By Councillor McCluskey, seconded by Councillor Karsten, that Regional Council:

- Authorize staff to initiate the process to consider amending the Bedford Municipal Planning Strategy and Land Use By-Law to include 26 Bridge Street with the Union Street Residential Comprehensive Development District (RCDD); and
- Direct Staff to follow the public participation program as approved by Council in February 1997.

Councillor Outhit respectfully asked Council not to support the motion on the floor. He noted that not supporting the motion will not stop development but would speak to what development can be carried out. It may inflict some challenges and additional costs to the developer but, in his opinion, it is the right course of action.

Councillor Hum requested that the wording of the petition pertaining to this application be read into the record. The Municipal Clerk clarified the petition is to prevent a zoning change at 26 Bridge Street from residential single unit to residential comprehensive development district.

Councillor Outhit requested a recorded vote on the following motion
