Councillor Harvey noted the passing of Frank Sutherland, long time Councillor and employee of the County of Halifax and volunteer.

A moment of silence was observed in memory of Mr. Henry and Mr. Sutherland.

Councillor McCluskey thanked and congratulated organizers and participants of the 30th annual SEDMHA Honda International hockey tournament that was held last week, with over 260 teams attending.

Councillor Fisher extended congratulations to the Dartmouth Whalers Peewee AA who won the Provincial Championship last week.

Councillor Dalrymple noted that this is Cathy O'Toole's last Council session as the Director of Finance. He thanked her for 10 years of service and wished her all the best in the future.

Councillor Adams advised that April is daffodil month in support of the Canadian Cancer Society.

Councillor Watts noted a meeting on April 6, 2011 at 7:00 p.m. at St. Agnes School Library regarding maintenance to the Westmount playground. There will also be a meeting on April 14th at 7:00 p.m. at the St. Andrews Community Centre regarding maintenance of the Flynn Park playground and park.

- 10.1.1 Proposed Administrative Order SC-64, Respecting Closure of a Portion of Purcell's Cove Road Right-of-Way, Purcell's Cove

10.1.2 2011 Spring Debenture

A staff report dated March 23, 2011 was before Council.

MOVED by Councillor McCluskey, seconded by Councillor Nicoll, that Halifax Regional Council authorize the Mayor and Municipal Clerk to sign the Resolution for Pre-Approval of Debenture Issuance Subject to Interest Rate confirmation not to exceed 6.5% to enable the Halifax Regional Municipality to issue a 10-year debenture in the amount of \$13,250,000. MOTION PUT AND PASSED.
