1. INVOCATION

Mayor Kelly called the meeting to order at 3:04 p.m. with the Invocation being led by Councillor Rankin.

2. SPECIAL COMMUNITY ANNOUNCEMENTS & ACKNOWLEDGEMENTS

Councillor Sloane thanked Mayor Kelly and the volunteers who attended the Uniacke Square Beautification Day. She reminded residents of the Mawio'mi PowWow being held on the Halifax Common from July 1 - 3, 2011.

Councillor Wile indicated that the final crime prevention series meeting would be held at the Canada Games Centre on June 22, 2011.

Councillor Hendsbee congratulated the Boston Bruins on winning the Stanley Cup and requested that Mayor Kelly send a letter to Halifax native, Mr. Brad Marchand. He announced that a Marine Drive Valley and Canal Community Council meeting would be held on June 22, 2011 and that on June 25, 2011 the Orenda Canoe Club would be hosting a free paddling day.

Councillor Blumenthal announced that the Imagine Bloomfield annual general meeting would be held on June 22, 2011 and the Ward 5 annual general meeting on June 27, 2011.

Councillor Mosher thanked the following for taking part in the grand opening of the Chain of Lakes Trail: sponsors J & M Murphy Petrocan - Joseph Howe Drive, Superstore - Joseph Howe Drive, Shoppers Drug Mart - Joseph Howe Drive, Bulk Barn - Joseph Howe Drive, Ms. Olga Milosevich from CBC who was master of ceremonies, band members Mr. Mark DeWolf and Mr. Ron Fitzgerald, organizing committee members Mr. Peter Driscoll, Mr. Joseph Faddoul, Ms. Joan MacKinnon, Mr. Oliver Berrigan and Ms. Madeline Berrigan, and Senator Fred Dickson, MLA Graham Steele, Mayor Peter Kelly and Councillors Watts, Hum, Walker, Wile and Adams. Councillor Mosher also thanked Public Works staff for clean up of garbage, debris and graffiti; especially Mr. Don Pellerine for working with Halifax Regional Police to make three subsequent graffiti – related arrests on the Trail at the Northwest Arm Drive provincial highway underpass.

Councillor Adams thanked Mayor Kelly, Councillor Mosher and members of the community team who helped plant flower beds at the intersection of North West Arm Drive and Old Sambro Road. He also announced that the grand opening of the new Herring Cove fire hall would take place on June 25, 2011.

Councillor Watts stated that a public information meeting regarding the rezoning of a property on the corner of Oxford and Oak Streets would be held on June 22, 2011 at the HRM Planning Offices and that an Affordable Housing Seminar would be held on June 27, 2011. She also congratulated all graduates.

Councillor McCluskey announced that a Summer Special Household Hazardous Waste Drop off Day would be held on June 25, 2011.

Councillor Dalrymple announced that the Beaverbank Kinsac Community Centre Board would be hosting their annual general meeting on June 23, 2011 and advised that the tender bids for building the new community centre had opened the week prior and would be announced at the meeting.

Deputy Mayor Smith advised that the semi annual meeting for the Farrell Benevolent Society would be held on June 29, 2011 and that Business is Jamming was offering a free Break into Business camp for youth at the Bloomfield Centre in July. He also thanked the Take Action group in District 9 who conducted a clean up around Harbour View School.

Councillor Lund announced that on June 24 and 25, 2011 several non-governmental organizations would be hosting their fourth annual forum in St. Margaret's Bay with the focus this year being coastal management issues. He also announced the grand opening of the 65 Firehall in Upper Tantallon on June 25, 2011 and that a bike rally would be held on June 26, 2011 by the Greater Hammonds Plains Residents Association to raise awareness and promote bike lanes on Hammonds Plains Road.

Councillor Fisher stated that the Kinsmen monthly community breakfast would be held on June 26, 2011 at the East Dartmouth Community Centre.

Councillor Nicoll announced that a Westphal Cole Harbour firefighter would be spending 48 hours on a ladder starting on June 24, 2011 in order to raise money for muscular dystrophy research.

A report dated May 26, 2011 was before Council.

MOVED by Councillor Sloane, seconded by Councillor Karsten that Halifax Regional Council:

MOVED by Councillor Harvey, seconded by Councillor Sloane that Halifax Regional Council:

1. Recognize Lower Sackville, Middle Sackville and Upper Sackville as official HRM Communities as outlined on the map in Appendix B of the report

dated May 16, 2011 and authorize staff to install community signs at their boundaries; and

2. Modify the Lakeview Community boundary, at Lower Sackville, as outlined on the map in Appendix C of the report dated May 16, 2011 and authorize staff to relocate the current community sign.

Councillor Harvey advised that some community members wanted to name the entire community Sackville; however, there were some postal issues with this suggestion and he also did not feel support was strong enough to undergo such a large change at this time; noting that the whole area functions well as a community.

11.1.5 Appointment of Building Official

A report dated May 18, 2011 was before Council.

MOVED by Councillor Watts, seconded by Councillor Walker that Halifax Regional Council appoint Kenneth Swinimer as a Building Official, pursuant to Section 5(2) of the Nova Scotia Building Code Act. This appointment is effective for the duration of his current conditions of employment with Halifax Regional Municipality. MOTION PUT AND PASSED.

11.2 HERITAGE ADVISORY COMMITTEE

11.2.1 Case 16217 – Substantial Alteration and Heritage Development
Agreement – Municipally Registered Heritage Property - 10 Kirk Road,
Halifax

A report from the Heritage Advisory Committee dated May 30, 2011 was before Council.

On behalf of Councillor Mosher, Councillor Adams moved the following motion:

MOVED by Councillor Adams, seconded by Councillor Walker that Halifax Regional Council approve the substantial alteration to the municipally registered heritage property as described in the development agreement contained in Attachment A of the May 5, 2011 staff report.

Discussion on the motion ensued.

Regarding a previous suggestion in relation to an ongoing Private Ways Act matter, Ms. Mackenzie Stonehocker, Planner, advised that Marterra Inc. had advised her that 10 Kirk Road does not have a relationship to the property in question as far as a right of way is concerned.

Councillor Harvey advised that this was the understanding of the Heritage Advisory Committee members and staff as well; noting there would be no public road access even if there was a right of way.

Councillor Mosher stated that she had discussed this matter with legal staff and there was currently no consideration for a public right of way. She requested that Ms. Karen MacDonald, Solicitor, submit the pertinent information to Chebucto Community Council for the record.

MOTION PUT AND PASSED.

Councillor McCluskey left the meeting at 3:43 p.m.

11.3 HALIFAX WATER

11.3.1 Harbour Solutions Project in Review

A presentation was submitted.

Mr. Carl Yates, General Manager of Halifax Water, provided the presentation on the Harbour Solutions Project in Review.

On behalf of Council, Mayor Kelly thanked Mr. Yates, his team and all stakeholders involved in this project.

A discussion on the presentation ensued with staff responding to questions. The following points were noted:

- All deficiencies have been corrected and the Halifax Wastewater Treatment facility has reached total completion status; there are three year warranties in place in case of the occasional defect
- The \$3,000,000 in surplus will remain with Halifax Water and its rate payers in accordance with the 2007 transfer agreement with HRM
- The pumping station at Pier A will have one more performance review in the fall

- It was suggested that staff contact the provincial and federal government for potential cost sharing options in order to complete the Herring Cove Sewer and Water Project
- Capacity will be increased at the Eastern Passage facility which will create an improvement in water quality
- The new Canadian Council of Ministers of the Environment (CCME) wastewater strategy speaks to combined sewer overflow management plans and Halifax Water will need to file a plan with the Department of Environment to increase frequency and duration over time which Halifax Water will be measuring and managing
- Concern was expressed regarding the consistency water quality objectives as residents are sceptical about swimming because it rains and they are unsure if it is safe
- Concern were also expressed regarding the length of time it takes to obtain water testing results
- A chart of results and what further environmental enhancements would be done at the facilities was requested
- It was suggested that Halifax Water be nominated for the 2012 Federation of Canadian Municipalities' Sustainable Communities Award for the Harbour Solutions project
- Intervention and resident compliance will be a continuing program

The Mayor reviewed the Rules of Procedure for Public Hearings and opened the hearing for anyone wishing to speak.

The Mayor called three times for anyone wishing to speak; there being no response, it was MOVED by Deputy Mayor Smith, seconded by Councillor Sloane, that the public hearing close. MOTION PUT AND PASSED.

MOVED by Councillor Lund, seconded by Councillor Walker, that Regional Council:

- 1. Approve the proposed amendments to the Planning Districts 1 & 3 (St. Margaret's Bay) Municipal Planning Strategy and Land Use By-Law as contained in Attachments "A" and "B" of the March 11, 2011 staff report; and
- 2. Approve the proposed amendments to the Beaver Bank, Hammonds Plains and Upper Sackville Municipal Planning Strategy and Land Use By-Law as contained in Attachments "C" and "D" of the March 11, 2011 staff report.

MOTION PUT AND PASSED.

Councillor Streatch rose on a point of personal privilege, asking that the Notices of Motion put forward earlier in the day by Councillors Lund and Uteck for the Council session next week be dealt with this evening.

The Mayor clarified that with a 2/3 majority vote, the Rules of Order could be suspended to allow the Motions to be brought forward at this meeting.

MOVED by Councillor Streatch, seconded by Councillor Karsten, that the Rules of Order be suspended. MOTION PUT AND PASSED.

The Solicitor clarified that it is up to the Councillor that placed the Notice of Motion whether they are agreeable to bringing forward their motion for consideration.

13. ADDED ITEMS continued

13.4 MOTION - Councillor Lund

MOVED by Councillor Lund, seconded by Councillor Uteck, to request that the Province amend the HRM Charter to include the provision that "breach" of trust, regardless of personal gain is punishable by law, in order to ensure those responsible of breach be held accountable to the extent of law and ethics.

Councillor Lund clarified that the reason the recent concert funding scandal could not go through an RCMP investigation was that a breach of trust and personal gain would have to be demonstrated, which would fall under the Federal Criminal Code. The intent for this motion is to make punishable a breach of law, in this case the HRM Charter, outside of the Criminal Code.

Councillor Hendsbee suggested that the intent of the motion should be forwarded to the Province to consider amending the Municipal Government Act (MGA), or to the Union of Nova Scotia Municipalities (UNSM) for their consideration.

With the agreement of the Mover and Seconder, it was MOVED by Councillor Hendsbee, seconded by Councillor Streatch, that the motion be amended to replace "HRM Charter" with "Municipal Government Act" and to refer the proposed amendments to the UNSM for policy debate. MOTION PUT AND PASSED.

13.5 MOTION – Councillor Uteck

It was clarified that Councillor Uteck's Notice of Motion was to "bring a motion of censure to the office of the Mayor for one week".

Councillor Uteck clarified that this motion is intended to put an end to the actions associated with the recent concert funding scandal, which she feels have cast a shadow on the ethical behaviour and general competency of Regional Council and certain HRM staff members. The intent of the motion is to acknowledge that members of Council accept and agree that although the concert scandal did not involve criminal acts it did result in misdirected public anger, negative public perception and public outrage that is reflected in an undeserved manner on HRM Councillors. This motion seeks to address the notion that some representatives of HRM have acted in a misguided and inappropriate manner that has brought HRM as an organization into disrepute and unnecessarily burdened the citizens of HRM. This motion acknowledges and accepts that while criminal behaviour, nor the notion of intentional deceit were ever intended, the actions of those individuals involved has harmed this municipality and those actions

must be responded to with some kind of consequence with recorded measure and meaning.

MOVED by Councillor Uteck, seconded by Councillor Lund, that Regional Council approve a period of censure on the Office of the Mayor for one week.

Councillor Uteck commented that this period of censure would take effect immediately in recognition of the Mayor's actions and responsibilities related to the concert funding scandal. During this period, the Mayor would remove himself from the Office of the Mayor, not act on behalf of the Municipality or campaign for his re-election. He would not be able to comment publically on the censure or concert funding scandal. The motion is of a temporary nature, reflects the displeasure of Council and the acknowledgement of the Mayor of his errors in judgment in relation to this matter. She noted that the former Acting CAO resigned his position in acknowledgement of his errors in judgment related to this scandal.

The Mayor asked for clarification from Councillor Uteck whether she agreed to bring forward the Motion at this meeting, to which Councillor Uteck responded that in order for members of Council to understand the intent of her earlier Notice of Motion, she does agree to bring this forward to defend her position.

The Solicitor clarified that the Councillor does have the option of bringing forward the motion at this meeting, or another Councillor may bring her motion forward.

Councillor Watts inquired whether Council had authority to bring censure, and the Solicitor advised that s. 3.3 of Administrative Order One states that the rules of the Nova Scotia Legislature shall be followed in all cases not provided for in the Admin Order. Under the rules of the Legislature, certain remedies against members can be taken, such as censure. The Solicitor clarified further that the only power the Province has to remove members, is to remove a Council as a whole, not to remove individual members.

At the request of Councillor Karsten, Councillor Uteck clarified that she chose the one week time period for the censure.

At the request of Councillor Karsten, the Solicitor advised that the censure rule is designed for any member. Councillor Karsten noted concern that this may set a precedent for Councillors placing censure against each other.

Councillor Walker challenged the legal opinion of the Solicitor, noting that he has never heard of such a rule being available to members of Council, and questioning why members of Council were not advised of this remedy on previous occasions when legal advice was sought regarding remedies to the scandal.

Councillor Hendsbee, as a previous Member of the Legislative Assembly, commented that his understanding is that the censure rule was intended to allow to have someone removed from the chamber to preserve decorum of the meeting. He suggested that this matter should be referred to UNSM as well for debate.

Councillor Outhit commented that in light of new legal advice provided at this meeting, members of Council should have more time to give consideration to the motion to make an informed decision. He noted that research should be conducted on the use of censure in other municipalities and the length of time that the penalty is imposed.

MOVED by Councillor Outhit, seconded by Councillor Watts, that this matter be deferred.

The Solicitor **ruled this motion out of order** as Council approved by a two thirds motion to suspend the rules of order to deal with the motion at this meeting. A motion of deferral would be in inconsistent with the previous motion.

Council recessed at 7:39 p.m., reconvening at 7:50 p.m.

Discussion on the motion ensued.

MOVED by Councillor Watts, seconded by Councillor Sloane, that the motion now be put. MOTION PUT AND PASSED.

Councillors Harvey, Outhit and Lund moved to seats in the gallery. It was clarified that if a member refrains from voting while they are in the Council Chamber, their vote will be counted against the motion.

Councillors Lund and Outhit left the meeting.

A recorded vote on the original motion was taken at this time with 3 in favour, and 17 against. **MOTION DEFEATED.**

Those voting in favour were Councillor Fisher, Deputy Mayor Smith, and Councillor Uteck.

Those voting against were Mayor Kelly and Councillors: Adams, Barkhouse, Blumenthal, Dalrymple, Harvey, Hendsbee, Hum, Karsten, Mosher, Nicoll, Rankin, Sloane, Streatch, Walker, Watts and Wile.

Councillors McCluskey, Johns, Outhit and Lund were not in attendance.
