### 2. <u>APPROVAL OF THE MINUTES - November 16, 2004</u>

MOVED by Councillor Harvey, seconded by Councillor Meade, that the minutes of November 16, 2004, be approved. MOTION PUT AND PASSED UNANIMOUSLY.

# 3. <u>APPROVAL OF THE ORDER OF BUSINESS AND APPROVAL OF ADDITIONS</u> AND DELETIONS

MOVED by Councillor Rankin, seconded by Councillor Fougere, that the Order of Business be approved. MOTION PUT AND PASSED UNANIMOUSLY.

# 4. **COMMUNITY COUNCIL BOUNDARIES**

- A report prepared for Mr. George McLellan, dated November 24, 2004, was before Council.
- Correspondence from Howard Epstein, MLA, Maureen MacDonald, MLA, Marilyn More, MLA, dated December 3, 2004 was circulated to Council.
- C A copy of the overhead presentation, was circulated to Council.

Mr. Dan English, Deputy CAO, gave a brief overview of the report for the information of Council, noting the Community Council boundaries had changed and, as a result, the new boundaries need to be put in place. He suggested the portion of the recommendation pertaining to the exclusions could be addressed at a later date.

MOVED by Councillor Rankin, seconded by Councillor Meade, that Regional Council endorse in principle the following community council boundaries:

#### Group A:

- C Marine Drive, Valley & Canal Community Council: Districts 1, 2 and 3;
- North West Community Council: Districts 19, 20 and 21
- Chebucto Community Council: Districts 10, 15, 16, 17, and that portion of District 18 within the former City of Halifax
- Western Region Community Council: Districts 22 and 23 and that portion of District 18 within the former Halifax County Municipality; and

#### **Group B:**

- C Harbour East Community Council: Districts 4, 5, 6, 7, 8 and 9 excluding the area shown on Map 1, of the staff report dated November 24, 2004
- C Peninsula Community Council: Districts 11, 12, 13, and 14 excluding the area shown on Map 2, of the staff report dated November 24, 2004

Without a vote being taken on the motion on the floor, the following amendment was placed:

MOVED by Councillor McInroy, seconded by Councillor Kent, that Regional Council approve the staff recommendation with the exclusion of the words "excluding the areas shown in Map 1 from the Harbour East Community Council and excluding the areas shown in Map 2 for the Peninsula Community Council."

At the request of Councillor Fougere, Council agreed to split the vote on the exclusions portion of the recommendation relative to the Harbour East and Peninsula Community Council.

#### Part 1

MOVED by Councillor McInroy, seconded by Councillor Kent, that Regional Council endorse the boundaries of Harbour East Community Council to include Districts 4, 5, 6, 7, 8, and 9 of the Halifax Regional Municipality. MOTION PUT AND PASSED.

# Part 2

MOVED by Councillor McInroy, seconded by Councillor Kent, that Regional Council endorse the boundaries of Peninsula Community Council to include Districts 11, 12, 13 and 14 of the Halifax Regional Municipality. MOTION DEFEATED.

#### MOTION AS AMENDED

MOVED by Councillor Rankin, seconded by Councillor Meade, that Regional Council endorse in principle the following community council boundaries:

#### Group A:

- Marine Drive, Valley & Canal Community Council: Districts 1, 2 and 3;
- North West Community Council: Districts 19, 20 and 21
- Chebucto Community Council: Districts 10, 15, 16, 17, and that portion of District 18 within the former City of Halifax
- Western Region Community Council: Districts 22 and 23 and that portion of District 18 within the former Halifax County Municipality; and

- C Harbour East Community Council: Districts 4, 5, 6, 7, 8 and 9.
- C Peninsula Community Council: Districts 11, 12, 13, and 14 excluding the area shown on Map 2, of the staff report dated November 24, 2004
