# **ORIGIN**

At the March 4, 2014 meeting, Regional Council directed staff to assess the merits of including the additional lands requested by WSP Canada Limited in the Secondary Plan Area as outlined in Map 1 of Attachment E of the February 11, 2014 staff report, under the Land Suitability and Pre-design Baseline Infrastructure Capacity studies (Attachment A – February 11, 2014 Staff Report)

#### LEGISLATIVE AUTHORITY

At the March 4, 2014 meeting, Regional Council adopted a public participation program for the Port Wallace Secondary Planning process. The program included formation of a public participation committee with a mandate which included making recommendations regarding any policy and regulatory amendments proposed for the Port Wallace Secondary Plan Area

# **RECOMMENDATIONS**

The Port Wallace Public Participation Committee recommends that the North West and Harbour East – Marine Drive Community Councils recommend that Halifax Regional Council consider the Conrad request to:

- 1. have 470 acres of its quarry lands zoned for industrial uses and proceed with a separate planning process from that of the remainder of Port Wallace;
- 2. have a 53 acre parcel included in the Port Wallace secondary planning process to allow for residential development; and
- 3. allow for 242 of the 470 acres of the quarry lands to be serviced with municipal water and wastewater services and to allow for highway commercial uses on this portion of the property.

# **BACKGROUND**

Conrad requests were discussed at the June 15 and June 29, 2016 meetings of the public participation committee. Planning staff provided background on the requests and circulated a map illustrating the lands subject to the requests. Tom Swanson, a consultant representing the Conrads was also in attendance and responded to questions.

#### DISCUSSION

The committee was satisfied that the requests were worthy of further consideration. It was noted that the committee was not recommending approval of the Conrads requests at this time.
