SUBJECT: Eastern Passage High School – Public Enhancements

INFORMATION REPORT

ORIGIN

May 14, 2015 Harbour East-Marine Drive Community Council motion:

MOVED by Councillor Karsten, seconded by Councillor Fisher, that Harbour East-Marine Drive Community Council request a staff report in regard to proposed upgrades to the construction of the Eastern Passage High School; specifically, in relation to a proposed artificial turf and multi-purpose arts and culture space. MOTION PUT AND PASSED

LEGISLATIVE AUTHORITY

- Halifax Regional Municipality Charter, Section 79 (1), including: (k) recreational programs; and (x) lands and buildings required for a municipal purpose.
- Community Facility Master Plan, approved by Regional Council on May 27, 2008.

BACKGROUND

In April 2012, the Minister of Education announced the construction of a high school for Eastern Passage and area, to be completed in September 2014. The announcement identified that the existing Seaside Elementary School would be renovated to provide for the new school.

When a new school or substantial alteration project is announced by the Province, the Municipality is afforded the opportunity to fund enhancements for community purposes through the *Education Act.* HRM staff review the associated community recreation needs for opportunities to meet municipal recreation service provision through these potential enhancements. The announcement of the Eastern Passage project resulted in HRM staff being directed to complete a Recreation Needs Assessment in order to identify whether there were recreation needs in the area which could be met through a school enhancement.

The ensuing Recreation Needs Assessment (Attachment 1) resulted in Regional Council approving a joint partnership with the Province and Halifax Regional School Board to add 2,100 square feet (sf) of gymnasium space, at an estimated net cost of \$630,000 as a community enhancement, at their January 15, 2013 meeting.

The high school project was initiated but was halted by the Province prior to construction, as a result of design challenges and escalating costs associated with the scope of work required to convert the existing elementary school into a high school. As a result, the Department of Education decided to change the project to include construction of a new facility. Subsequent to that decision, on March 10, 2015, Regional Council approved sale of land for the new school to the Province. Design of the new school on that site is currently underway. A School Steering Team has been struck with representatives from the Province, local school advisory boards, HRM and Halifax Regional School Board staff. Construction of the school is now estimated to be completed early in 2018.

On May 14, 2015, the Harbour East-Marine Drive Community Council received a presentation (Attachment 2) from a group of Eastern Passage residents representing Community Education Enhancement Project (CEEP). The purpose of their organization is to seek additional upgrades to the new Eastern Passage high school. Harbour East-Marine Drive Community Council subsequently requested a staff report on potential additional upgrades.

DISCUSSION

Typically, Regional Council has approved expansion of gymnasia and additional program space as community enhancements in school projects (Attachment 3). Construction of new or renovation schools have not historically been the catalyst for upgrading fields. Improvements to sports fields are considered through HRM's capital budget process.

Subsequent to the direction from Community Council, HRM staff met with representatives of CEEP to outline the facility planning process and the results from the Eastern Passage Recreation Needs Assessment. Staff also explained the role of the Community Facility Master Plan as a decision making tool for Regional Council.

The presentation by CEEP to Community Council outlined a request for two considerations with the following justifications:

- 1. <u>Arts and Culture Upgrade</u> Build multi-purpose space (cafetorium and rooms) and provide sound, lights, and seating for arts and culture usage.
 - There is a strong history of arts and culture in the community
 - o Facilities are limited in Dartmouth area
 - o It is a venue that could be used by students and the community

- Recreation Field Upgrade Convert one soccer field at Eastern Passage Commons into an allweather field with an 8 lane track
 - o 4 soccer fields in Eastern Passage (1:3,248 residents vs 1:2,750 as Halifax standard);
 - The ratio of fields to citizens indicates a need
 - Health indicators and obesity levels warrant greater access to recreation facilities
 - o An artificial all weather fields reduce cancellation rates due to weather

The CEEP presentation further requested that the Provincial Government could contribute \$300k to the cost of the artificial turf field through the high school project with HRM contributing the remaining capital cost, and that the 8 lane track could be cost shared equally between HRM and the community. The presentation outlined a request for \$400k from HRM towards the arts and culture performance space with the remaining funding being provided by the Province of Nova Scotia.

Staff has reviewed the additional enhancements requested above by CEEP in relation to the Eastern Passage Recreation Needs Assessment completed in 2012.

Request for Arts and Culture Upgrade

Staff supports the inclusion of a cafetorium in the Eastern Passage school design which will support local arts and culture. HRM has typically worked with the Province on the design of new schools to include the provision of a cafetorium in place of a cafeteria. These changes have not required any additional construction funding from HRM but have provided the opportunity for cultural programming in the schools. Performance infrastructure such as sound, lights and seating have been historically funded through fundraising, area rates, grants, or a combination thereof.

Request for Field Upgrade

The Eastern Passage Recreation Needs Assessment includes the following commentary regarding outdoor facilities:

"Current outdoor facility inventory in Eastern Passage consists of 4 sport fields (natural turf), 4 ball diamonds (natural turf), 6 outdoor basketball courts, 1 tennis court (converted to an outdoor rink in winter), 10 playgrounds and 1 Skateboard Park. HRM staff is responsible to book all the outdoor facilities including the Eastern Passage Education Centre (P3 school)."

The information submitted within the CEEP presentation outlined that the ratio of fields to population did not meet the "Halifax Standard" and as a result indicated a need in the community. However, the ratio analysis provided in the CEEP analysis was not consistent with that completed as part of Eastern Passage Recreation Needs Assessment and as a result differed from the municipal ratio.

The analysis completed as part of the Eastern Passage Recreation Needs Assessment determined that the ratio of field supply to population for the Eastern Passage area was generally consistent with the 2008 Community Facility Master Plan (CFMP) recommendations. Chart 6 from the Eastern Passage Recreation Needs Assessment (Attachment 1) summarizes sport field supply by population for Eastern Passage compared to the municipality as a whole. It demonstrates that the community is sufficiently served, not only in terms of availability, but also in terms of quality.

Football in Eastern Passage / Cole Harbour

Football Nova Scotia has confirmed that there are currently no unaddressed requests for football specific infrastructure in Eastern Passage. That confirmation is consistent with HRM scheduling data. Youth living in Eastern Passage are currently accommodated in football by playing either in the Dartmouth Destroyers Minor Football Association, or in the Cole Harbour District High School football team.

Practices for high school and minor sport football typically take place on natural turf fields at schools and throughout the municipality. Games are all accommodated on artificial turf fields with appropriate field-of-play and infrastructure. Dartmouth Destroyers Minor Football play their home games at Halifax East artificial turf field (Commodore Drive) and Cole Harbour District High School plays their televised games

at Bedford Hammonds Plains artificial turf field (accommodates television broadcast) and their other home games at the Halifax East (Commodore Drive) artificial turf field.

Consistent with other local high schools, it is anticipated that if the new Eastern Passage High School develops a football team, practices will be held on natural turf fields and games take place at either the new Cole Harbour artificial turf field or Halifax East (Commodore Drive) facility.

Artificial Turf Fields

Regarding the request by CEEP for additional artificial turf fields, the CFMP states that "Three additional artificial turf fields should be constructed (in the municipality) as a means to meet the increasing demand for outdoor field sports."

Since the approval of the CFMP, Soccer Nova Scotia has opened a new indoor artificial turf facility on the Mainland Common with the assistance of the Municipality and one new artificial turf field has been opened in Bedford/Hammonds Plains bringing a total of ten artificial turf fields in HRM. Regional Council has also approved an eleventh artificial turf field for construction in Cole Harbour, which will improve the geographical distribution of fields across the municipality and meet the recommendations from the 2008 CFMP. In addition, work is currently underway at the Mainland Common field which will incorporate permanent uprights onto the field, thereby enhancing the field's capability for football.

CEEP Estimated Capital Cost

The CEEP presentation (Attachment 2) outlined potential funding for the provision of an artificial turf field being cost shared between HRM and the Province of Nova Scotia. The presentation estimated the cost for construction of an artificial turf field to be approximately \$710,000, with a potential allocation of \$300,000 from the Province and the remaining capital cost being provided by HRM. This estimated cost does not include the requested 8 lane track, which the presentation estimated to be an additional \$1 million, with a request for \$500,000 from HRM. Finally, the presentation also estimated the construction of arts and culture space in the range of \$1.5 million, with a request for funding from HRM in the amount of \$400,000 towards that cost. As a result, the presentation outlines a total estimated capital cost for the requested enhancements of \$3,208,250, with a total request for funding from HRM in the amount of \$1,308,250.

However, based on previous field construction projects, the construction costs for artificial turf fields tend to be significantly higher than CEEP's estimate and can be in the order of magnitude of \$2.5 - 4 million. Staff's estimate also does not include the 8 lane track or appropriate washroom and maintenance amenities. Staff have reviewed the preliminary technical requirements for a potential conversion of a field on the Eastern Passage Common and have found that there are space constraints to meet the necessary field of play size for an artificial turf field, therefore, additional site costs would be expected as well.

As a result of the anticipated project costs, the capital costs for the projects outlined are likely to be significantly higher than estimated by CEEP. Therefore, HRM could be expected to address additional funding requests. Further, the CEEP request does not outline operating costs that would be HRM's responsibility through the ongoing programming and maintenance of the field.

Provincial Funds for the New School Project

In terms of funding availability, it should be noted that at a recent School Steering Team meeting, the Province of Nova Scotia (PNS) and the Halifax Regional School Board (HRSB) advised the group that any proposed changes to the school design would be required to be funded out of the existing approved capital budget for the new school. This would include any additional enhancements for arts and cultural purposes or artificial turf fields. Further, PNS advised that there is no intent to return for additional funding from the Treasury Board for any additions to the project. Subsequently, the Province confirmed that they have not included a \$300,000 allocation within the high school budget for a contribution towards an artificial turf field.

Summary

As noted, analysis has indicated that access and distribution of artificial turf fields in HRM is sufficient at this time and that funding for arts and culture performance infrastructure has historically been provided through fundraising, area rates, grants or a combination thereof. Further, the Eastern Passage Recreation Needs Assessment did not determine that there was a significant need for those enhancements in the community and no additional information was provided in the CEEP presentation that countered those findings. Therefore, staff feel that additional funding for community enhancements to the Eastern Passage School is not required from HRM beyond the \$630,000 which was previously committed by Regional Council for the gymnasium enhancement.

Should Regional Council decide to proceed with additional community enhancements at the Eastern Passage School, based on the request outlined in the CEEP presentation, HRM has been asked to provide an additional \$1,308,250. Staff is concerned by what appears to be a low cost assumption regarding the artificial turf field and therefore the funding requested could potentially range another \$3 million higher based upon recent project experience.

It should be noted that the Community Facility Master Plan update project is currently underway and is expected to be before Regional Council in early 2016. This project will assist Council and staff in determining where new recreation infrastructure investments should be prioritized throughout the Municipality.

FINANCIAL IMPLICATIONS

There are no financial implications associated with this report. Regional Council approved \$630,000 towards a community enhancement to the Eastern Passage School in January 2013 which has been allocated in HRM's capital budget for 2017/18. Should Regional Council direct that additional enhancements be provided as part of the Eastern Passage school project, staff would need to undertake additional work to refine budget estimates that, in turn, would have to be considered and prioritized against other capital requests through HRM's capital budget process.

COMMUNITY ENGAGEMENT

During the Eastern Passage Recreation Needs Assessment a variety of feedback methods were used including an on-line survey, Facebook, twitter, dedicated phone number, dedicated e-mail and two community consultations.

Introduction

On April 17, 2012 Regional Council approved a motion directing staff to prepare a report regarding the recently announced high school in Eastern Passage including any needs for community enhancement in the area, potential partnership with the Province and possible infrastructure funding opportunities.

Purpose and Rationale of the Recreation Needs Assessment

Regional Council approved in principle the Community Facility Master Plan (CFMP) in May of 2008. The CFMP presents guiding principles, implementation models for making decisions about existing and future facilities and site-specific recommendations. This plan is built on several key themes:

- Integrated Planning to serve the needs of the citizens the work is done collaboratively with the community, Council and other HRM Business Units
- Distribution of Facilities facility planning and development that takes into account the needs of the population and its distribution within HRM
- Activity Coverage provision of a range of recreation opportunities for HRM residents and design facilities that promote participation
- Community based arts and culture ensure program opportunities are built into facilities whenever feasible
- Communities building through asset management strongly recommend models other than municipally operated recreation facilities
- Balance new assets against lifecycle obligations balance between investing in new assets and existing facilities

The CFMP discusses HRM's relationship with the Halifax Regional School Board (HRSB) and joint opportunities to deliver programs and operate facilities. Recommendation #53 expands on this by recommending HRM build upon the past successful relationship with the HRSB on the development and operation of the Citadel Community Centre attached to Citadel High School and the expanded gymnasium facilities. The CFMP recommends HRM explore further opportunities to do joint projects whenever new school facilities are being planned.

The Halifax Regional School Board (HRSB) *Imagine Our Schools* 10 year plan recommends enhancement opportunities for community-centred schools with a commitment to exploring partnerships and joint-use agreements. As a result HRM has partnered with the HRSB to develop and complete 2 joint-use projects: Bedford Hammonds Plains Community Centre and Porters Lake Community Centre.

HRM is granted permission under the Provincial Education Act to partner with the Province to enhance the Seaside Elementary school project if there is a community recreational need. Therefore, a comprehensive recreation needs assessment ensued to review the existing recreational opportunities for the Eastern Passage community, to identify gaps in service delivery and to determine if the potential HRSB partnership is a recommended course of action.

Framework and Methodology of the Recreation Needs Assessment

The focus of the Needs Assessment was to investigate how effective and efficient the provision of HRM mandated services are delivered in the Eastern Passage community. The geographical area under review is based on the HRM Regional Plan and 2011 Census Community definition: Cow Bay, Devils Island, Eastern Passage, Mynas Island, Rainbow Haven, Shearwater, and South East Passage.

The following analysis was completed to develop the contents of this Recreation Needs Assessment.

- 1. Demographic of community
 - a. Total population, percentage growth, new housing stats, employment
 - b. Development of "community profile" using several years of comparative data
- 2. Inventory of facilities
 - a. Identification of existing community / private recreation / community facilities in community, and
 - b. Services provided, services required or wanted, cost structures
- 3. Community Consultation Engagement with the Citizens

A discussion was held with community regarding what is currently working well or is challenging with recreation service delivery and what improvements would a community enhancement offer the community. The goal was to gain the appropriate community perspective, context and commentary to help craft staff recommendations.

- a. Email, phone, Facebook, twitter, on-line survey, community consultations and evaluation feedback from the consultations
- 4. Interviews with Stakeholder Groups
 - a. Sport Nova Scotia Groups: Badminton, Soccer, Basketball, Volleyball, Football, Special Olympics, Tennis

Data Research and Analysis

Recent Analysis undertaken related to community needs includes:

- a) In 2010, an Eastern Passage Recreation Survey was conducted by the HRM and encouraged public discussion regarding the usage and effectiveness of existing community indoor and outdoor facilities, as well as programs and services. This process included online survey, open public meetings, focus group meetings and key stakeholder interviews. Response to this process was moderate and there were no conclusive gaps to service delivery identified at that time.
- b) An ongoing community analysis "Eastern Passage Common District Site Inventory," began in April 2012. The intent of this study is collect information for discussion and consideration prior to the commencement of formal master planning on the Eastern Passage site.
- c) There are two major housing developments in progress: a 166-unit project that includes single condos, semi-detached condos, three-unit condos and 10 homes to be completed by 2014 and a development of 65 lots.
- d) A partnership proposal was recently submitted for consideration from a group that would like the Municipality to construct a BMX race track located somewhere on the Eastern Passage Common. This project has not yet been approved.

Community Profile

The demographics of the Eastern Passage community is evolving, however the Regional Plan review(RP+5) indicates lower growth patterns than initially projected for a variety of reasons:

- Shearwater airspace zoning height constraint on development
- noise impact constraints on residential areas

- Irving refinery explosions constraint on development
- existence of flood plain and existing capacity of the tertiary treatment plant

The 2006 Regional Municipal Planning Strategy identified Eastern Passage as a Suburban Local Centre and one of a number of HRM growth centres in which a Community Visioning exercise will be undertaken. There are 2 major developments in progress:; a 166-unit project that includes single condos, semi-detached condos, three-unit condos and 10 homes to be completed by 2014 and a separate development of 65 lots.

Based on the 2011 Census of Population, the HRM's District 3 (Woodside - Dartmouth South - Eastern Passage/Cow Bay) has a population of 27,230 which is 18.9% higher than in 2001. In 2011, 24.1% of the population was under the age of 20 and 14.6% was 65 years or older.

Based on the 2011 Census of Population, Eastern Passage has a population of 11,740 which is 13.5% higher than in 2001. In 2011, 26.4% of the population was under the age of 20 and 9.3% was 65 years or older.

In comparison, Nova Scotia has a population of 921,725 which is 1.5% higher than in 2001. 21.2% of the population was under the age of 20 and 16.6% was 65 years or older.

• Please Note:

With the Government of Canada's cancellation of the long-form portion of the Census in 2011, Census data is now very limited compared to what it was in 2006 and all of the data that was collected from the short-form of the Census in 2011 has not yet been released by Statistics Canada. Household data will be released at the community level on November 21st and posted by the end of December 2012. As for income, employment and other population characteristics, this was collected under a brand new survey Statistics Canada introduced called the 'National Household Survey'. Data from this survey will not be available until May 2013

Consequently, the 2006 Census Data will be used for a detailed community profile.

In 2006, for Eastern Passage, total census families increased 15.2% to 3,241. Married families increased by 6.5% while common law families increased 59.7% and lone-parent families increased 77.8%. Lone female parent families were 12.3% of all families while lone male parents were 4.3% of all families.

In Nova Scotia, total census families increased 5.3% to 267,415. Married families increased by -1.4% while common law families increased 43.2% and lone-parent families increased 14.1%. Lone female parent families were 13.9% of all families while lone male parents were 3.0% of all families.

Compared to Nova Scotia, Eastern Passage has a relatively low immigrant population. In 2006, there were 358 immigrants which is 3.3% of the population compared to 5% immigrants for Nova Scotia. In Eastern Passage, 99.5% of people were Canadian citizens compared to 98.3% for Nova Scotia.

The median income for individuals in Eastern Passage was \$32,835 a year, compared with the median of \$24,030 for Nova Scotia. Families in Eastern Passage had a median income of \$63,783, compared with the median of \$55,412 for Nova Scotia.

In 2006, the average income for individuals in Eastern Passage was \$35,210 a year, compared

with the average of \$31,795 for Nova Scotia. Families in Eastern Passage had an average income of \$68,976, compared with the average of \$66,032 for Nova Scotia. The employment rate for Eastern Passage residents aged 25 and over increased by 2.2 percentage points to 71.9% between 1996 and 2006 and there were 1,024 more employed workers. Nova Scotia's employment rate experienced an increase by 3.6 percentage points to 58% between 1996 and 2006 and there were 46,050 more employed workers, during this same period.

The employment rate in Eastern Passage for residents aged 15-24 years decreased by 1.4 percentage points, to 51% between 1996 and 2006 and there were 164 more employed workers. Nova Scotia's employment rate experienced an increase by 7.1 percentage points to 52.9% between 1996 and 2006 and there were 62,287 more employed workers.

In 2006, 83.6% of the population of Eastern Passage owned their dwellings and 16% rented, this compared with 72% and 27.6% for Nova Scotia respectively. In Eastern Passage, 37.2% of dwellings required either major or minor repairs in 2006, as compared to 38.2% in 1996. The average value of dwellings in the area increased 100.1% between 1996 and 2006 to \$145,933. The average major monthly payment for homeowners was \$874 in 2006 compared with \$667 in 1996. Average monthly rent in Eastern Passage decreased from \$549/month in 1996 to \$432/month in 2006.

Assessment of Indoor and Outdoor Recreation Facilities in Eastern Passage

There is a 29 ha District Park known as the Eastern Passage Common with three HRSB elementary schools, a HRM Community Centre, a community garden and picnic area, outdoor gym, skate park, playground, tennis court in the summer converted to an outdoor rink in the winter and various sports fields located within its boundary.




Figure 1: Eastern Passage Common

Indoor Facilities

The majority of gymnasia in HRM are owned by the Province of Nova Scotia or Private Partners and operated on their behalf by the Halifax Regional School Board. Six have been co-funded by the municipality as community enhancements and have "assured access" through Joint Use Agreements. The School Board is responsible to create the policies and usage guidelines for their facilities and HRM scheduling staff, through a formal Service Exchange Agreement with HRSB, provide scheduling services to community users. The priority for access to these gymnasia is given to school usage. This utilization pattern is different in the co-funded Joint Use Agreement facilities, where a higher percentage of gym usage is available to community groups and programming.

There are several factors that influence gym usage in the municipality. There are various rental costs and policies for staffing in place, depending on whether the school is a provincially owned school, a P3 school or a municipally enhanced community school. Some gymnasiums have available prime time that is not utilized because of the pricing structure at the school. Citizens involved with minor sport and non-profit organizations in particular note that the cost of the gymnasium is as important a consideration as the actual location or availability of the space.

The HRM Tallahassee Community Recreation Facility is attached to the Tallahassee Community School. In addition, the Department of Education has approved the renovation of the Seaside Elementary school, which is also located in the area known as the Eastern Passage Common, as

the site for the new high school.

The size dimensions of the gymnasiums available to rent at Seaside Elementary and Oceanview Elementary work well for children and some youth activities, but are challenging, and are the wrong field of play requirements for adult usage, and for high school or provincial competition. The Tallahassee gymnasium is adequate in size for all uses but is booked to capacity with a waiting list for usage.

The waiting list consists of:

- 100 youth participants in Metro Volleyball
- 100 youth/child participants in Dartmouth Storm indoor soccer
- 50 youth/child participants in Indoor Eastern Passage Baseball
- 30 adult/youth participants in Badminton
- 30 child/youth participants in Eastern Passage Basketball.

HRM staff is responsible to book both the gymnasiums and fields of schools under the HRSB and only the field under the P3 system. The individual schools provide the HRM staff with their time requirements and the remaining time is filled by community/sport groups through the application process. The current practice is to give preference to groups who had access in previous years; this does create an accessibility challenge to those groups who have not historically had access as often times the gyms will be booked to capacity using this "grandfathering" system. The following displays the total hours of gym usage:

The Tallahassee Community Centre plays a key role in the provision of recreation services for the community. Due to its age and extensive use, recapitalization and refurbishment is needed in order to ensure the asset does not depreciate in value and use.

Other Facilities Available to Eastern Passage Community Members

Shearwater Fitness and Sport Facility

This facility is geographically convenient for the community members of Eastern Passage;, however, many parameters are set by the Canadian Forces that make it challenging for non-military members to utilize. Membership is a "Four Tier" system with preference to members of the military and DND employees. The general public is classified as Tier IV and must have a member of the military sponsor them for a membership or sign for drop in privileges. The public can attend fitness classes as long as there are more than 50% military personnel in the group. The facility does rent the gymnasium to local groups as long as it does not interfere with their primary client.

- 26 hours per week for gymnasium floor
- 20 hours per week for arena
- 6 hours per week for pool

Cole Harbour Place

Both Cole Harbour Place and Dartmouth Sportsplex are within the CFMP 20-minute drive-time standard for service provision for the Eastern Passage community. In particular, Cole Harbour Place offers programming and services for the Eastern Passage community. However, although this facility is close in distance, there are transportation challenges in accessing it. There is no dedicated Metro Transit bus to travel directly from Eastern Passage to Cole Harbour nor a direct driving connection, thus making the commute to this facility a more lengthy travel in both time and mileage. Therefore, due to transit schedules and road layout, access is not convenient and therefore, there is a perceived lack of local service delivery.

Outdoor Recreation Facilities

Current outdoor facility inventory in Eastern Passage consists of 4 natural turf sport fields, 4 natural turf ball diamonds, 6 outdoor basketball courts, 1 tennis court (converted to an outdoor rink in winter), 10 playgrounds and 1 skateboard park.

HRM staff is responsible to book all the outdoor facilities including the Eastern Passage Education Centre (P3 school). The following is a breakdown of 2011/12 usage and the respective Service Standard level for each field:

The current supply of ball diamonds per population in Eastern Passage is higher than the recommended standard in the CFMP by approximately 16%. This is consistent, however, with the oversupply of ball diamonds throughout the municipality which is currently 66% higher than the service standard recommended in the CFMP.

Based on this data, there is no evidence at this time that the Eastern Passage community would benefit from additional or upgraded natural turf sport or ball diamond facilities

Consultations with Stakeholder Groups

Community groups, Sport Nova Scotia groups, District 3 former and current Councillor and HRM

Eastern Passage Recreation professionals were consulted to identify gaps and opportunities in the provision of HRM mandated recreational services.

The various sport and community groups expressed a level of frustration about the lack of equitably access for field and gym times. The "grandfathering" methodology of bookings teams who have had past access inhibits the available play time and growth of sport groups whom have not had access in the past (Badminton, Tennis, Gymnastics, Ball Hockey, Lacrosse, Special Olympics, Boys and Girls Club, Football). For example, Football Nova Scotia has moved their indoor play area to East Hants due to lack of access in HRM. It was also noted on several occasions that the gymnasium space was not used in the most effective manner due to rentals to non-sport groups. Also, it was noted that some sport groups dominate the usage of better quality and/or lit fields as well as access the prime times for their membership's age groups.

The basketball community has no alternative but to use the Elementary school gymnasiums, however, the hoops are fixed at 10 feet which is too high for their mini groups and the floor space is too small for play standards for older participants. There are agreements in place between the Basketball Nova Scotia and HRSB but often times the gym access is denied due to school activities, Professional Development days and school holidays.

The Non-profit groups such as the Provincial Special Olympics fall under the HRM non-profit cost structure that would not charge for usage but they cannot access the gymnasiums due to the full usage by other groups. These groups require larger gym spaces as there are participant safety concerns when using the smaller elementary gyms.

A recent Capital Health community health plan, Our Healthy Future...Realizing Our Promise: A Community Health Plan for 2010-2013 identified issues such as physical activity, healthy weights and access to facilities. The focus was placed on all age groups from youth to seniors and the lack of available opportunities within HRM. Citizen feedback indicates physical inactivity, poor nutrition and obesity are their key health concerns. Citizens want help to remove roadblocks like lack of money, opportunity, information, encouragement, time or motivation. Although the roadblocks are different for each person, everyone is telling them they want the healthy choice to be the easy choice. Community Consultations

Citizens in Eastern Passage were provided with a variety of feedback methods including:

- on-line survey
- Facebook
- Twitter
- HRM dedicated phone number
- HRM dedicated e-mail
- Two structured public meetings

The public meetings were held at the Eastern Passage New Eco Tourism Service Centre on October 11th and 17th and asked for feedback regarding programming and services that are currently working well in terms of community use of indoor and outdoor recreation space and ideas regarding what improvements are necessary or desirable.

Commentary from citizens at both public sessions and other forums indicated the community members have a desire for additional gym space. There were few comments about the outdoor recreation facilities. Most participants rated the sport field conditions as fairly good but the seasons were short due to the weather conditions in the community. The ball field access and condition was rated as fair but did note the Triple A teams could not use due to dimensions. A few citizens did express the desire for either an upgrade to an artificial turf or at minimum increase the size and condition of an existing field to increase the available usage hours.

The on-line survey results indicated that 97% of respondents consider recreation programs an enhancement to their quality of life. There were 82% of households who participated in a recreation program or sport group using a gymnasium within the past year. Almost 50% of respondents indicated a very high/high level of satisfaction with the availability of gymnasiums space in the Tallahassee Community School whereas the HRSB's school gymnasiums rated low or very low.

This current needs assessment produced commentary from citizens to support the need for additional gymnasium space. Specific needs assessment and analysis related to indoor arenas has recently been completed and approved in principal by Regional Council (August 2012). This recreation needs assessment confirmed that an additional ice surface is not required in Eastern Passage, as per the standards of service provision outlined in the Long Term Arena Strategy, at this time.

Relevant Findings not in Scope

During both the Stakeholder and Community Consultations there were several points consistently mentioned which should be addressed by other HRM Business Units or HRSB. The following items will be sent to the respective staff to action as appropriate:

- 1. Consideration of a Library located in the Eastern Passage area either as a stand-alone facility or partner with the HRSB during the Seaside School renovations.
- 2. Request that the HRSB consider an auditorium as part of the cafeteria in the high school for the community to celebrate heritage, arts, culture and theatre.
- 3. Consideration of a direct metro transit route to the Cole Harbour Community
- 4. Consideration of the extension of the roadway network to connect the HRM communities.

Findings

- 1. The Community of Eastern Passage/Cow Bay is very engaged in "community pride" initiatives.
- 2. The factors of the time of day, programming, size of play surface, accessibility, travel distance and cost all ranked very high or high in the usage of both the gymnasiums and playing fields.
- 3. Presently the school recreation facilities which are administered by a Service Exchange Agreement with HRSB are not effectively accessible to the community/sporty groups. If HRM enters into a monetary partnership to enhance the Seaside School gymnasium, a Joint Use Agreement would be developed that clearly defines community usage based on HRM recreational need. Feedback was also provided that indicated that increased community usage is desired in schools without Joint Use Agreements. Staff will continue to work on improvements in the Service Exchange Agreement in order to increase community access to all schools.
- 4. The usage, lack of access and community/stakeholder feedback data supports the partnership with HRSB to enhance the gymnasium. Therefore, the development of community gymnasium space is recommended. An enhancement of the redevelopment of the Seaside School is seen to be the most cost effective and appropriate mechanism to construct additional space of this type at this time. This would provide a full-sized gymnasium (suitable for curtained separation) for both school and community use, would ensure appropriate community access through the administration of a Joint Use Agreement for that site with the Halifax Regional School Board and will allow the municipality to construct the enhancement at a reduced capital and operating cost.
- 5. The rating of the sports fields ("B" rating") indicates that the community is well serviced and does not require an upgrade to an artificial field or an increase to the size and condition of an existing field.
- 6. The community has access to many diverse recreational opportunities as compared to the majority of communities within HRM, tennis courts, outdoor rink, Skate Park, outdoor gym, walking path at Fisherman's Cove and community garden.
- 7. Access to existing Regional Recreation Facilities is not convenient due to lack of direct transportation routes and transit service. This will be forwarded to Metro Transit for consideration in future planning.
- 8. The Tallahassee Community Centre plays a key role in the provision of recreation services for the community. Due to its age and extensive use, recapitalization and refurbishment is needed in order to ensure the asset does not depreciate in value and use.
- 9. There is no is no identified need for the development of a BMX Race Track in Eastern Passage at this time.

I'm not sure why it's not recognized that Eastern Passage has approx. 12,000 residents and we deserve facilities just as much as other communities with similar numbers. There are rural communities with a mere 1,000 people throughout NS with hockey rinks. There are hundreds of children in Eastern Passage who play hockey and hundreds more who would play if they weren't forced to drive across Dartmouth to play. I'm also sure that the community would be willing to contribute to the cost as well. It is because of our lack of facilities and opportunities for children, the main one being hockey, that people are choosing to move elsewhere to Cole Harbour, Bedford, Sackville etc. I am just curious if this has ever been discussed and if it is even remotely possible. I am an officer in the Canadian Forces and would be more than willing to head this operation if you think it would at all attainable.
- 12. A playing field and gym should be an integral part of a school. The cost should be borne by the province as they are building the new school. What we really need is a library and other city services that are not available without a 20+ minute drive.

- 37. We need the new school and a swimming place
- 38. Being a new mom and new to the area a program that I could take my baby that was close to home would be great. It isn't always easy to get out the door and go somewhere, especially if there is a commute involved. It would be great to meet other moms in the area and have some "friends" close by. It would also be great when my daughter gets older it will be even greater to have things close by to go with her friends while I don't have to worry as I know where she is, I know she is safe and its close to home. I hope you take this into great consideration when deciding what to do as I am sure I am not the only parent that feels this way!
- 39. There is a lack of accessible and appropriate activities for youngsters and adults with special needs in our area. Families have to travel outside of the community to access appropriate programs and facilities. Seniors have moved out of the area due to the lack of programming and facilities in our area. We have a large number of children with disabilities who play sledge hockey, floor hockey and take part in therapeutic swimming and this has been very costly to families plus further isolates them from their community which should be supporting them.
 - For most families they cannot afford the time or cost of travel to these programs. We have a huge number of families that do not take part in winter sports such as skating due to lack of facilities Shearwater has open skate on Sunday afternoons only which limits most families and if there is a tournament this option is not available. The lack of public transit in Cow Bay affects residents as they are unable to travel to most areas.
- 40. It would be amazing to have a facility that includes a pool and fitness facilities. Our family loves to go swimming and would definitely benefit from a fitness facility that were closer to home.
- 41. We need a facility we can use for swimming, hockey, Fitness center, community events. Something in the order of Cole Harbour Place, not as big but something similar.
- 42. I did not see an inquiry about a swimming pool? This is something that could really benefit the Eastern Passage community.
- 43. We pay the same taxes as other communities in HRM (Sackville, Spryfield, etc.) however we do not have the same facilities, our bus service is bad, we have no skating rink, community pool, library and the programs offered at our rec facility are very limited. We should have access to the same services or we should be paying significantly lower taxes.




