ANNUAL REPORT

ORIGIN/LEGISLATIVE AUTHORITY

Section 27(1) of the HRM Charter states:

A community council shall hold an annual public meeting in the community in each year to report to the public concerning its activities and to receive the views of the public respecting all matters within its mandate.

BACKGROUND

Harbour East-Marine Drive Community Council was established on December 3, 2012 by Administrative Order 48 Respecting the Creation of Community Councils.

Daylighting Sawmill River in Dartmouth – *Ecology Action Centre & Sackville Rivers Association*Presentation provided. Motion approved to waive the rules of order to request a report.

Motion approved that Harbour East-Marine Drive Community Council request a staff report on the presentation, with commentary from Halifax Water, using full-cost accounting.

Shearwater Flyer Trail - Cole Harbour Parks and Trails Association

Presentation provided. Motion approved to waive the rules of order to request a report. Motion approved that Harbour East-Marine Drive Community Council request a staff report with regard to the request from the Cole Harbour Parks and Trails Association for HRM to take over the entire Shearwater Flyer Trail from Bissett Road to 12 Wing Shearwater and also the short section across DND property to Corsair Drive, including a cost analysis to HRM with ongoing maintenance costs.

PUBLIC PARTICIPATION

December 12, 2013

- Speaker commented on the importance of the Regional Plan review, noting the need to attract families to Downtown Dartmouth, including Wyse and Windmill Roads, and encouraged Community Council to become more active in pushing development in the urban core to attract more families to the area.
- Speaker requested that Council consider in the future requesting amendments to the Municipal Government Act to mandate holding public consultation meetings on any studies done by consultants, in order for the public to be able to ask questions of the consultants undertaking these studies.
- Speaker discussed a submission on lake carrying capacity, noting that it is important to know
 what phosphorus levels are before any development begins. He reviewed work done by the Soil
 & Water Conservation Society of Metro Halifax with regard to phosphorus readings on 600 lakes
 in HRM, which HRM staff has.

• Speaker discussed the revitalization of the Dartmouth Sportsplex, and reminded Community Council about the importance of the project.

February 13, 2014

 Speaker updated Community Council on plans for the 2014 EPIC Dartmouth event on June 28 & 29, 2014.

April 3, 2014

- Speaker commented on the Porters Lake Watershed Servicing Study, making comparisons between the results of the Porters Lake and Lake Echo Watershed Servicing Study surveys.
- Speaker made several inquires with regard to the extension of central water and sewer services
 to Porters Lake and how the costs of the extension of these services would be covered.
- Speaker inquired about monitoring of septic systems on properties adjacent to Porters Lake, and encouraged regular updating of the study for data tracking purposes.

June 12, 2014

- Speaker circulated a submission to Community Council with information from his archives on lake water quality.
- Speaker discussed the difference between community visioning and secondary planning, and
 encouraged moving forward with the community vision created through the Musquodoboit
 Harbour Visioning process. She brought to the attention of Community Council plans by an area
 MLA to move the retirement home, the high school and the rink/community centre from
 Musquodoboit Harbour to Chezzetcook, noting that this is of great concern to the community.

August 7, 2014

 Speaker commented on the lack of community signs on Highway #7, Highway #118, Windmill road, and Pleasant Street.

September 11, 2014

 Speaker discussed the Dartmouth Curling Club's interest in acquiring the Bowles Arena when it becomes surplus property.

October 2, 2014

• Speaker commented on the lack of visible minorities on police commissions.

November 13, 2014

- Speaker commented on the need for protection of the Porters Lake Canal, which was recently put up for sale by the Federal government.
- Speaker noted concerns with the daylighting of Sawmill River, which he would like to discuss with the staff person assigned with the writing of the report requested by Community Council.
