

INFORMATION REPORT

ORIGIN

Item 12.3 raised at the March 5, 2008 meeting of the Harbour East Community Council.

It was MOVED by Councillor Smith, seconded by Councillor Karsten, that Community Council request a stop sign on South Ridge Circle where the intersection of Argus and Fury creates a blind spot when drivers make a left hand turn onto Fury.

BACKGROUND

Councillor Smith advised that the staff report dated February 5, 2009 from Traffic Services on the need for a stop sign at the intersection of South Ridge Circle and Argus Drive, District 9 did not address the concern. He stated there was no request for an all way stop and the stop sign on Fury Drive has no impact on his request. He noted the problem is with drivers coming down Argus wanting to make a left turn onto Fury as there is a blind spot.

DISCUSSION

Restating the intersection characteristics as per the original report, the intersection of Argus/South Ridge/Fury is a low volume T-intersection located in the Lancaster Ridge subdivision. Recent manual traffic counts indicate the total approach volumes for a.m. and p.m. peak periods at 57 and 60 vehicles per hour, respectively. There is an existing stop control on Fury Drive which is typical traffic control for a major/minor street intersection.

The traffic volume on Fury/South Ridge is less than 3,000 vehicles per day. A single collision was reported in the past five years which would not have been prevented by a change in the present traffic control.

Staff met with Councillor Smith on-site to further discuss the issue. It was determined that sight distance was good at the intersection on all approaches and no change to the present stop control was required. Follow-up traffic counts are scheduled and staff will monitor ongoing development for this area.

There are no budget implications.
