SUBJECT: Halifax & West Community Council – 2016 Annual Report

ORIGIN / LEGISLATIVE AUTHORITY

Section 27(1) of the HRM Charter states:

A community council shall hold an annual public meeting in the community in each year to report to the public concerning its activities and to receive the views of the public respecting all matters within its mandate. The powers and duties of Community Councils are outlined in section 25 of the Halifax Charter.

Halifax and West Community Council requested that the Legislative Assistant maintain a record of the Community Council's business for the first annual meeting held in 2013 and annually held thereafter.

BACKGROUND

Halifax and West Community Council was established on December 3, 2012 by Administrative Order 48, Respecting the Creation of Community Councils.

DISCUSSION

Members of the public provided input during Public Participation on the following issues:

- Concern for the infrastructure of road networks approaching Maskwa from Hamshaw Drive and Saskatoon Avenue.
- Concerns were expressed about the service standard for Fire Services adopted by Regional Council in February 2006, the removal of staff from the Lady Hammond Road station, and potential volunteer staffing issues and response times.
- The Larry Uteck and Kearney Lake Road intersection; it was suggested that the intersection be evaluated by staff.
- The removal of leaves from stormwater drains
