#### 10.1.1 Uniform Charge for Birch Bear Run Homeowners Association

Implementation of the area rate would be conditional on the Birch Bear Run Homeowners Association securing one-third funding from HRM and one-third funding from the Nova Scotia Department of Health Promotion and Protection.
