EIGHTH MUNICIPAL COUNCIL

OF THE

COUNTY OF HALIFAX.

FIRST DAY.

HALIFAX, Jan. 10th, 1893.

In accordance with the Statute, and by advertisements and special notices issued by the County Clerk, the Councillors for the several Polling Districts of Halifax County elected Nov. 15th, 1892, attended at the County Court House, at 12 o'clock, noon, on Tuesday, the 10th day of January, 1893.

The Clerk read from the Revised Statutes, chap. 56, sections 3, 4, 5, 6, 30, the course of procedure for the Annual Meeting, took the Chair, and having called the Meeting too order, declared the undermentioned persons duly elected, Councillors for their respective Districts, as notified to him by the Presiding Officers, and verified by the Poll Books.) In three Districts Petitions were fyled against the Councillors returned, but there was no authority for Municipal Clerks to refuse or reject the parties, as all controverted elections are to be settled by the County Court. The term of the present Council would be three years:

. The Clerk administered the Oaths of Allegiance, and that of Municipal Councillors who signed the roll, except Chas. E. Smith, not arrived, and C. W. Christian, who stated by letter that illness prevented his attendance.

Nominations were asked for by the Clerk for the position of Warden and Deputy Warden—all County Officers to be elected by ballot if more than one name was submitted.

On motion of Councillors Madill and Bissett, Councillor John E. Shatford was elected by acclamation Warden of the County, and took the chair.

On motion of Councillors Bartlett and Taylor, Councillor Geo. H. Madill was unanimously elected as Deputy Warden.

The Warden and Deputy Warden were sworn into office. On motion of Councillors Bissett and Bartlett, W. H. Wiswell was elected County Clerk and Treasurer at the same salary as heretofore.

The Clerk thanked the Council for the appointment, and referred to the change made in the tenure of the Offices of Clerk and Treasurer by Statute (Chap. 39, 1892). They are to hold office hereafter "during good conduct" instead of yearly as heretofore. He said the work had increased so greatly it might be necessary to separate the two offices unless some assistance was provided.

The reading of Minutes of last day of April Session, 1889, was waived as the Councillors had them in the printed form.

Appointments of other County Officers were deferred till later on in this Session.

The Clerk read the proclamation summoning the Provincial Legislature to meet Thursday, Jan. 19th, for special business.

The Warden said he would have his address ready for the afternoon Session.

On motion, Councillors Madill, Henley, Sellars, Fraser, Taylor, Fagan and Donaldson were appointed a Committee to nominate the Standing Committees for the year 1893.

The Council then adjourned to meet at 2.30 p.m.

Afternoon Session.

January 10th.

The Council met at 2.30 p. m. Present the Warden and 29 Councillors. Councillor C. E. Smith arrived and was sworn into office.

The Warden asked attention to the By-Laws relating to the proceedings of the Council, of which each Member had s copy. He then delivered the following address:

THE WARDEN'S ADDRESS.

Gentlemen of the Municipal Council:

We are now entering upon the fourteenth year of Municipal Government in this Province, and I think we have no reason to find fault with the system. As a result of the elections held in November last under the law, you are herefresh from the people charged by them with the important duties devolving upon you as their representatives in the County Council. The new Council, I 'may remark, consists of fourteen that were in the last Council, six that were in the Councils previous to the last, and eleven new men that are here for the first time, thereby making a greater number of new Councillors than were clected to any previous Council. I feel sure you have all come hither with a determination to do the very best you can to advance the interest and welfare of your Constituents and the County generally. You are here under much more favorable auspices than any of your predecessors ever were. For years they, had to contend against disputes and financial difficulties with the City Council of Halifax, as well as with the Provincial Government; lawsuits to carry on and legal bills to foot with almost an empty treasury. At one time it looked as if we would have to abandon the whole business and let matters drift as best they might. But a better day has dawned. Some old Councillors who are now here and some members of former Councils, now absent, together with myself, stood by the wreck until we brought it safely into port.

The County of Halifax is now in a better financial position than it has ever been since the inauguration of the Municipal Council. As proof of this I have only to refer you to the opening addresses of the different Wardens and to the reports of the various finance committees from 1880 to 1891. Tam pleased to inform you that we effected a settlement with the City of Halifax last April, up to May, 1891, though on terms not as favorable as we might have expected. We made concessions that under any other circumstances we should not have made, but we did it with a desire to come to some fair and mutual adjustment of a long standing dispute. Only last month we effected a settlement with the Provincial Government up to September 30th, 1892, barring some old claims prior to 1878, which we have no reason to anticipate will ever become a liability of this Council. All our lawsuits have been settled and we have to our credit a sufficient sum to meet all our present liabilities. so the Treasurer informs me. This, you will see, is a very striking contrast to the old blue ruin times when every succeeding Council was deploring its financial difficulties and could not see its way clear to meet all the liabilities of the county. We, therefore, enter upon this fourteenth year of our Municipal system with almost a clean sheet and plain sailing,

One condition of our settlement with the Government was the privilege extended to us of holding an investigation before the Commissioner of Works and Mines respecting some insane paupers, whose "settlement" was doubtful, with a view to having them placed under those who had a legal right to assume their maintenance. As I am of the opinion that the expense of such an investigation would be greater than what we might gain by it, Mr. Wiswell and I have decided to submit the question to this Council to say whether it will be in the interest of the County to hold such investigation or not.

The report of the license inspector, so far as applications for licenses are concerned, must be dealt with to-day as the law directs.

The report of the Board of Assessment Revisors will be laid before you in due time, and I regret to say that it is not a very encouraging one. By their report and the valuations made by the Local Assessors, there is a depreciation in the valuation of the County as compared with former years of \$51,134, not including two districts whose rolls were not in at the time of the Revisors' report. I am really at a loss to understand why this is, and I hope you will give this matter your earnest attention before we adjourn. One member of, the Board, although signing the report, has dissented from it, and in a letter attached to the same has not only expressed his dissent but tenders his resignation and asks not to be appointed again.

I cannot give you a detailed statement of the business to come before you. If I attempted to do so it could not be strictly followed. The Treasurer's accounts, which will be laid before you in due time, will give you a better opportunity to inform yourselves of the financial affairs of the County in detail than any statement I might here make. In order to expedite the business of the session, you will, as soon as possible, appoint the various Committees, and they will mature their reports as early as is consistent with the business coming up for their consideration. At this, four Annual Meeting, you are to appoint your District Officers, and let me urge you now, as I have on former occasions : In selecting men to fill such offices, see that they are permanent residents of the respective Districts for which they are appointed, and not transient persons who may any day leave the County and necessitate the appointment of others at our April meeting.

In conclusion, let me request that in dealing with all business coming before you for your consideration you will be guided by justice and economy, always keeping in view the best interests and welfare of the taxpayers of the County of Halifax

REPORT OF INSPECTOR OF LICENSES.

GENTLEMEN,---

I beg to state for the information of the County Council that the following applications have been received according to the requirements of the Liquor License Act of 1886, and amendments thereto.

H. N. Paw, District 15, hotel, St. Elmo, Rockingham.

Wm. Wilson, District 15, hotel, Bellevue, Bedford.

W. E. Poppleton, District 13, hotel, Hawthorne House, St. Margaret's Bay Road.

C. H. Gough, District 14, hotel, 3-Mile House, Bedford Road.

Nora Hurley, Prospect, District 10, shop.

Benjamin Gordon, Porter's Lake Road, District 30, shop, 144-Mile House. Upon examining the petitions and certificates I find that W. F. Poppleton and Mrs. Nora Hurley have complied with the provisions of the Act and there have been no objections made to their applications, therefore I would recommend that their licenses be granted.

The certificates of H. N. Paw, Wm. Wilson, Benjamin Gordon and C. A. Gough have not the required number of signatures. The granting of a License to C. A. Gough has been objected to by the rector and curate of St. Mark's Church; by Maple Grove Lodge, I. O. G. T.; also by the residents in the immediate vicinity of the place sought to be Licensed, and by the ratepayers in the neighborhood, all of which accompany this Report. The following are some of the objections made:

(1) That it would be detrimental to the true interests of the community (2) that the proprietor of the house has resently been fined for Sunday selling; (3) that it is a resort for boys; (4) that it causes Sunday traffic; (5) that it is in close proximity to St. John's Church; (6) that it is not necessary in the place.

Since the time expired for receiving applications, Wm. Keddy, of Preston Rosd, and Gilbert Walker, of St. Margaret's Bay Road, have made application for License, but I could not entertain them.

On motion of Councillors Bartlett and Umlah:

Resolved. That license be granted to Mrs. Nors Hurley, of Upper Prospect, and W. E. Poppleton, of St. Margaret's Bay Road, they having complied with the requirements of the Law. Passed.

Discussion ensued in which the Inspector took part relative to refusal of licenses to Paw, Wilson and Morrison in District 15.

Mr. J. G. Corbin, by permission, addressed the Council. He claimed that 9 persons on the Electoral List were called non-residents, and as Wilson had 6 out of the 9 he would have on his application 3 too many, therefore, as the voters' list was wrong he should be granted his license. Councillor Donaldson advocated the same course.

on motion, the matter was referred to a Committee composed of Councillors Fraser, Hubley, Thomson and Wilson. The Council adjourned to 10 a.m., Wednesday.

SECOND DAY.

MORNING SESSION, Jany. 11th, 1893.

The Council met at 10.30 a.m. Present the Warden and 29 Councillors. Yesterday's afternoon Minutes were adopted.

Read petitions of the Clergy, the Good Templar Lodge, and a number of people of District No. 14, against granting a license to sell liquors at 3 Mile House, applied for by C. A. Gough.

Reference was made to application of Benj. Gordon, of District No. 30, for license, which was defective in not having sufficient names in the certificate.

On motion of Councillors Taylor and Madill:

Resolved. That license be not granted to Benjamin Gordon and C. A. Gough, they having failed to comply with the law. Passed.

The Committee on nomination of the Standing Committees reported as follows:

On motion the Report was adopted.

Read, a memorial from Albert Stewart, enclosing several Bills of Costs, etc., claiming that the Treasurer had paid the amount of \$170 assessed in District 18 to F. Congdon, which should have been paid to him.

Read, also, a lengthy Petition from the ratepayers of District 18, bearing upon the case of Wallace vs. Stuart. It states that the District was assessed in 1892 in the sum of \$175, which was to reimburse Albert Stuart, but that the same had been paid to Mr. Congdon for legal expenses, Mr. Stuart not receiving a cent of it. The petitioners express

much dissatisfaction at such proceedings, and state they did not assess themselves to pay lawyers' fees, but to reimburse Mr. Stuart only. They want the money paid over to him.

The Warden and Clerk said that Mr. Congdon being Mr. Stuart's legal adviser the payment was (as is the established rule) made to him. Ordered to lie on the table.

Read, the Report of T. A. Chambers, keeper of County Jail, 1892.

REPORT OF THE KEEPER OF THE COUNTY JAIL, 1892.

To His Honor the Warden and the County Council.

GENTLEMEN,—I beg herewith to submit my Report of Commitments to the County Jail during the year ended December 31st, 1892.

• For the year beginning January 1st and ending this date, there were: criminals 240, debtors 40, showing an increase of 22 criminals and a decrease of 18 debtors, as compared with 1891.

At the present time there are 10 criminals and 1 debtor in the Jail.

The largest number of prisoners in the Jail at one time during the year was 26.

Annexed are statements showing the various crimes for which prisoners were committed during the year. There were quite a number of prisoners committed in 1891 who were not discharged until 1892.

During the year there were 280 persons committed to Jail, of which there were from

The amount of monies received for boarding merchant sailors and deserters from Her Majesty's Service is \$17.60. No room rent was received on account of the new "Debtors' Act," abolishing imprisonment for debt, and there were very few deserters, either merchant sailors or from Her Majesty's Service.

The sanitary condition of the Jail has been generally good, with little sickness excepting of those committed temporarily from the City Court, of which there were for drunkenness 23, and insanity 6, during the year.

The conduct of the prisoners during the year was generally good.

Hon. Provincial Secretary was present at this Session, seated beside the Warden.

Submitted a claim from Chas. McGunnigle, District 22, for extra service in assessing there. After explanations by Councillor Burris the bill (\$4.00) was ordered to be paid.

Read, a letter from John Deéhman, 2nd, District 22, to be relieved of taxes as a non-resident, etc.

After remarks by Councillors Burris and Taylor it was referred to the Committee on Assessments.

Read, a Petition from Thomas Eldershaw, Clam Harbor, District 27, complaining of being prevented using a footpath through property of John Homans, Sr., and asking for a right-of-way to the main road. Referred to Road and Bridge Committee.

Read, Petition from persons in District 38 for leave to extend the Road Section from Burns' Point to Swaw Point on which to do their Statute Labor.

Read, Petition from Little River, District 35, complaining of obstructions kept up on a section of road between the Guysboro and Meaghers Grant roads, rendering it unsafe and inconvenient. Councillor McMullen gave further information as to the cause of the trouble. 'On motion referred to Road and Bridge Committee.

Read, the Petition of residents of District 33, near the Southeast Passage, asking for a right-of-way between the Soward Road and the new Cole Harbor Road.

On motion of Councillors Conrod and Wilson-

Resolved, That a precept be granted for the road required, and that the Committee to lay out the same be B. J. Newcomb, Joseph Osborne and George Bowes, Jr. Passed.

Submitted and read the following

REPORT OF REVISORS OF ASSESSMENTS.

As the law directs we examined the several assessment rolls from the various districts. and are of the opinion the local assessors have made a fair assessment, although many of the districts show a decrease in valuation, which we think if due to the dullness of times and depression in trade. We, therefore, decided not to add any percentage on such districts The annexed schedule of valuation will show the standing of the various districts for the ensuing year, with the exceptions of Nos. 9, 11 and 14, which are not to hand.

The Councillors of the several Districts up to No 16 commented on the changes of valuations since the last assessment.

The Council adjourned at 2.30 p.m.

(Councillor Bissett requested all Councillors wishing to visit the Poor Farm to report to him by 2 o'clock.)

Afternoon Session.

WEDNESDAY, Jan. 11th, 1893.

The Council met at 2.30, the Warden and 29 Councillors present.

The Minutes of Morning Session were read and approved. The Report of Assessment Revisors was resumed at District No. 17, and valuations discussed, decreases explained, &c., to the end.

Councillor Taylor and others, pointed out inaccuracies

in the figures, and the Clerk said that summations in these reports since 1888 were largely incorrect, but in making up the Collectors' Rolls he took care to rectify all errors. Councillor Donaldson said District 15 was \$7,000 more.

On motion the Report was received and passed.

Read letter from E. B. Hubley (one of the Board) dissenting from the work of his colleagues of this year as retrograde instead of progressive, whereby a very large reduction is made in the aggregate assessment of the County, showing the uselessness of the Board, for which reason he tenders his resignation.

The resignation was accepted by the Council.

The Clerk read Section 2 of Chapter 43, Acts of 1892, by which the Municipal Council are not required to appoint the Board of Assessment Revisors except every third year. Moved by Councillor Burris, seconded by Councillor

Bartlett-

That the duties of Revisors of Assessments be suspended for the incoming two years and none be appointed for the said period. Passed.

Moved by Councillors Hubley and Bartlett, and

Resolved, That in future the local Assessors when forwarding the Assessment Rolls to the Clerk of the Municipality, shall show or explain the reason why decreases or increases have occurred in their respective Districts. Passed.

Read letter from W. Y. Gray, District 15, complaining of over-valuation of his property and unequal assessments by the Assessors of the District.

Councillor Donaldson contended that Mr. Gray had no ground whatever for complaint. He had paid \$2400 for part only of the property, and built two two-story houses on it.

On motion, referred to Committee on Assessments.

Moved by Councillors Wilson and Bartlett-

That a Committee of Messrs. Wilson, Donaldson, Bartlett and Bissett be appointed to confer with Inspector Read in regard to the qualifications of the ratepayers in license applications in District 15 and report to this Council Thursday. Passed.

Read a Petition from Saml. McKay, J. P., and a number of Ratepayers of District 30, for an Investigating Committee to inquire into charges against Councillor Joseph Thomas, of Preston, for misappropriation of funds of the Municipality:: It was alleged that while a sum of \$73 was stated to have been spent on the Preston Old Road, only \$20 worth of work was done. Other irregularities were charged, such

as forged returns and fraud in payments for work, &c. Moved by Councillors Bissett and Taylor—

Resolved, That the petition from District No. 30 with regard to the laying out of the Government Road Grant be referred to a Committee consisting of Councillors Madill, Wilson, Sellars, Donaldson and Hays, to report on at this or the next meeting of Council. Passed.

Moved by Councillors Donaldson and Thomson, and

Resolved, That Jas. L. Griffin, Dominick Farrell and Norman Hays be appointed the Committee of Justices of the Peace to admit insane patients to the Lunatic Asylum. Passed.

By Councillors Taylor and Madill-

That Jno. D. Tupper and Walter McCurdy, of Middle Musquodoboit, be added to the list of Justices for admission of insane patients to Mount Hope Hospital. Passed.

By Councillors Fraser and Kirker-

Resolved, That J. F. McKenzie, J. P., and Malcom McFarlane, J. P., be Justices to sign papers for admission of patients to the Hospital for Insane for the year 1893.

Moved by Councillors Bartlett and Grono-

That the expenses of providing teams wherewith to enable those Councillors . who wish to inspect the Poor Farm, be a county charge. Passed

The Clerk reported that in examining the Dominion Census Returns he found that the County population had been reduced by increasing that of Dartmouth. As this would lessen the School Grant he had written the Commissioner at Ottawa for correction.

Read, Reply from Geo. Johnston, Esq., Census Commissioner, explaining and rectifying the error. The population of the County is 28,299, making the amount required for County Schools for the next ten years at 30 cents per head, say \$8,500.00.

Read the Report of the Superintendent of the

HALIFAX COUNTY-POORS' FARM.

To the Warden and Councillors of the Municipality of Halifax County now in Session.

GENTLEMEN, --- I beg to submit herewith for your information the fifth Annual Report of the Poor Farm for the year ending 31st Dec., 1892.

The past year has been a good success in respect to crops and farm labor. The hay crop has been in advance of the previous year. The potato crop has been exceedingly good, both in the quantity and quality. Turnips, cabbage, peas and beans give no just reason for complaint. The Farm has been very much improved by breaking one acre and three-fourths of very stony ground, also digging thirty rols of drain four feet deep, three wide at the top and two feet in the bottom. The work of clearing the ground of stone has been very much impeded for want of sufficient teams, although the greater portion of stone has been removed. By order of your Committee the yoke of Oxen supplied to the Farm by the Council were turned into beef, and in order to beef them they could not be worked very much in the summer season. This left us with a one horse team to do all trucking and other business in connection with the Institution. I consider the loss of the team a very great one to the Institution and the County also. Whereas, for want of sufficient teams a large amount of stone remains on the ground, which could have been removed and the ground reploughed and prepared for early epring sowing, but it now remains in a crude state awaiting teams sufficient for the emergency. Gentlemen, allow me to call your attention to this one great fact. When the present team is called away from the Farm for provisions and other business in connection with the Institution, which averages about three times a week, farming is at a stand still, working men idle, which is not very satisfactory for those who are expected to make the Poor Farm a success. There are at the present date 58 inmates in the Institution; 9 insane men, 12 insane women, 19 sane men, 18 women. There have been 10 deaths during the year, chief cause La Grippe. We have had no epidemic. There has been one improved case of insanity, the patient taken home by her parents. There have been three births during the year. Two have been discharged, one still remaining.

IMPROVEMENTS.—There has been a store built for provisions, size 14x 18 feet, also a dead house, 10x6 feet. Cost of the two, \$65.08.

Also about 8 tons of good upland hay.

WANTS.—The old barn on the farm needs a thorough repairing, or a new one to replace it.

Councillor Bissett advised deferring till spring.

The Report passed, to be fyled with Committee on Public Property. GENTLEMEN.-I beg to submit the following Sanitary Report of the County Jail for the year just ended.

No cases of contagious sickness have occurred among the inmates since my last report. Minor cases of illness have been numerous, and the usual number of sases of alcoholism and insanity, have called for special care and treatment. Of the former, one case was so serious, that his removal to Victoria General Hospital was a necessity.

During the year six insane persons were committed to Jail for safe keeping, and one, who was a crown witness in an impending trial, became violently insane while an inmate of the Jail awaiting the trial. Four of these were sent to Mount Hope Hospital for the Insaue for treatment, two were placed in the City Poors' Asylum, and one was handed over to her friends.

It is required, with each detachment of prisoners sent from the Jail to Dorchester Penitentiary, to forward a clean bill of health. I have accordingly supplied certificates of freedom from disease for John Scanlon and Robert Desmond in March; for Wm. Aikins in August, and Nathan Griswold in September; for McGuire, Shea, Neville, Whalen, Hartnett, Sweeny, McVicar, Baker and Slaugnwhite in October; and for Thomas MacEvoy in December.

The walls and corridors I have, as usual, found clean and well limewashed; the food has been of good quality and well cooked; and the Jailor, Mrs. Chambers, and the turnkey have been considerate of, and attentive to the wants of sick prisoners.

Read, a letter from A. Elliot, Town Clerk, Dartmouth, requesting the Council to name a time for a conference with their Water Commissioners in regard to raising the roadway near Lamont's Lake, District 31, rendered necessary on account of the Water Works.

The Clerk was instructed to name 11 or 12 o'clock next day.

Read, application from Dr. Thos. Trenaman for the position of Physician to the County Jail for the current year. Moved by Councillors Bartlett and Taylor—

That Dr. Trenaman be re-appointed as surgeon to the County Jail during the ensuing year, with usual salary of \$75.00. Passed.

Read, the Report of the City and Provincial Engineers, containing Specifications and details of the diverted roadway around Chain Lake, District 14, 21 feet in width, to be completed by 30th June next. The work is rendered necessary for the new pipe line for the City Water Works. The Report was favorably commented upon, accepted and transmitted to the Road and Bridge Committee. Read, Report of A. S. Innes, Custodian of Lake Porter Draw Bridge. The draw had been opened 60 times. The Bridge requires new covering, the abutments need repairs, and the centre pier has settled. Referred to Road and Bridge Committee.

Read, Report of Joseph Lloy, Custodian of Rocky Run Draw Bridge, District 29. The draw had been constantly in use, and the machinery and other parts of the Bridge are in good order. The report was received and adopted.

Read, Report of S. & W. Purcell for year ended Sept. 30th, 1892, for the Ferry between Point Pleasant and Purcell's Cove. A total of 2,275 paying passengers were taken across each way. Besides these there were 350 blanks or deadheads in a revenue of \$159.29. Purcell, the Ferryman, has been in receipt of no subsidy from the County.

A discussion followed on the subject of Ferries and Ferry Licenses. Chapter 52, R.S., 5th Series, and the Sections of the By-Laws relating to Ferries were read. The Clerk said that some years since the Council voted \$30 for this Ferry, but it was discontinued.

It was stated by Councillors Fagan and Hays, that a new boat for rough weather was necessary at this Ferry, and that the Ferryman needed financial aid to obtain such an one. On motion—

Resolved, that the sum of forty dollars be granted to the ferry between Point Pleasant and Purcell's Cove in consideration of a new boat being obtained. The money to be paid when the boat is secured and approved.

The Report of Ferrymen S. & W. Purcell was received and adopted.

The Council adjourned to Thursday at 10 a.m.

THIRD DAY.

THURSDAY, Jan. 12th, 1893.

The Council met at 10 a.m. Present, the Warden and 29 Councillors. The Minutes of last Session were confirmed. Read, the Report of Committee on Licenses ungranted in District 15, which was discussed.

Councillor Donaldson urged that the parties, for various reasons, and the requirements of Hotel accommodation, were entitled to their License.

REPORT OF THE COMMITTEE TO CONFER WITH IN-SPECTOR REID IN REFERENCE TO LIQUOR LICENSES IN DISTRICT 15.

Your Committee find that the report of Inspector Reid to this Council in regard to the qualifications of Ratepayers in said District was strictly in accordance with the information furnished him, but your Committee found reasons for believing that the making up of the list of Ratepayers defining residents and non-residenta was subject to many inaccuracies, and we find in investigating said list sufficient evidence to satisfy us that there are on the Roll the names of thirteen persons set down as residents who are non-residents.

We also find that the name of Councillor Donaldson was erased from the applications of W. Paw and W. Wilson for the reason that on the Voters' Roll the only name of Donaldson which appears is "The Estate of T. Donaldson,". which Councillor Donaldson claims should have been in his name, but as Inspector Reid excluded all estates in his calculations he had no choice in this instance.

Your Committee would therefore beg to state that they consider the placing of these names of *non-residents* in *residents*? list was an unpremeditated error of the assessors; and if the correction of these errors is admissable under the law-as your Committee believe to be just—then the applications of W. Paw and W. Wilson would be quite within the legal requirements and entitle them to a license.

Read, Report of Board of Health in District 38. No contagious disease had prevailed. There were five deaths during the year—two from consumption and three from other causes. The Report was received and adopted.

Read, the Report of R. W. Tremain, Sanitary Inspector for District 17, with an account for his expenses, \$5.50, and an account of Dr. H. H. DeWolf for \$24.50.

Moved by Councillors Burris and Bartlett-

That the report of the Sanitary Inspector for District No. 17 and the accounts annexed to it be referred to Finance Committee Passed.

Read Report of Board of Health, District 26, stating measures adopted to secure the fulfilment of the law in regard to Offal at Lobster Factories, which some Canneries had carried out and others disregarded or ignored. The District had been free of infectious diseases. On motion the Report was received and adopted. Read, Report of Board of Health, District 33, with an account from Dr. Cunningham for attendance, \$35, and Mrs. Negus for services as Nurse, \$20, in diptheria cases. On motion, referred to the Finance Committee.

Councillor Chas. E. Smith asked that Mr. Hartlen, Counsel for Mr. C. E. Gough, of District 14, have leave to address the Council on the subject of the latter's application for License in that District not granted.

The Warden ruled that the subject having been already disposed of could not be again considered.

Read a letter from J. A. McNab, complaining of the action of Assessor J. Farquharson in valuing him on the Assessment Roll of District 31, year after year, for property of estate of late Peter McNab, which was held by Grant brothers, who should pay the taxes. Referred to Committee on Assessments.

Moved by Councillors A. W. Smith and Fraser-

That the road from Ecum Secum Bridge to Samuel Pye's be made No. 9 Road Section in District 24. Passed.

By Councillors Jos. Thomas and Kerr-

That the road between Look Out Hill and Hall's Corner be made a new road section in District 30. Passed.

Read the Report of the County Auditors, with the Treasurer's financial statement of receipts and expenditures for the year 1892.

" Read Report of Board of Health, District 18, that there had been no infectious disease in the District, and nothing for the Sani'ary Inspector to do.

The Report was received and adopted.

The Treasurer reported refusing to pay, as being exorbitant, a bill of Messrs. T. C. Allen & Co. for \$81.60 for two books for the Registrar of Deeds, and A. J. White, Esq., (the Registrar) attended to explain the matter. He stated that the books were of parchment as formerly, and ordered from England, and that such books had gone up very much in price, of which he was not aware. That these books were far superior to ordinary registers, and would outlast them (being so much handled,) many years, &c.

It was moved by Councillors Fagan and Wilson-

That the books for the Registrar's Office be retained, and the Treasurer be authorized to pay the account. Passed.

Moved by Councillors Wilson and Kerr and-

Resolved, That the new Road from Lake View and Rocky Lake to the Cobequid Road-two miles in length-be included for Statute Labor in Windsor Junetion Section, District 17. Passed.

The following re-distribution of Statute Labor in District 18, was moved by Councillor Wilson, seconded by Councillor Bartlett___

Whereas, the Statute Labor Road Sections in District 18, which were estabwhereas, the Statute Labor Road Sections in District 10, when were statute lished many years ago have, by the changed conditions at the present time, be-come unsatisfactory and unsuited to the judicious apportionment of the Statute Labor. And whereas, public meetings were held at Oldham and Waverley in said District, at which the following re-arrangement of the Road Section was unanimously accounted and the section was

unanimously approved. Therefore Resolved, That Road Section No. 1 shall extend from the District line between 18 and 31 to Waverley Corner and thence to the Robinson Bridge on the between 18 and 31 to Waverley Corner and the Bedford. the Cobequid Road and the District line on the road to Bedford.

That Road Section No. 2 Extend from Waverley Corner to the Iron Mine Pit near head of Grand Lake on the Truro Road and to the first bridge beyond Rutherfords on the Guysboro Road. That Road Section No. 5 Extend from said bridge near Rutherfords on the Guysboro Road.

Guysboro Road to the boundary line between District 18 and 20.

That Road Section No. 4 Extend from the Guysboro Road to the Truro Road and through Oldham Village to the Hamilton Mill and to Frank Turney's residence

That Road Section No. 5 Shall extend from the District line on the Truro Road to the Frenchman's, or King's Road, including the branch roads to Enfield Bridge, to the railway and to Sandy Cove.

That Road Section No. 6 Extend from Frenchman's Road to the Iron Mine

Pit at head of Grand Lake. That Road Section No. 7 comprise all the Old Cobequid Road from where it leaves the Truro Road on Fletcher's Lake to its junction with said Truro Road again at Wellington. Passed.

The Clerk submitted the account for Insane at Mount Hope Hospital for December 2nd, \$432.10 Also a Report of Special Committee on disputed Insane. Deferred. The Council adjourned to Friday at 10.30 a. m.

THURSDAY AFTERNOON, Jan. 12th, 1893.

A large number of the Council went to Cole Harbor to inspect the Poor Farm and others engaged in Committee work.

FOURTH DAY.

FRIDAY, A.M., Jan. 13th, 1893.

The Council met at 10.30 a.m. Present, the Warden and 27 Councillors. Minutes of Thursday were read and adopted. The Provincial Secretary was present.

Read, a letter from ex-Councillor Fenerty, enclosing a copy of the City Engineer's reply to his letter, asking that the City contribute toward keeping up part of the Dutch Village Road, which forms the boundary line between District 14 and the City, and has heretofore been kept in repair by the District solely.

Engineer Doane set forth several reasons why the City should not help to maintain that road, the principal one being the limited amount of funds at disposal for the great number of more important streets the City has to maintain.

On motion it was referred to the Road and Bridge Committee.

Read, a letter from Sandford Fleming, Esq., C. M. G., to the County Clerk, and which he had submitted to ex-Councillor Fenerty in November last, to take action on, as follows:

Sir,—I beg leave to state for the information of the County Council of Halifax that I have taken some trouble during the past two years to establish a new road which will considerably facilitate travel from the head of North-West Arm to Lawson's mill and York Redoubt. The line of road leaves the Herring Cove Road, about $\frac{1}{2}$ mile south of Chocolate Lake, passes through the property of the Imperial Government and my own property to a point of intersection with the existing road near the stone gate pillars. It will avoid the heavy hills on both sides of Melville Island Prison, and in other respects will be better than the road now travelled when once it 27

is completed. After much delay I have obtained the assent of the military authorities. I have laid out the line of road and recently expended in wages, powder and labor, not far short of \$100 upon it. The road is now roughed out and rendered practical for a light cart to travel over. I desire to dedicate the road to the public, and I would be glad to go over it with someone representing the Council at an early date.

Mr, Fenerty reports that he had gone over the Road as requested and found it a vast improvement on the old one, and hoped the Council would be willing and able to contribute to the completion of the road.

Read, a note from Town Clerk, Dartmouth, explaining that owing to absence of one of the Commissioners and illness they had to defer a conference to another day. The Clerk was instructed to name any day for the meeting before the closing of this Session.

Read, a Petition from Andrew Rourke and other persons in Little River, (District 35,) complaining of obstructions of fences, poles, &c., on a quarter of mile of road leading from the Guysboro Road to Meagher's Grant Road.

Read, a Counter Petition from W. R. Ogilvie giving his version of the matter and reasons for opposing the requisition for District 35.

On motion of Councillors Taylor and Bartlett-

Resolved, That the petitions be referred to Committee on Roads and Bridges.

Read, a letter from W. R. Ogilvie claiming that his waggon had been broken by obstructions on the road at Little River, and asking \$25 damages for the same.

It was moved by Councillors Burris and Bartlett-

That the petition of W. R. Ogilvie for damages in District 25 be referred to the Finance Committee Passed.

Read, a Petition from inhabitants of Meagher's Grant asking for a grant of money towards a road and bridge across the Musquodoboit River, at a place called Gibraltar, where there is only a fordway, in crossing which Dr. Stewart and subsequently a young woman were drowned. FIFTH DAY.

SATURDAY, P. M., Jan. 14th, 1893.

The Council met at 2 P. M. Present, the Warden and 29 Councillors. Yesterday's minutes were read and confirmed.

The lists of Officers for Districts 15, 17 and 30, which were not at hand yesterday, were received, read and passed separately.

Read, application from Richard Burbidge to be Chief County Constable, and from Henry Wright, Ephraim Haverstock and Joseph Grant to be County Constables.

Moved by Councillors Fagan and Wilson-

That R. Burbridge be reinstated in office as Chief County Constable under the same pay as heretofore upon his providing the prescribed bonds. Passed.

Moved by Councillors Bartlett and Madill-

That Harry Wright be appointed a County Constable for ensuing year on condition of his furnishing bonds to the amount of \$200. Passed.

By Councillors Burris and Bartlett-

That Ephriam Haverstock be appointed a County Constable for 1893 on giving bonds for \$200. Passed.

On motion, Joseph H. Grant's application ordered to lie on the table.

On motions severally moved, seconded and passed, the following were appointed the Committee on Arbitration and Assessments between the City and Dartmouth for 1893, viz:

The Warden, Councillors Wilson, McCallum, Bissett and Taylor. Passed.

Read, a Petition from certain inhabitants of Bedford (District No. 15) for a Pound for that District.

Moved by Councillors Donaldson and Bartlett-

That the prayer of the petition from District No. 15, relative to establishing a pound for the confinement of stray cattle or horses, etc., be granted. Passed.

The Clerk mentioned that the expense of erecting a Pound has to be borne by assessment on the District.

Read, application from Mrs. J. B. Sentell for the position of Janitress of the Court House for the year.

Moved by Councillors Bartlett and Henley-

That Mrs Sentell be appointed janitrix of the County Court House for ensuing year. Passed.

Reference was made by several Councillors and by the Warden and Clerk to the large amount of work and strict attention to his duties, which precluded the County Stipendiary from taking and enjoying the holidays voted him yearly by the Council.

It was moved by Councillors Donaldson and Bissett and-

Resolved, That this Council vote the sum of \$50, (fifty dollars,) as an increase to Stipendiary Griffin's salary in lieu of Holidays, as in his office it is impossible for him to take any holidays, also as his salary is but a small charge upon the County after deducting his fees, which revert to the County.

It was moved in amendment to make the sum \$100. The amendment was withdrawn and the original resolution passed unanimously.

Councillor Burris stated that one of the inmates of the Poor Farm from his District rendered considerable and regular services which saved the County much expense. District 22 was paying for five paupers there, and the people thought it would be only fair that 75 cents per week should be allowed for the female pauper as there were reasons why she should not be removed. He approved the opinion of some Councillors that the poor should be a County charge.

Councillor Bissett agreed with him in regard to the valuable services of some of the paupers, and that these should be allowed for in part at least.

The Warden thought it would be a bad precedent to establish, and a departure from the rule adopted in such Institutions. The aim was to work the Farm, etc., by the inmates if possible, and so lessen its expense to the County thereby. There would always be a large number unable or unfit to work, and those of course are exempt and have to be supported like the rest.

The matter was allowed to drop and be brought up later on when the Report on Public Property was submitted.

And as there are four others who have taken out Licenses and have made no Report, we would recommend that a fine of Five Dollars be imposed on each License holder not making yearly Report.

. It having come to our notice that William Baker, of West Dover, is now and has been running a Ferry without taking out the necessary License, we would ask our Clerk to notify him and have him comply with our By-Laws.
We would also suggest to this Council the necessity of more stringent regulations on Pedlers and Hawkers, and would ask the Law Amendment Committee to have legislation at its next session to so alter the law as to make it compulsory for each and every Pedler and Hawker to take out a License.

And would further recommend that all Licenses for Pedlers and Hawkers with horse or horses be Ten Dollars, and foot Pedlers or Hawkers Six Dollars, and that there shall be no distinction between ratepayers or non-ratepayers, and that every License holder shall be compelled to have his name and number of License marked plainly on the dash-board of his waggon or sled, and if a foot Pedler on the side of his pack.

And that the Inspector of Liquor Licenses (Mr. Reid) be an Inspector of Pedlers and Hawkers, in conjunction with all J. P.'s, without remuneration, for one year.

- Read, a letter from Professor George Lawson in reference to a change of road near Sackville Mills, in District 17, forwhich he had granted a right-of-way through his property as a free gift. Councillors Corbin, Thomas and Croucher had laid out the road, but in a wrong direction to that intended by Dr. Lawson, being on the wrong side of the Pool at which his cattle were watered, so that they were cut off therefrom. He asks that this mistake be rectified, and also as this new route saves a long detour for the people of the County, and of Hants, Colchester and Lunenburg, that the County Council adopt measures whereby the road for the distance required could be completed and rendered fit for satisfactory use.

The resolution passed last year in reference to opening this road was referred to and read. See printed Minutes 1892, page 63.

Where a horse and vehicle is employed the License shall be ten dollars, and where the goods are carried by packs strapped on their backs or by satchels or carpet bags in their hands, it shall be six dollars. Any person to whom they offer their wares for sale or any ratepayer in the Municipality may demand them to exhibit their License, and upon refusal to do so they shall pay a fine of double the amount of the License required of them. The fine may be imposed before any Magistrate or Stipendiary Magistrate within the Municipality, and when collected shall be paid to the County Treasurer. Passed.

Read, Report of Health for District No. 15, which showed the District to have been in good sanitary state during 1892. The Inspector had caused a nuisance, being the putrefying remains of a horse which floated ashore, to be removed and buried, for which the expenses were \$4.00.

We find several irregularities in Commissioner's returns. We find also that the amounts of taxes uncollected for the years 1890, 1 and 2, are much larger in our opinion than they should be. Below we give statement of amounts uncollected for each year.

We find also in the year 1890 that collector for that year had a Warrant of Distraint issued by Judge Griffin against several persons for unpaid rates, but that the Warrant did not contain the names of several persons whose rates were unpaid.

We recommend that County Clerk be instructed to commence immediate proceedings to compel collectors to show cause why amounts were not collected and why names omitted from Warrant do not appear there.

REPORT OF THE COMMITTEE ON PUBLIC PROPERTY.

1.—The Committee, in presenting their report, would refer to the Jailor's and Surgeon's report on the County Prison, from which it appears that the past year has been one of fair results in the Institution.

2.—The expenditure for maintenance and repairs of Jail and Court House has been kept as low as possible, with a view to the comfort of inmates and preservation of the buildings.

1 3.—The Poors' Farm has been conducted with good success the past year.

4.—The total bills for the year for food, clothing and wages, including salary of keeper and matron, and attendance on insane, repairs to buildings, and milk, \$36, which may fairly be considered an asset, amounts to \$3,649.60 for 2,644 weeks and 4 days of inmates for the year 1892. We have also paid bills due 1891, but not at hand Dec. 31st, 1891, amounting to \$58.71, which is not included in the amount, \$3,649.60, expended the previous year, as we had a surplus in hand over expenditure in 1891 of \$132.21, which paid the bills for that year, over \$53.71, and left balance in favor of the Institution of \$123.50. The amount given, viz., \$3,613.60 expenditure, does rot include the \$800 instalment for repayment of debentures and interest thereon, but the sum saved by keeping the insane at the Poors' Farm, viz., \$1,142.50, less than it would cost at Mount Hope, will more than pay the yearly instalment of \$800 and interest thereon.

5.—Wherefore your Committee consider the County has no cause to regret the establishment of the Poors' Farm, but rather congratulate itself upon the present and favorable outlook for the future.

6 .- The cultivated ground has been largely extended the present year. notwithstanding the limited amount of labor from the inmates.

7.-The produce raised is all consumed on the Farm. There was

Whereas, in the opinion of this Council it would materially improve the appearance of the County Poor House, would tend to promote the general health of the inmates, and be otherwise beneficial to have the main floors, bedroom floors and halls, stairs, landings, wash-rooms and hall of dining-rooms and chapel painted; also floor and walls of the w. c. and sides of Main Building painted. Be it therefore resolved that the Chairman of Public Property Committee be authorized to purchase sufficient and suitable paint for that purpose. Passed.

Moved by Councillors Hubley and Fagan, and

Resolved, That the repairs or construction of a barn at the Poor Farm be deferred until the April meeting, and a report of the same be laid before the Council of the probable expense of such repairs, or by the Committee of Public Property. Passed.

Read, an application from Jas. F. Turner, Keeper of the Farm, for an increase of \$50 to his present yearly salary, showing the large amount of work and economy of management effected by himself and Mrs. Turner.

Several Councillors spoke in favor of granting it, and it was moved by Councillors Taylor and Bartlett-

That Fifty Dollars be added to the salary of the Keeper of the Poor Farm.

On being put the resolution was lost. Councillor Thomson asked to have the appointment of E. Haverstock as a County Constable cancelled. The Warden ruled that the matter could not be reconsidered. The Councillor handed in an application from George Mason, District 16, for position of County Constable.

On motion, he was appointed, on condition of giving the usual bond.

Councillor McCallum addressed the Council relative to the necessity of a conveyance running regularly between District 14 and the City. He claimed that the people were entitled, from the large amount of taxes paid to the County and the small amount received back. They should be assisted in supporting such a convenience.

The other receipts being such as were common to all Districts (as Revisors and Assessors and Councillors' pay.), He moved, seconded by Councillor Henley—

Whereas, District No. 14 is financially one of the largest rated Districts in the County.

And Whereas, the welfare and financial strength of the District depends largely upon the facilities for communication between the City of Halifax and the North-West Arm and Dutch Village in said District 14 :--

Resolved, therefore, that this Council do vote the sum of one hundred and fifty dollars to aid in establishing an Omnibus Line to run via Quinpool Road and head of North-West Arm to Dutch Village in said District 14.

The resolution was discussed and amended by adding that "the subsidy be in quarterly payments on certificate of the District Councillor." Passed.

REPORT OF SPECIAL COMMISSION IN REGARD TO MIS-APPROPRIATION OF ROAD MONIES IN DISTRICT 30.

Your Committee had three sessions in this investigation and each time getting more mystified; concluded that for mixed and confusing accounts those of District 30 should take the prize.

We do not find any evidence that Councillor Thomas has mis-appropriated to his own use or benefit any of the road funds, or that, he acted in collusion with any person towards that object. In fact he assures us he was very exacting for an selequate return for the money paid out

 We find also in a commission issued to expend a given amount on the Old Preston Road, that the account of expenditure included several days work done by other parties on the New Road, which was done to summarize these small items of repairs in several portions of the District So far as your Committee can ascertain, we cannot place our hands on any of these transferred items or charges, and they have not been done or have been paid for twice, but we must say they are most inextricably mixed; and in one commission of \$31.00 for repairs to Old Partridge River Bridge, the charges for labor appeared to us to be in excess of the value claimed to have been rendered for it, and it has been represented to us, for which we do not hold ourselves responsible, that the general roads of the District are in poor repair, and not commensurate with what might be expected from the amount of the District grant, considering that the Government have expended considerable there within the past few years.

In conclusion your Committee feel they must express disapproval of the method of making up statements of expenditure, and would suggest that a simple statement of the accounts of the time, where, and purpose for the expenditure, when out of the usual or regular time of making repairs, would not only make the case clear to any one investigating the expenditure of his District, but also relieve the Councillor and Commissioner from imputation of irregular practice.

Councillor Joseph Thomas made some explanations in regard to the extent of his District roads (over 60 miles) and the large number of Bridges to be kept in order out of the paltry grant for his District. He claimed that his maligners were afraid to meet him before the Committee, could not substantiate the charges, and that the whole affair was malicious.

Moved by Councillors Burris and Bartlett-

That the Report of the Committee on the Thomas case be accepted. Passed.

The Clerk read

REPORT OF THE SPECIAL COMMITTEE ON THE SETTLEMENT OF ACCOUNTS OF DISPUTED PAU-PER INSANE WITH THE GOVERNMENT.

To the Hon. the Warden and Councillors of the Municipality of Halifax County.

GENTLEMEN, — Your Committee invested at the April session of this Council in 1892 with full power to secure a settlement with the Provincial Government for the maintenance and expenses of Pauper Lunatics, claimed to be legitimately chargeable to Halifax County, requested the Municipal Clerk to prepare the list of disputed patients who had from year to year been objected to us as having undecided and doubtful settlements (or none) within said County, and to transmit the lists with all information therewith which he had been able to gather, to Hone-C. E. Church, the Commissioner of Works, etc.

This having been done, your Committee attended on May 19th, at the office of the Commissioner, and submitted the reasons and legal objections for non-pay ment of a number of the Lunatics charged for several years to Halifax County todate of last account rendered, the amount of which was \$23,000, including interest unprovided for.

The Hon. the Commissioner desired further time to consider the objections, and for the Secretary to procure documents and details relating to the disputed Insane, which would help to elucidate the accounts. Meantime the attendance of the Committee would be unnecessary until he and the County Clerk had further examined the evidence on both sides, and arrived at a basis of settlement.

examined the evidence on both sides, and arrived at a basis of settlement. The County Clerk was authorized by the Committee to take all necessary steps to prove the position, and establish the counter claims of the Municipality, and submit such an offer for the balance as might then appear equitable. That offer, after consultation with the Warden was \$15,000, on special conditions as to transferring a number of the Pauper Insane and their future maintenance, and was submitted to the Government by Hon. Mr. Church, with certain modifications.

The Hon. Provincial Secretary thereafter communicated his views on the subject to the Warden. The Committee were called together, and after conferring with Hon. Mr Fielding, unanimously adopted the following resolution, viz :

"Resolved, That an investigation be held at once to settle the legal settlements of the disputed Insane, and if in such investigation it is discovered that the Municipality has paid more for Insane Paupers justly chargeable to the Province than the sum allowed by the Commissioner of Works, such sum in excess shall be placed to the credit of the County of Halifax for future purposes."

Under this resolution the \$15,000 agreed upon was paid to the Commissioner, but as the negotiations had extended to the close of the year, and three members of the Special Committee are no longer in the Council, further proceedings have been deferred to a later period, then to be undertaken and carried into effect, should the Municipal Council so instruct the subsequent Committee for that purpose.

All of which is respectfully submitted.

The Warden and Councillor Taylor made some remarks in detail, and asked the opinion of the Council as to proceeding with further investigations and filling up vacancies on the Committee. It was decided to defer action until satisfactory evidence could be collected respecting the several cases.

On motion, Councillors Taylor, Madill, the Warden and Clerk; were appointed as the Committee to carry out the recommendations of the Council.

The Council adjourned to Wednesday at 10 a.m.

EIGHTH DAY.

WEDNESDAY, January 18th, 1893.

The Council met at 10 A. M. Present, the Warden and 29 Councillors. Minutes of last meeting were read and passed. Moved by Councillors Madill and Hubley-

That the bounties for Killing Bears and Wild Cats be the same as last year, viz., Bears Four Dollars, Wild Cats Seventy-Five Cents. Passed.

On motion of Councillors Kerr and Smith, the sum of eight dollars was voted to be assessed for Poor District No. 17.

REPORT OF COMMITTEE ON ROADS AND BRIDGES.

The petition from District 38, relative to extention of Road Section in that District, has been duly considered, and we therefore recommend "That said petition be granted."

Relative to communication in re Dutch Village Road, your Committee does not consider the County liable for total maintenance of said Road, and as we consider the City Corporation fully responsible for one-half the necessary outlay, we would recommend its being deferred for further consideration.

With respect to construction of new road in District No. 14, in heu of the present road running along Chain of Lakes, we recommend its being deferred until the April Session, to enable the Council to obtain further information in the matter.

Relative to petition from District 35, respecting the widening of a certain portion of road, we recommend "That if no title exists defining the breadth of the road in question, then petitioners interested do apply to this Council for the required precept.

With respect to a communication from Thomas Eldershaw, District 27, asking for the opening up of road, your Committee hereby recommend that the petitioner in this case apply for a precept, according to law made and provided in such cases.

The petition from District 20, praying for grant to assist in constructing a bridge across the Musquodoboit River, at a place called Gibraltar, has been duly considered, and your Committee would earnestly recommend that the amount asked for, viz: one hundred dollars, be granted by this Municipality in this years Road Grant.

The numerously signed petition from District No. 33, praying for the opening up of a new road in that District, having been carefully deliberated on by your Committee, we beg to recommend the granting of the necessary precept.

The letter of Sandford Flemming, Esq., has been carefully considered, but in the absence of necessary information we beg to recommend said letter being deferred until the April Session.

Relating to the report in re Porter's Lake Bridge, we recommend the matter to the Councillor of the District.

The annexed sheet will give a precise statement of the various Districts, showing work liable, work done, and work not performed.

Your Committee strenuously urge upon this Council, that until the Councillors of each and every District insist on all returns being brought to them for final inspection before the forwarding of said road returns to the Clerk, there will always be a vast amount of labor, which otherwise would be saved.

All of which is respectfully submitted.

The report was discussed in clauses. On clause one, on motion of Councillors Morash and Hayes, the extension of Statute Labor in District 38 was made to be from Power's Hill to Burns Point.

The remaining clauses were passed separately, and the Report passed as a whole.

The Provincial Secretary attended at this meeting, and in reply to enquiry concerning the Road Act, by Councillor Fraser, expressed himself quite willing to address the

Council on the subject. If the Council wanted the Act they could vote on it, and have the people vote on it at the next election. If the Council was opposed to the Act let it alone.

Councillor Fraser, seconded by Councillor Henley, moved the following resolution :---

Whereas, The Legislature at last session passed an Act known as the Public Road Act of 1892,

And Whereas, Section 41 of said Act provides that the Council of any Municipality may at any regular meeting by resolution decide to submit it to the electors of the Municipality,

electors of the Municipality, Therefore Resolved, That a vote of this Council be taken to decide whether we shall submit the question to the electors.

The Council seemed disinclined to debate the subject, and the Warden recommended them to leave the Act alone, as he felt sure the measure would be rejected by almost every man in the County.

Councillor Thompson wouldn't advise the Council to consider the Act at all. There were dangerous clauses in it, and very few people understood the scheme.

Councillors Wilson and Donaldson moved in amendment-

That the New Road Act be not considered at this session.

On being put the amendment carried with one dissentient, and the original resolution was lost.

On motion of Councillors Thompson and Donaldson-

Besolved, That Kearney Road Bridge be placed under the Bridge Act. Passed.

On motion of Councillors Lapierre and Conrod, George Myette was appointed keeper of Canterbury Draw Bridge for 1893 at same allowance as last year.

Read-

THE REPORT OF COMMITTEE ON LAW AMEND-MENTS.

The Committee on Law Amendments recommend that we ask the Legislature to pass the following amendments:-

1st.—That sub-Section (1) of Section 24, Chap. 2 of the Acts of 1888, be repealed.

2nd.—That sub-Section (2) of Section 24 of said Act shall read as follows:— Any party residing within the Municipality shall be taxed for his County or Poor Rates in each District where his property lies and his income is assessed, and such Rate or Rates shall be collected by the several Collectors of the County or Poor Rates in the several Districts. 3rd.—That Chap. 17 of the Acts of 1890 shall not apply to parties arrested for non-performance of Statute Labor or for non-payment of Poll Taxes for the support of Public Schools The above amendments for the County of Halifax only.

4th.—That Section 48 of the Acts of 1888 relating to Municipal Assessment, by adding after the word fees in the sixteenth line the words "for actual and necessary travel one way for each defaulter named in the warrant"

5th.—That property belonging to Corporate Companies be liable for Statute Labor, the same as other property (on its assessment valuation), with power to enforce such law.

6th.-That the law relating to Coroner's Inquests be added to as follows :--

No fees shall be claimed by any Coroner in respect of an inquest, unless, prior to the issuing of his warrant for summoning the jury, he shall have made a declaration in writing under oath (which oath may be administered by any Justice of the peace or Commissioner for taking Affidavits in the Superior Courts, and shall be returned and filed with the inquisition) stating that from information received by such Coroner, he is of opinion that the deceased did not come to his death from natural causes or from mere accident or mischance, but came to his death from violence or unfair means, or culpable or negligent conduct of others, under circumstances requiring investigation by a Coroner's inquest.

Resolved, That we again ask the Legislature that Section 4, Chap. 57 R. S., be amended by substituting the words "Five Hundred, for the words "One Thousand" in said Act. Passed.

The Report was then passed as a whole.

Councillor Burris referred to and read a resolution of the Halifax Board of Trade, relating to a proposed railway from Dartmouth to Musquodoboit, and moved the following resolution:--

Resolved, That this Council having heard the resolution relating to the construction of the Musquodoboit Railway, passed at a meeting of the Halifax Board of Trade on the 17th January, 1893, hereby endorses the same.

Further Resolved, That the question of the grant of a free right-of-way by the Municipality to any Company undertaking the construction of the Railway, be considered at the Semi-Annual Meeting of this Council, to be held in April next.

Seconded by Councillor McMullin, put and passed.

Read, a letter from W. A. Black, Esq., protesting against being taxed on his income in District 15 last year as being illegal, being resident there only a few months in summer, and already taxed in the City where his income is derived. etc.

On motion referred to Revising Assessment Board. Read—

THE REPORT OF COMMITTEE ON POOR.

Your Committee having examined the Returns of the several Districts, beg leave to report as follows :--

The Returns presented are in some respects very unsatisfactory. Several Districts have not sent in returns, and others are in such a state that your Committee cannot make them out correctly.

We find in the Report from District 18, that there is a charge of \$10.00 for. Postage, Stationary and Salary to J McDonald. Your Committee would again recommend that this charge be investigated. The annexed table gives a summary of the returns to hand as we find them.

SEMI-ANNUAL MEETING

OF THE

Municipal Council of the County of Halifax.

APRIL, 1893.

FIRST DAY.

TUESDAY MORNING, APRIL 11, 1893.

The Council met in accordance with adjournment at the Court House, Halifax, this day at 11 o'clock.

Present the Warden and 27 Councillors. Councillors C. E. and A. W. Smith and J. Kirker had not arrived, but were present subsequently.

The Clerk laid on the table the report of his doings in connection with the election of a Councillor for District No. 16, held, as appointed by the Warden, 15th March, and resulting in the return of Samuel Thompson, Esq., by a majority of 34.

Councillor Thompson was sworn in and took his seat. The Minutes of last day of January Session were read and adopted.

The Warden then delivered the following address:

WARDEN'S ADDRESS.

GENTLEMEN OF THE MUNICIPAL COUNCIL.

It is so short a time since our last meeting that I have nothing of special importance to communicate to you. Our Session, as you are aware, is one week earlier than usual; it is in fact the earliest Session we have had since the organization of the Municipal Council. During recess two of the Councillors, whose returns were petitioned against, were unseated. In No. 16, after receiving the judgment of the Court, I issued a warrant for a new election to be held on the 15th of March, which resulted in the return of the Councillor who had been petitioned against, by an increased majority. In No. 36 the judgment was rendered so late that there was not time to order an election before this meeting, not even if we should have met a week later. District 36 is therefore unrepresented at this meeting of the Council.

The division of the Road Grant will be the most important matter to engage your attention.' This will, of course, fall principally upon the Road and Bridge Committee. I trust the Members of this Committee will keep in view the needs and requirements of the several Districts, and make their division accordingly.

You will remember the resolution passed at the last Annual Meeting respecting the April Meeting, and having the assurance of the Provincial Secretary that the road grant would be ready for us this week, I instructed the Clerk to summon you to-day in accordance with your expressed desire in January.

I must remind you that at this meeting you are required to appoint revisors for the electoral lists, and request that you appoint competent persons to perform that duty irrespective of any other considerations, as the incompetency of some of the revisors has given the Clerk a vast deal of trouble. In many cases the lists have had to be sent back for amendment.

I anticipate a short Session, and in conclusion I beg to express the hope that your duties during the Session may be performed with a due regard to the welfare and best interests of the County.

The subject of a Board of Appeal for assessments was considered. The Board of Revisors not having been appointed in January left the County without recourse for that service. The discussion was deferred to Thursday.

The appointment of Revisors of Electoral Lists for 1894 was next introduced. On motions moved by the Councillors of each District, seconded and passed, the following were duly appointed such Revisors, viz :--

And that I have determined that the election held on Nov. 15, 1892, for District No. 36, East Chezzetcook, was void, and that neither Dennis Smith or any other person was returned thereat.

And I further certify that there is no reason to believe that corrupt practices have extensively prevailed at the election to which the petition refers. All of which I certify.

Resolved, That District 11 be placed under the regulations of the By-Law in respect to sheep running at large. Passed.

Read a letter from W. T. Gray, District 15, complaining of being notified to attend the Assessment Committee in January in reference to over assessment, and on attending and waiting no meeting was held, so that his explanations were unheard. Councillor Thompson, Chairman of Committee, was requested to write Mr. Gray an explanation of the oversight, etc.

On motion of Councillors Madill and Taylor-

Resolved, That \$15 be added to the amount voted in January for the support of the poor in District 19. Passed.

Moved by Councillors Thompson and Wilson-

That in order to get an expression of opinion regarding amendments to the Statute Labor Act, the several Councillors call public meetings in their respective Districts at sometime between now and next meeting of this Council, and elicit, as far as possible, the popular opinion of the inhabitants as to what would be equitable and fair, amendments as to the method of levying a road tax, exemptions of persons by age and to what extent, the rate of commutation, and obtaining any other suggestions or information relative to the subject.

The motion was discussed, and it was suggested that Councillor Thompson address meetings thereon this summer.

On being put the resolution was lost.

Read report of the Board of Health for District 30, shewing that little or no sickness and no infectious disease was prevalent during the year. In July last an ox (owner unknown,) was found dead by the wayside, and becoming offensive had to be removed and buried. The cost of the same was mentioned as being \$6.00, but no bill or voucher was submitted with the report.

Several Councillors considered \$1.50 or \$2.00 as a sufficient charge. Councillor Thomas explained.

Moved by Councillors Kerr and Henley-

That the account presented by Councillor Thomas for burying an ox be referred to the Board of Health for rectification and a proper voucher. Passed.

Reference was made to some alterations and painting in the Court House undertaken and supervised by Judge Weatherbe, one of the Commissioners.

On motion of Councillor Wilson, seconded by Councillor Fagan—

Resolved, That it is the opinion of this Council that the Council Room needs renovation and cleansing, and suggest that the Commissioners of the Court House be asked to have the necessary repairs and renovating performed at any time previous to next meeting of Council, to be done under the superintendence of the Committee of Public Property. Passed.

Read a petition from inhabitants of Districts 13 and 9 for a special grant toward the levelling and improvement of a piece of highway in which both Districts are interested.

On motion referred to Road and Bridge Committee. Council adjourned to 10.30 Thursday.

THIRD DAY.

THURSDAY, APRIL 13, 1893.

The Council met at 10.30. Present, the Warden and 29 Councillors. Yesterday's minutes were adopted. The Clerk read Sections 2 and 3 of Chapter 46, R. S., requiring the Council to fix mode of distributing the Road Grant. Also Section 16 respecting the amount to be paid per day for labor, teams, plough, &c. Deferred until the Road and Bridge Committee report. Read

Brookfield, President of the Halifax Wood Fibre Company, regarding the assessment of the Company's property at Sheet Harbor at \$7,000. The Directors valued it at \$2,000, and could not sell at that figure. It would not pay to remove the machinery for old iron. The mill had distributed a good deal of money in the District while in operation, and the Directors thought their appeal should be allowed, if only as an act of justice. After brief discussion the Clerk was ordered to notify Mr. Brookfield that the appeal was made too late to be acted upon.

The following District Officers were nominated by the Councillors of their Districts and duly appointed:

In District 27, Albert Warnell to be custodian of the Draw Bridge over Salmon River, Jeddore.

In District 10, Patrick A. Duggan to be fence viewer, vice G. J. Longard, over age.

In District 17, P. J. Blakeny to be Sanitary Inspector instead of R. W. Tremaine.

In District 20, James Dickie to be Overseer of Roads for Section 1, vice Kent Sibley, who has gone away.

In District 13, Robert A. Yeadon to be Overseer of Statute Labor, vice Wm. Yeadon, left the District.

Read a request for payment of bounty on a bear, with a certificate from the Montreal purchaser of the skin, received from G. E. Van Buskirk, of Halifax.

The Clerk explained that Mr. Van Buskirk had applied for the bounty, but as the purchaser in Montreal objected to having the nose cut off, and that being the Clerk's instructions, he had refused the demand until the Council should decide upon it. The Council under the circumstances, and on affidavit in the case, authorized the treasurer to pay.

Moved by Councillors Kerr and Henley-

. That the road leading to Lakeview be included in Cobequid Road Section instead of Windsor Junction Section. Passed.

Read'a letter from Dr. H. H. DeWolf, enclosing a claim for \$4.50 as being a balance due him for medical attendance in diphtheria case in District 17 last year.

The Treasurer explained that the Bill presented in January Session from the Board of Health of District 17 was for \$24.50, and referred to the Finance Committee, who, on enquiry, recommended \$20 to be paid Dr. DeWolf, which had been done.³

Moved by Councillors Bartlett and Hubley-

That the communication from Dr. DeWolf¶for additional 10 nuneration for medical tervices in District 17 lay on the table. Passed.

On motion the Council adjourned to Friday at 10 A. M.

FOURTH DAY.

FRIDAY, APRIL 14, 1893.

The Council met at 10.30 A. M. Present, the Warden and 29 Councillors. The minutes of last meeting were read and confirmed.

The property qualification of E. L. Fenerty being insufficient, it was moved by Councillors Madill and McCallum-

That Alex. Forrest be appointed a member of the Board of Appeal. Passed.

Moved by Councillors Lapierre and Fagan-

Whereas, it has been represented to me that the draw in the Canterbury-Bridge has been often opened by persons without authority wanting to pass through in the absence of the keeper; and Whereas, the keeper appointed last January will be absent from his duties during a great part of the summer; *Revolved*, therefore, that the Bridge be provided with a chain and lock, and that Charles Murphy be appointed keeper of said Bridge for the ensuing year, or until the January meeting of Council, in place of George Mayette, going away, at the same allowance as last year. Passed.

Submitted and read notice of appeal received from F. T. Congdon against the decision of the County Court Justice in the controverted election in District 36, Nov. 15th, 1892. D. Casey, plaintiff, vs. D. Smith and Jas. Keizer, respondents, on 6th April, and subsequent order therein.

The appeal is to set aside and reverse said decision except the portion relating to corrupt practices, and will be moved at next sitting in banco of the Supreme Court at Halifax. The document was placed on fyle.

On motion of Councillors Sellars and Taylor, Albert Leslie was appointed Sanitary Inspector for District 29.

Moved by Councillors Donaldson and Fagan-

That hereafter no bounty be paid for the killing of bears and wild cats. Onbeing put the motion was lost.

By Councillors Lapierre and Cole-

That George Mayette be appointed Road Overseer for District 28 in place of . Charles Murphy, over age. Passed.

Read the

REPORT OF THE ROAD AND BRIDGE COMMITTEE

Your Committee beg to report as follows :---

1.-The Petition from District 13 having been duly considered, the sum of Twenty-Five Dollars was granted toward the charges asked for, said amount is included in the District allotment.

2.-The Petition from District 28 was taken into consideration, and the sum of Twenty-Five Dollars' extra granted and added to the amount of the District allotment.

3.-Respecting Petition from District 20, relative to the building of a Bridge near Gibraltar, your Committee beg to state that the sum of One Hundred Dollars is granted for said Bridge, on condition that said Bridge is completed, and that the Committee of the District be responsible for the just expenditure of said grant, and further, we would recommend that no further grant of monies shall hereafter be allowed for said Bridge.

The Report was discussed at length, and objections made to some of the allotments by Councillor Henley and others as being inequitable. The Chairman explained the principle adopted in framing the Report, and that ample hearing had been granted to all Councillors, whose views and statements had been received and duly considered before the Committee finally made up the Scale.

The Warden reported a conference with the Hon. the Judges of the Supreme Court, at which they recommended an increase in the Junior Crier's, J. W. Watt, pay. The Senior Crier received all Court fees and his proportion of the salary paid at present, and the balance was insufficient for Watt.

That J. W. Watt's salary be increased \$100 annually. Passed.

Resolved, That the Councillors of the several Districts be required to bring to the Council at the January meeting a statement of the length of road, with number and span of the bridges, in each of the several road sections in his District, under the statutory declaration of an overseer, commissioner or other person to be appointed by the Councillor-the road to be classed. Passed.

The Clerk read Sections 2 and 3 of the Road Act, 1883, (Chapter 46, R. S.,) respecting the mode of expending the Government grants, and Section 16 for price of labor, teams, &c.

Moved by Councillors Bartlett and Bissett and-

Resolved That the Government grant for roads and bridges be expended by Commissioners. Carried.

Three resolutions were offered respecting price of labor per day: one for \$1.25, one not to exceed \$1.25, and one for \$1.00 per day.

That the price of labor be \$1.00 per day.

Moved by Councillors C. E. Smith and Henley-

Thall for all moneys expended by the Local Government for the use of any roads in any District, the said amount or amounts shall be handed in to the Committee on Roads and Bridges before the Committee make their annual report.

The Clerk submitted and read the following
