THIRD ANNUAL MEETING

OF THE

EIGHTH MUNICIPAL COUNCIL.

FIRST DAY.

HALIFAX, TUESDAY, JAN. 8TH, 1895.

As required by the Statute and Special Notices, the Councillors of the Municipality of Halifax County met at the Court House on Tuesday morning, January 8th, 1895, at 11 o'clock. There were present—His Honor the Warden (John E. Shatford, Esq.) and Councillors John Hayes, Charles E. Smith, Clarence W. Christian, James E. Grono, Alvan Hubley, John W. Umlah, H. M. McCallum, Thomas S. Donaldson, Samuel Thompson, George H. Kerr, B. C. Wilson, George H. Madill, Thomas Cole, John H. Taylor, George Burris, John H. Bartlett, W. C. Henley, Peter Myers, James H. Sellars, John G. Bissett, James Conrod, Alex. McMullen, Dennis Smith, James Moreash and Joseph Thomas.

Absent, but on the way, Councillors O. P. Fraser, A. W. Smith, Jno. Kirker. The Warden addressed the Council as follows:---

THE WARDEN'S ADDRESS.

Gentlemen of the Municipal Council:

In assembling here at this, the last Annual Meeting of the Council as at present constituted, I trust you will so perform your duties as to merit the confidence and approval of your constituents. Our present financial position is fairly good, although some of the services for which we provided have exceeded the estimates. Chief among these are the Jury Fees. The Treasurer's Accounts, together with the Auditor's Report, will shortly be placed in your hands, and I hope will be found satisfactory, both as regards expenditure and balance.

You have to appoint your District Officers at this meeting, and I must once more impress upon you the importance of selecting permanent residents of the District and persons competent to perform the duties assigned to them, and thus endeavor to avoid making new appointments at the Semi-Annual Meeting. With the exception of two or three Districts the Assessments have been nearly all collected during the year just closed.

There is a question affecting to a large extent our Finances, which requires remedial legislation. I refer to the question of Jury Fees. Halifax being the Metropolitan County of the Province, and this city a commercial centre as well as the capital of the Province, as a natural consequence the number of lawsuits is yearly increasing and Juries increase proportionably, which causes a very large expenditure for Fees. Before the establishment of Municipal Incorporation, no cause, when a Jury was asked for, could be entered on the docket for trial until \$20 was paid by the litigant to the Prothonotary, to be by him paid over to the County Treasurer without deduction. This was amended by the Acts of 1879, chap. 19, sections 7 to 12, by reducing it to \$15, except for libel, slander, etc., when it remained at \$20 until 1883. On the revision of the Statutes in 1884 by some means unexplainable and without any legislation that I can find, Halifax County was deprived of all or any fees in civil actions, while other Counties were allowed \$6 in each case. This Council urged upon the present Attorney-General the necessity of making litigants pay the Jury Fees as formerly, or to give us some remedy, which he promised to do, but instead of returning to the old system, the Legislature swept away all fees from every County. (Chap. 106 of Juries, sec.

50, repealed by chap. 35, Acts 1887.) The County is therefore charged with the expense of court trials with regard to Jury attendance. There are Grand Juries, Petit Juries, Special Juries, and sometimes County Court Juries, all of which have to be paid out of the pockets of the taxpayers of. this County. There are often wealthy Corporations, Insurrance Companies, and men of large pecuniary means from outside Counties of the Province, and sometimes from outside the Province, who have cases here and demand Special Juries. For instance, during the last term of the Supreme Court there were four Special Juries empanelled. Any of the parties to these suits could have paid for these Juries, and yet the County, without receiving one cent of benefit therefrom, under the present law, was obliged to pay these Juries. Large as was our estimate (\$900) for Jury Fees last year, it has been greatly exceeded, and the amount increasing year by year. Why should this County be called upon to pay for Special or other Juries to determine causes brought to Halifax from distant parts of the Province. Every County in Nova Scotia should bring this matter to the notice of the Legislature, and insist upon such a change in the law as would relieve the Counties of this burden. I therefore recommend you to appoint a special Committee to wait upon the Government and urge upon them the necessity of relieving the taxpayers of this County of the burden thus placed upon them. Parties indulging in the luxury of law should certainly pay for it themselves.

You will appoint your Committees and arrange your meetings with as little delay as is consistent with the work before you.

I cannot conclude without referring to the late lamented death of Sir John Thompson, the Lawyer, Judge and Statesman, who in his day, and while residing in this city, was so closely identified with this Court House. He was one of the first Commissioners under the Act vesting this building in a commission. It was during his regime as Commissioner that this wing of the Court House and this room were constructed. Previous to that there was not a room in this building in which the County Council could meet. As some of you may remember, we were first organized in the old office of the Treasurer. It was in this Court House that J. S. D. Thompson first practiced at the Bar, and in this same building he presided as a Judge, with so much credit to himself and to the bench of which he was for a time 'an honored member. We therefore feel the more keenly his untimely end. The Address was received for publication as heretofore. On motion of Councillors C. E. Smith and Henley, W. H. Wiswell was reappointed County Clerk.

The minutes of final day of last session were read and confirmed. (See April 17th; 1894, minutes.)

Read applications for position of Chief County Constable from R. Burbridge; for Deputy County Constable, from E. Haverstock and D. Gorman; and County Constable, H. W. Wright; for Janitress of Court House; from Mrs. Sentell.

Some parts of the Warden's address were discussed, especially in regard to jury fees. It was moved by Councillor Hubley, seconded by Councillor Bartlett, and—

Besolved, That Councillors Taylor, Henley, Madill and the Warden be a Committee to wait upon the Government relative to the adoption of a better mode of dealing with jury fees. Paased.

The Clerk laid upon the table the Treasurer's abstract of Receipts and Expenditures for the year 1894, with the report and certificates of the County Auditors as to its correctness and balance in bank, \$7,808.09. On motion it was received and referred to the Finance Committee. The Treasurer said the Report was being printed.

Moved by Councillors Henley and McCallum, and-

Resolved, That the same Nominating Committee to appoint Standing Committees remain as last year.

In amendment by Councillors C. E. Smith and Bartlett-

Resolved, That the Nominating Committee to appoint the Standing Committees for the present year consist of Messrs. Hubley, Henley, Kerr, C. E. Smith, Taylor, Thompson and Sellars.

The amendment passed.

Councillor Henley referred to what appeared to be a doubtful point in the Statute in regard to the time within which District Officers should be sworn. He mentioned a case in the Stipendiary's Court where defendant's Counsel claimed that the officer's appointment was not legal, as he had not been sworn into office in ten days thereafter. He read section 50, chap 56, R. S., as shewing the lawyer's contention sustained.

The Clerk quoted section 52 same chapter as conflicting. A majority of the Council considered that the clause could not be construed to mean ten days from the date of notifying the person of his appointment. The clause could not be acted upon otherwise. cillor for District 16, as formerly (1880-93.) He strongly advocated this course. and was opposed by Councillor Donaldson, in whose District part of the road is located. The matter was laid over for future discussion.

Read, application from Albert W. Purcell for reappointment as Coroner's Constable for the City and County, accompanied by a letter, suggesting that the appointment of one man as Coroner's Constable would prevent disgraceful racing and wrangling over dead bodies, as has been witnessed in the past. This, he thought, was the only way to do away with such scenes. The Constable would be summoned in case of sudden death or deaths, under suspicious circumstances, and he would notify the nearest Coroner.

Read, an application from George Wilson for reappointment as a County Constable for this year.

On motion, he was appointed. Bond to be given, \$200. , Moved by Councillors C. E. Smith and Henley—

That the appointment of County Constables be deferred until to-morrow morning. Passed.

Moved by the same-

That the appointment of Janitor of the Court House be deferred until Saturday morning. Passed.

The Council adjourned to 2.30 P. M.

Afternoon Session.

TUESDAY, JANUARY 8TH, 1895.

The Council met at 2.30. Present the Warden and 28 Councillors. The Minutes of previous Session were read and adopted.

Submitted and read the Report of T. A. Chambers, Keeper of the County Jail, with Statistics of Commitments for the year 1894.

Also, Report of Dr. Trenaman, for reappointment.

": On motion of Councillors Bartlett and Donaldson- 1

That Dr. Thos. Trenaman be Surgeon for the County Jail for the current year at the usual salary. Passed. Read, Report of Inspector of Licenses, D. W. B. Reid, which was discussed. Mr. Reid gave some explanations and portions of the Statute were read respecting Licenses.

Read, a Petition from several persons in District No. 13, chiefly women, against granting License to Jas. Evans, giving reasons for their opposition to it.

Also from Clergymen of the city in support of the former petition and endorsing the views therein.

It was moved by Councillors Bartlett and Donaldson-

And Resolved, That James Evans be granted License to sell intoxicating Liquors for the current year, he having complied with the Law.

Read, the Report of James F. Turner, Superintendent of the County Poor Farm. Also, his Application for an increase of Salary to \$400.

On motion of Councillors Wilson and Fagan, the Report was received and referred to the Committee on Public Property to report upon, and then to be dealt with by the Council. Passed.

Read, a letter from Messrs. Kelso and Grindon, of Truro, asking, on account of their being Ratepayers within the Province, that the \$40 paid by them to the Clerk of License for a Pedler's License be returned to them.

A discussion followed on the subject of the status of applicants for such Licenses, and the By-Law passed last year was shown to be defective. The Clerk stated that the Lawas contained in chap. 26 (1894), secs. 1 and 2, would supersede the By-Law and authorize the Council to make the necessary emendation so required.

Moved by Councillors McMullen and Bartlett-

That the letter of Kelso and Grindon lie on the table. / Passed.

The Council adjourned to Wednesday at 10.30 A.M.

WEDNESDAY, JANUARY 9TH, 1895.

The Council met at 10.30. Present, the Warden and 27 Councillors. The Minutes of last meeting were read and adopted. Printed copies of the Treasurer's Accounts of Cash Receipts and Expenditures for 1894 were distributed among the Councillors.

Read, Applications from J. A. Gray and C. W. Gray, to be appointed Coroner's Constables.

The Warden referred to the proceedings of Coroners and their Constables in their rivalry to get possession of dead bodies. The appointment of one respectable man would prevent such indecent conduct as was reported last year. He cited the alleged body-snatching case at Undertaker Snow's premises, and hoped that a similar scene might never again occur in Halifax.

The applications were laid on the table.

The Committee to nominate Standing Committees reported as follows, and the Report was adopted :--

The Committee recommended that Councillor Sellars be associated with the Chairman of the Public Property Committee and visit the Poor Farm and Jail as often as convenient, he to receive one-half the remuneration paid the prevaious Chairman.

The Report was read clause by clause, and with the recommendation, adopted as a whole.

Councillor Thompson mentioned the death of Hon. S. La Shannon, Judge of Probate, who had for many years occupied his Court Room in the building. He moved, seconded by Councillor DonaldsonThat this Council adjourn till 3 o'clock to attend the funeral of the late Hon. S. L. Shannon.

Moved in amendment by Councillors Wilson and Fagan-

That members of the Council who desire to attend the funeral of the late Hon. S. L. Shannon shall be allowed to retire at 3 o'clock.

The amendment carried.

- The appointment of Constables was taken up and the applications handed in on Tuesday read.

For Deputy Chief Constable the ballot was taken for • Ephraim Haverstock and Daniel Gorman. The count showed 23 for Haverstock and 5 for Gorman. The former was elected and is to give the usual Bond (\$200.)

On motion, H. W. Wright was re-elected County Constable on same condition.

The Clerk referred to the appointment of Commissioners of the Court House, and read sections 1, 2 and 7 of the Acts of 1881, defining their powers and duties as a body corporate, which for the most part had been delegated to and fulfilled by him, entailing in addition to his onerous duties as Clerk and Treasurer the whole responsibility, care and worry of attending to these matters, which were a serious interference with his time and office work.

After some remarks by the Warden, it was resolved that the same Commissioners as proposed last year be continued. "The Warden referred to the extension of the Boundaries of Dartmouth, north and south, and Councillor Bissett said the Provincial Secretary had been seen, and had said the people concerned should be heard.

... Joseph Lloy, Custodian of the Draw Bridge in District 29, reported that the bridge is only in fair condition and wants some planking and repairs.

Stuart Innes, Custodian of the Draw Bridge in District 36, at Porter's Lake, reported that the bridge needs some repairs. Councillor Smith said repairs were now being made on the bridge by the Government. Both reports were received and referred to the District Councillors for further action as may be required.

Councillor Donaldson presented a petition from the residents of Bedford District against allowing Indian squatters to remain in a portion of the district, as their presence is detrimental to the public health. The matter was discussed but no special action taken for the present. The Clerk pointed out that the petition was addressed to the Board of Health for the District, who, as the Statute provides, could take the matter in hand.

Councillor McCallum mentioned a similar case in his District. To remedy the nuisance he had applied to the Dominion Agent for the Indians, who effected the desired result.

Councillor Donaldson related what had been attempted in the case, so far without success. He enquired where or how necessary funds were to be provided for further action. The Warden said the Statute showed that all legitimate expenses in connection with Public Health matters would be met by the County.

The Petition from the residents of Hammonds Plains, relative to the Kearney Road was again taken up, and a lengthy discussion held thereon. The petition was strongly opposed by Councillor Donaldson, whose district a portion of the road is in. The petition was referred to be discussed in the afternoon.

Councillor Taylor requested the Special Committee on Juries to meet at 3.15 P. M., and proceed to the Provincial Secretary's office to confer on the matter with him.

The Council then adjourned to 2 o'clock, P. M.

Afternoon Session.

WEDNESDAY, JANUABY 9TH, 1895.

The Council met at 2 o'clock. Present, the Warden and 30 Councillors, including the absentees who had been detained by bad roads. The Minutes of the Morning Session were read and approved.

The discussion of the Hammonds Plains Petition was resumed by Councillor Thompson, who contended that the former action of the Council in 1880, and the By-Laws relating to Roads established his claim to appoint the Overseer for the Section.

Councillor Donaldson said he had not asked the residents of District 15 to sign a Petition, but was certain the ratepayers did not desire the course proposed by Councillor Thompson. It was an encroachment on privileges of the Councillor of District 15, as well as establishing a bad precedent. He had last year conceded the point to Councillor Thompson, on condition that money to the extent of \$70 be expended on the Section, as he had a much smaller sum to lay out on it. The whole Section had been under the control of the Councillor for District 16 for over 12 years, and yet it was none the better of such supervision, etc. After further debate, it was finally referred to the Road and Bridge Committee.

It was moved by Councillors Henley and C. E. Smith-

That the Resolution passed last year with reference to Pedlers and Hawkers be amended by expunging the word "Province" and substituting therefor the word "County." Passed.

The Warden requested Councillors to prepare carefully their Lists of Officers, to be handed in and passed on Saturday next.

In order to enable Councillors to attend Hon. Mr. Shannon's funeral, and Committees to begin their Reports, the Council adjourned to Thursday morning at 10.30.

THIRD DAY.

THURSDAY, JANUARY 10TH, 1895.

The Council met at 10.30. Present, the Warden and 29 Councillors. The Minutes of previous meeting were read and accepted.

Read, Reports of Board of Health for District 15 for 1894. The health of the inhabitants had been good, but was endangered by the continued bad drainage from the Mount St. Vincent and McDonald properties, mentioned in last Report, and later by the filthy habits of the Indian encampment, referred to in the Petition submitted to the Council.

Councillor Donaldson said that as the Indians had squatted on lands owned by the Catholic Church application had been made to the Archbishop to have them removed elsewhere.

Councillors Wilson and McCallum recommended that Father O'Sullivan be applied to and he would have their removal to the Indian reserve effected.

- Read a petition from Andrew O'Rourke, District No. 35, referring to obstructions caused by one Ogilvie on a portion of road in that District, not having been removed in accordCouncillor McMullen gave information as to the action taken by the Council. The Committee appointed to remedy the trouble and see that the road was cleared to the proper width had not done what was required.

On motion of Councillors McMullen and Bissett, it was referred to the Road and Bridge Committee.

The Clerk submitted the proclamation of the Lt.-Governor summoning the Legislature for 31st January, and referring to the Councillors' election in November-mentioned that the Council in preparing the bye-laws had made no regulations respecting such elections. Difficulties had arisen in regard to polling places and presiding officers' proceedings. In the absence of any instructions, the Statute authorized the Clerk to proceed as in the case of County members.

It was moved by Councillors Wilson and Fagan-

That this Council shall have power to define the place at or near which the Municipal elections shall be held in the several districts, and when such locality is defined in any district it shall remain the permanent polling place until further changed by the Council. Passed.

Moved by Councillors Donaldson and Kerr-

That Albert Tolson be appointed a County Constable. Passed.

By Councillors Donaldson and McCallum-

That Reuben C. Purcell be appointed a County Constable, Passed.

The following matters in connection with Roads were submitted and disposed of, viz.:--

Read, a Petition from 31 ratepayers in District 19 for a road to be laid out from Antrim Road at George Grono's leading in a westerly course to Elmsdale Road at Oliver Simpson's, 2881 chains, &c.

Moved by Councillors Madill and Bartlett-

That the Road from Antrim at George Grono's, joining the Dutch Settlement road at Oliver Simpson's, be formed into one Road Section, No. 19, Passed.

Read, Report of James Foley on changes in Road leading down East Jeddore one quarter of a mile from middle road to the road back of H. Corkum's, westerly around the hill to main road. The same was approved by P. W. Maskell and Enos Baker, J. P.'s, District 27.

Read Report of Committee on Precept for a short Road

between Gay's River and Milford Station, stating they had examined the line of Road between Gay's River and McPhee's Hill and consider the new road from Jno. Merson's to Annand's Mill no improvement, and no chance round McPhee's Hill along the river for any road, and they recommended a line from McPhee's Hill crossing Gay's River till it strikes the Coach Road near Bennett's Mills.

Moved by Councillors Burris and Taylor-

That we accept the report of Committee from District 19 condemning the line suggested for the road from Merson's to the foot of McPhee's Hill, along the side of the hill near the river. Passed.

Moved by Councillors Madill and Bartlett-

 $^{\xi}$ That the Clerk be authorized to assess on District 19 \$4.50 to pay the Committee for looking out the foregoing line of Road. Passed.

Read Report of Committee with return of precept for a road from the Post Road to the head waters of Salmon River, District 27, to Indian Landing, 11 miles. The owners making no claim for the land it traverses, they consider said road can be made at small expense.

Moved by Councillors Myers and C. E. Smith-

That the precept relating to change of road in District 27, and report of Committee thereon, be received and adopted. Passed.

Read, a Petition from Ira Dean, also endorsed by a number of residents of District 22, for leave to do 3 days of his Statute labor on his private road.

On motion, the matter was referred to the District Councillor.

Read. Report of Committee on Precept issued last year for a Road from Soward Road to new Cole Harbour Road in District 33, with a plan of the same, and giving their valuations of the land it would go through, and cost of fencing, amounting in all to \$90.25, for Peter DeYoung, R. Fraser, Jno. Himelman and Wm. Himelman.

Councillor Conrod explained that the road was much needed, but had not been undertaken from the difficulty of settling with the owners of the land through which it passes, more especially DeYoung, whose land was cultivated. The only way now was to follow the provisions of the Statute, and let the matter be settled by arbitrators. The suggestion was approved by the Council as the only recourse, if the road is to be made.

The Clerk reported that he had not received any more

Returns of Measurements of Roads and Bridges since those of last year were sent in.

SPECIAL REPORT OF FINANCE COMMITTEE ON THE REPORT OF THE INSPECTOR OF LICENSE.

From the Inspector's Report we obtain the following summary :-

There were 49 prosecutions, ten of which failed to convict. Of the 39 convictions only 24 were successful in collecting the fines, or partial fines, the remaining 15 being classed as "committed to jail, dead, appealed, left the country, nothing to ge!, etc., while some convictions obtained near the end of the year will probably be collected and estimated by the Inspector at about \$250.00.

Your Committee offer no objections to the individual prices charged, presuming they were actual costs, and as a whole appears above criticism.

We may, however, remind you that the office is far from self-sustaining, as the account of the Treasurer shows \$421.91 paid out above receipts previous to 1894, in our efforts to keep the people temperate, and we are now confronted with another shortage of \$279.36, and a deficit in the current year would appear inevitable, as we will get but \$130.00 from Licenses as against \$480.00 in 1894. Hence, it becomes the Council to consider if the service In view of which, your Committee cannot be made more economical. would refer to the item of \$126.00 for legal services, which appear as exclusively in the Stipendiary's Court in the city, whence it is pertinent to enquire if justice and the law could not be just as efficiently and more cheaply administered if the prosecutions were brought before the local Magistrates where the offence occurs, and away from the expensive and distracting influence of the Lawyers, and where the costs involved would be materially less as evidence the large sum of \$343.05 for expenses of court, and where in the Stipendiary's court the costs average over \$13.00 per trial, as against some \$6.00 to \$9.00 in the County Magistrate's court.

The amount of travelling to be done must necessarily be left largely to the judgment of the Inspector. By reference to the location of the offences, it appears that about 80 per cent. of them occur from 5 to 25 miles from the city, and the great mass of duty requires to be administered from the city, and an Inspector residing in this vicinity would have considerably reduced this item of \$439.40 for the past year. The item of \$66.24 for Constables services is for work outside of direct prosecutions, and for duties within short distances from the city, but your Committee are not prepared to give an opinion of how much of this might have been saved if the Inspector had been more centrally located.

Of a number of the fines imposed and not collected, your Committeo, while offering no suggestion, are of the opinion that an attempt to collect would result in increased expense to the County for arrest and imprisonment, with but very meagre prospect of collecting anything.

The estimate for last year (as was reported to be the case for 1893) was insufficient to meet these amounts. Your Committee regret to notice this increase, but as it is inevitable, and cannnot be obviated as far as they know, the burden of maintaining pauper insane has to be borne and provided for. • The Clerk and Treasurer has collected from friends of insane, as shown in his account, \$126, and expects to secure a much greater sum in 1895, but the great majority of those who have to be sent to Mount Hope enter there as paupers. Once admitted to the Hospital, the chances of their relatives or friends contributing the smallest trifle toward their maintenance or comfort are hopeless.

There have been no transfers during the past 12 months of harmless patients to the Poor Farm. Your Committee are of opinion that there may be some of the inmates at present whose condition might admit of their removal; but, as it is the province of the Medical Superintendent to determine or recommend this course officially, it might be well for the Committee on Public Property to press the matter and possibly affect a reduction of our obligations to the Government.

Your Committee, as at former times, consider that the expenses of clothing and extras could be lessened, as in comparison with those at the Poor Farm they seem greater than need be, but how to accomplish this result is not very clear.

The following statistics are made up to the present time, and form a necessary terminal to this report:

REPORT OF THE PHYSICIAN TO THE COUNTY JAIL FOR THE YEAR ENDING DEC. 31st, 1894.

HALIFAX, N. S., JANUARY 5TH, 1895.

To His Honor the Warden and the Councillors of the Municipality of Halifax County.

GENTLEMEN,---

I beg to report as follows on the sanitary condition of the County Jail and its innates for the year just ended :

Nothing of an unusual character, in a professional way, has happened, and I have no cases of severe sickness to chronicle.

There was about the customary number of insane persons—six in all committed during the year. Of these, two were sent to Mount Hope and one to the insane wards of the City Poors' Asylum; two were handed over to the Civic Police authorities for disposal by them, and one to the agents of the S. S. Halifax for return to the United States under the terms of the Act providing against nauper immigration.

Act providing against pauper immigration. It is a matter of much satisfaction and for congratulation that the number of those committed to jail for drunkeness was lessened to nearly one half that of the previous year. It is perhaps not easy to point out all the causes of this pleasing diminution, but as several of those who have been regular visitors to us in the past were, during the year, subjects for treatment at the Gold Cure Institute, we can safely credit, I think, that institution with some of the good done, and hope that the result may be a permanent one. All of the cases of drunkenness needed treatment to some extent, but in only one instance was it deemed expedient to remove the patient to hospital for more careful nursing.

patient to hospital for more careful nursing. The sanitary condition of the juil building is good, and its surroundings have been neatly and cleanly kept. The wards, cells, and corridors are regularly lime-washed, scrubbed and well aired, and the health of the Disopers, as a whole, has been maintained in a good condition.

The Jailor and Mrs. Chambers and the Turnkey have been mindful of the wants of the sick prisoners and considerate in their attentions to them. I have examined the food supplied from time to time, and have found it of good quality and well cooked.

REPORT OF THE COMMITTEE ON PUBLIC PROPERTY.

1.—The Committee in presenting their report would refer to the Jailor and Surgeon's Reports on the County Prison, from which it appears that the past year has been one of fair results in that Institution.

2.—The expenditure for the maintenance and repairs of the Jail has been kept as low as possible, with a view to the preservation of the building.

3.—There has been a new fence built on the south side of the Jail yard, costing \$289. Also, a new cooking range for kitchen, costing \$60.

4.—I'he Poors' Farm has been conducted with fair success the present year.

5.—The bills for the present year for food, clothing, bedding, repairs, painting the in-side of the building throughout and papering the hall and three rooms, and wages, including the Keeper and Matron, and Doctor's pay, stoves, for the furnaces, for the year, amounts to \$4,097.90; for 31,031 weeks of inmates for the year 1894. Three has also been paid bills for 1893, amounting to \$29, the payment for which we had balance in favour of the Institution Dec. 31st, 1893, \$66.09.

6.—The sum given, viz., \$4,097.90, does rot include the \$300 instalment for repayment of debentures and interest thereon, but the sum saved by keeping the harmless insane at the Poors Farm, viz., \$1,082 less than it would cost at Mount Hope, will more than pay the instalments and interest thereon.

7.-The cultivated ground has been largely extended in the past year.

8.—There was grown on the Farm during the year 200 bushels of sound potatoes, more than half the crop having rotted in the ground; 250 bushels turnips, 10 bushels carrots, 5 bushels beets, 8 tons hay, 2 tons of oats for fodder. For other produce see keeper's report.

There are 69 inmates at the Institution now, consisting of 20 insane . and 49 sane Paupers.

We recommend that Mr. and Mrs. Turner be reappointed Keeper and 'Matron for the present year.

REPORT OF COMMITTEE ON LAW AMENDMENTS.

Your Committee respectfully recommend-

1.—That our By-Laws in regard to Licensing of Pedlars and Hawkers of Goods be amended by adding the following as a sub-section to section 1 of the By-Laws passed last year in relation to this subject :--

That all Pedlars and Hawkers of Goods being Ratepayers within the Province, but not being Ratepayers within the County, shall be required to obtain a license therefor, the fees to be paid being for a team Twenty Dollars, and for a pack Ten Dollars. Subject to the same penalties and liable to the same procedure as laid down in foregoing and following sections of said By-Law. 2.—We would also recommend that all Pedlars and Hawkers being Ratepayers within the County shall, before offering their wares, be required to obtain a certificate countersigned by the County Clerk, certifying to the fact of their being Patepayers within this County, which certificate they shall be required to exhibit when demand is made by any Ratepayer to whom they may offer their goods for sale.

3.—That all such licenses and certificates shall require to be renewed annually.

4.—That the above regulations shall not apply to or affect the sale of the products of the farm, the forest or the sea.

5.—That all By-Laws inconsistent with the foregoing be hereby repealed. And in the case of District Officers, we would recommend the following :—

That any person appointed to an office in this Municipality (he being competent to perform the duties of such office) who shall neglect or refuse to be duly sworn in or otherwise qualified, or refuse to perform the duties of such office, shall, upon such neglect or refusal, forfeit a sum of not less than Eight nor more than Twenty Dollare, excepting in such cases as are specially provided for by the existing Statute or By-Law.

REPORT OF THE KEEPER OF THE COUNTY JAIL 1894.

For the year beginning January 1st and ending Dec. 31st, 1894, there were -Criminals, 163; Debtors, 49, showing a decrease of 82 Criminals and 1 Debtor, from 1893. At the present time there are 8 Criminals and 1 Debtor in the Jail.

The largest number of Prisoners confined at one time in the Jail during the year was 19. There were quite a number of Prisoners committed in 1893 who were not

discharged until 1894, and one is still in the Jail.

Annexed are statements showing the various crimes for which Prisoners were committed during the year.

The amount of monies received for boarding Merchant Sailors and Room Rent is \$4.60, the Room Rent being small on account of the "Debtor's Act" abolishing imprisonment for debt, and very few deserters among Merchant Sailors.

The sanitary condition of the Jail has been generally good and little sickness, excepting those committed temporarily from the City Court, of which there were

for drunkenness 13, and insanity 6, during the year. The fence on the south side of the Jail next to the Lieutenant Governor's garden was completed by the contractor in October, and is a good substantial structure; but the rest of the fences are much dilapidated, and may be blown down by any storm, especially that on the east side. The conduct of the prisoners during the year was generally good.

MUNICIPALITY OF HALIFAX COUNTY.

THIRD SEMI-ANNUAL MEETING

OF THE

EIGHTH MUNICIPAL COUNCIL.

FIRST DAY.

HALIFAX, WEDNESDAY, APRIL 3RD, 1895.

In accordance with adjournment and special notices, the County Council assembled at the Court House at 11 o'clock this day, the Warden and 29 Councillors attending.

The Warden addressed the meeting as follows :---

THE WARDEN'S ADDRESS.

Gentlemen of the Municipal Council:

I am pleased to again welcome you to the scene of your municipal labors. There is nothing special, beyond the division of the road grant, that I know of at present to engage your attention. This, as you know, is the last meet-ing of this Council as at present constituted, and as you all have to give an account of your stewardship, before the end of the year, I hope that any of you who may ask your constituents for a renewal of their confidence, may be successful in the highest degree. I regret to inform you that the question of Jury fees, notwithstanding the urgent requests we made to the Government and Legislature, remains as it was the past few years, and this County will still have to bear the burden of being taxed to pay the Jury fees of litigants, from without as well as within the County. This question does not affect the other Counties of the Province to the same extent that it does this County. They have very few Jury cases, nearly all of their lawsuits are settled without Juries. When cases requiring Special Juries come

up, they are generally brought to Halifax, thereby throwing the burden of paying those fees on this County. This is one reason why the County members take so little interest in this matter. Any alteration in the Jury Law as it stands at present is strenuously opposed by all the lawyers in the Legislature, upon the ground that it comes hard on the poor litigant. They don't consider the poor taxpayer. It also has a tendency to encourage lawsuits, which is certainly good for the lawyers. Referring to the Coroner question, I may say that I believe the new law respecting Coroners that passed the last session of the Legislature, is a great improvement on the old system, and should commend itself to the citizens of Halifax and Town of Dartmouth, and be extended to the whole Province. The road grant is about the same as last year. I trust you will make a judicious division, and in accordance with the requirements of the various localities of the County. You have at this meeting to appoint Electoral Revisors, which I hope you will do with a due regard to the best interests of the electorate, and free from any political considerations.

The address was received to be printed in the Minutes of the Session.

The Clerk read the Minutes of last day in the January Session, which were confirmed. He also submitted a copy of the New Law relating to Inquests within the City and Dartmouth, and mentioned that Dr. W. D. Finn had been appointed by the Government as sole Medical Examiner under the provisions of the Act. Outside the City and Town the Inquests, where necessary, would be under the Statute for Coroners (Chap. 17, R. S.) The new law would be a great improvement, and effect a large saving of expense.

Submitted also a copy of the Law proposed for amendment of the Jury system. The Clerk had advocated the abolition of Special Juries and other amendments to Chap. 106 R. S. before the Law Committee of the House. Some of these had passed, but the principal matter asked for was set aside.

Submitted a number of Pamphlets and illustrated Catalogues of Road Machines and Rock Crushers from different manufacturers.

A discussion followed in connection with these as to the advisability of the County purchasing such implements. A law had passed the Legislature by which the Warden, with the approval of the Council, may enter into an agreement for the purchase of Road Machines, the cost to be paid by instalments out of the Road and Bridge Grants of the County, or a Councillor or Councillors, with the approval of the Warden, may do likewise, and the sums due to any persons under agreement for such machines, shall be a charge upon the Road and Bridge moneys of the District.

Councillor Taylor reported his practical experience of the use and value in road-making of the machine supplied by the Government last year. It proved to be very efficient and economical, saving a great deal of labor and doing excellent work. These machines could be used much more extensively than supposed and prove a great saving of labor and expense while doing the required work much better. Some Councillors were in favor of Rock Crushers as being more suitable to the requirements of their localities, but the heavy cost was the great objection. It was suggested that the cost of either kind could be paid by instalments out of the District Grants for Roads.

The Clerk submitted the official statement of the Government Grant for Roads and Bridges, 1895, for Halifax County, as being \$12,433.00, less annual interest on Bridge advances \$2,844.67, leaving the net amount to be divided \$9,588.33. Comparing this with last year shewed a decrease of \$210.17, on account of the interest being greater than 1894.

Councillor Henley complained of the manner in which a certain road in his district leading to gold mines and opened by the Mining Companies, had been constructed. It had been tunnelled and undermined so as to fall in from the surface and so left by the original parties. He was unwilling to spend his road grant on it, and on applying to the Inspector of Mines, had received a letter from him referring to clause 14 of chapter 47 R. 1 S. which did not apply to the case. He desired a Committee to call on the Commissioner of Works and Mines and get some redress for the grievance.

Councillor Conrod submitted the Report of the three arbitrators appointed to settle the disputed costs for right-of-way reported in connection with the proposed Soward road in District 33 last year.

Moved by Councillors Bissett and McMullen-

That \$125 be assessed on District 31 for support of Poor for the present year. Passed.

Read, an application from Joseph Grant, District 31, to be appointed a County Constable.

On motion, the request was ordered to lie on the table. The Council then adjourned to 2.30 P. M.

Read, a letter from the Inspector of Mines, in re a Road to Mines in District 26, giving section 14 of chapter 47 as the remedy for the sinking of the surface.

Moved by Councillor Henley, seconded by Councillor Thomson, and

Resolved, That a Committee be appointed to interview the Inspector of Mines with reference to a certain piece of road in Tangier, said road being new in a dangerous condition on account of gold mining operations there.

Councillor Henley pointed out that the reference made by Inspector Gilpin did not apply to this case, that former workers of the mine had tunnelled under the road and had now left the mines without making it substantial. He considered that the Government was the proper party to make the roadway safe and reliable. The motion passed.

The matter of appointment of Janitor of the Court House was discussed. It was decided that a Janitor is necessary to meet the requirements of care and protection of the building and offices, and that the appointment was rightly vested in the Commissioners.

It was moved by Councillors Bissett and McMullen-

Whereas, There are several applications for Janitorship of the Court House, Resolved, That this Council leave the appointment to be made by the Commissioners of the Court House, it being their opinion that it is the duty of said Commissioners to make such appointment, and also that they investigate the eligibility of the various applicants, Passed.

Read, the Report of the Arbitrators appointed in connection with Precept for the Soward Read—to decide the amount to be allotted the owners of lands through which the right-of-way was required. They confirmed the values previously fixed by the Committee to lay out the road. Moved by Councillors Conrod and Henley—

That the Report of the Arbitrators on the road in District 33 lie on the -table until the parties who petitioned for it pay the right-of-way, according to agreement. Passed.

Moved by Councillors Conrod and Umlah-

That the sum of Three Dollars be assessed on District 33 to pay the Arbitrators on new road in that District. Passed.

On motion of Councillors Bartlett and Taylor-

"The sum of Fifteen Dollars be assessed on District 23 for support of the Post for 1895." Passed. Read the Petition from Henry Howell, of the St. Elmo Hotel, District 15, deferred from the January meeting, asking for a refund of the License fees, \$150, paid by him to Inspector Reid for 1895. The Council had assented to and granted the License, but he had been summoned into Court and deprived of the License, which was declared to be illegal on account of proximity to the Railway. In addition to costs in the suit, his business was destroyed and had to be closed.

A protracted debate followed, and it was then moved by Councillor Donaldson, seconded by Councillor Bartlett—

That the sum of \$150 be refunded Henry Howell for License granted in January, 1894, but which was afterwards proved by the Supreme Court to be illegal.

Moved in amendment by Councillors C. E. Smith and Henley—

That the sum of Seventy-Five Dollars be refunded Howell in consideration of unexpired License."

On being put, the amendment passed.

The Council adjourned to Thursday morning at 10.30.

SECOND DAY.

THURSDAY, APRIL 4TH, 1895.

The Council met at 10.30 A. M. Present, the Warden and 30 Councillors. The Minutes of last meeting were read and accepted.

Moved by Councillor Myers, seconded by Councillor Hayes-

That the Municipal Election in District 27 be held at the School House at or near Mitchell's Mills, Jeddore. Passed.

Benjamin Smith was appointed Constable in District No. 9, in place of Wm. Henneberry.

In District 27 Benjamin Day was appointed Overseer Statute Labor, instead of D. Blakeney, over age; and Azariah Weeks, Overseer of Statute Labor in place of Louis Hill.

On motion of Councillors McMullen and Bissett, five dollars was assessed for support of poor in District 35. On motion of Councillors Fraser and Bissett-

Resolved, That the sum of \$300 be assessed on District 25 for support of poor for present year. Passed.

Frank Thompson was appointed District Clerk for District No. 16.

Read a petition from a number of the ratepayers of District No. 15 asking for an increase in the Road Grant for that district, as the roads, being traversed by the people of adjoining counties and districts and of the city, are being rapidly worn out, and a stone crusher is necessary to the work of renovation.

Referred to Road and Bridge Committee.

Read a petition from inhabitants of District 28 for a special grant of \$75 to repair Canterbury Draw Bridge. Referred to Road and Bridge Committee.

Read petition from District 29 stating the bad condition of the roads about Porter's Lake, and asking special extra grant to put them in satisfactory repair, &c. Referred to Road and Bridge Committee.

Read Report of Health District No. 20, which showed there had been no epidemic, and the general sanitary state was satisfactory.

The Clerk read the Hon. Provincial Secretary's circular calling attention to the law relating to the mode of apportioning the Road and Bridge Grant, and fixing the price for labor, teams, &c.

Also read Sections No. 2 and 3, chap. 46, relating thereto, and Section 10 as to the returns of expenditure in duplicate. Moved by Councillors Bartlett and Burris, and—

Resolved, That the money appropriated by the Government for the Road and Bridge service for the year 1895 be expended by Commissioners. Passed.

THIRD DAY.

FRIDAY MORNING, APRIL 5TH, 1895.

The Council met at 10.30 A. M. Present, the Warden and 29 Councillors. The minutes of Thursday were read and passed.

Read a petition from 30 inhabitants of West Chezzetcook (District 28) asking for a precept to lay out a new road in Section 10 between the Main Road and Middle Section Road, from a point near Canterbury Bridge.

Moved by Councillors Lapierre and Wilson-

That a precept be granted to lay out a road in District 28, in accordance with the prayer of petition, and that John Conrod, Lawrence Belfontaine and Stephen Lapierre, be a Committee to lay out the same. Passed.

Read an application from Chas. McGinn, Crier of the County Court, asking for an increase of Salary in consequence of the large amount of duty imposed on him by the number of Criminal Cases transferred to that Court.

Read, in connection therewith, a letter from Judge Johnson in support of the application, and that the salary be altogether \$350, the present salary being only \$200.

Councillor Thomson and others were opposed to any further increase of salaries, as opening the way to unnecessary expenditure. It was moved by Councillors Bartlett and Burris that

This Council augment the salary of Charles McGinn, Crier of the County Court, by \$100 and no fees to be paid.

Moved in amendment by Councillors Thompson and Conrod-

That the salary of Crier McGinn remain as it is.

The amendment was put and carried. Councillor Bartlett, seconded by Councillor Donaldson-

That the decision arrived at in re application of Charles McGinn for increase of salary be re-considered. Adopted.

Councillor Bissett gave some statistics in connection with the Poor Farm expenses, which had increased in past two years. The cost of food and clothing, and not counting wages, was about \$1.03 per week. The present charge for Paupers was too low, and it might be advisable for the Council to increase the Dartmouth rate.

Moved by Councillors Wilson and Fagan-

• That the prices charged for Dartmouth inmates at the Poors Farm remain as now for the present year. Passed.

Councillor Burris referred to Auctioneers' Licenses, and enquired as to whether there was any modification of the Act or By-Law respecting them, and the cost if any.

The By-Law was referred to and read, showing the charge to be two dollars under certain conditions, but exempting products of the sea, mine and forest. Also persons selling their own products, etc.

The subject of Measurements of Roads and Bridges was very fully aired. Councillor Henley, Chairman of Road and Bridge Committee, stated the failure of several Councillors to make the returns; and also that some of those received were not correct, being over-stated.

Councillor Fraser and several others rebutted the statements. Explanations were also made by Councillors Thomson, Burns, Bartlett, Conrod, Kirker, Bissett, Taylor, McMullen, and others. The Tabulated Returns so far as had been received, were submitted and referred to be acted on by the Road and Bridge Committee at discretion.

Read a petition very numerously signed by ratepayers of District No. 15, against permitting the appointment by District 16 of an Overseer of that portion of the Kearney Road within said District 15. Referred to Road and Bridge Committee.

On motion, Harry Brown was appointed a Constable for this year in District No. 30.

The Council adjourned to 10.30 A. M. Saturday.

FOURTH DAY.

SATURDAY, APRIL 6TH, 1895.

The Council met at 10.30. Present, the Warden and 30 Councillors. The Minutes of yesterday were confirmed. Reconsideration of action with regard to salary of Crier McGinn was brought up by Councillor Bartlett, who subse Read, a letter from Judge Johnson, stating the requirements of the County Court as very largely increased, and that McGinn, in consequence, had to attend almost continuously; that the Criminal side was a district Court, for which a Crier was imperatively needed; and that should the efficiency of the Court be impaired by the Council's action, they would be responsible and not the Judge. That the Crier would be entitled to fees to pay for taking charge of property in certain cases coming before the Court. The Treasurer had refused these, on the ground that he had no authority to pay them. The transfer of the numerous Criminal cases to the County Court saved the County a large amount of expenses, and the officer had been very poorly remunerated for his services in the past, and was fully entitled to the increase named in letter of 5th inst., etc.

On motion, the consideration of the letter and subject was deferred to Monday morning.

The Warden submitted an application, which was endorsed by Judge Henry, for an increase of salary of J. W. Watt, one of the Criers of the Supreme Court, on the ground that, from the greater number of days' attendance than formerly, he was unable to do any outside work, and the salary was insufficient. After discussion it was moved that there be no increase on present salary. Passed.

Councillor Henley, Chairman of Road and Bridge Committee, said they had difficulty in obtaining accurate information upon which to distribute the grant, and wished to know about pent roads, whether they were included.

The Statute was read—Chap. 45, Sections 15 and 16 relating to Pent Roads, from which it is shown that the Council has the control of them, and that the Government Grant is intended for public highways and post roads, not for by or pent roads.

Read a memorial from Overseers of Poor District 30 opposing the claim for support of Harriet Smith, of Preston, since deceased, stating that she had been placed there without their knowledge and consent, and was not a pauper, but had property now in possession of her son. Referred to Committee on Poor.

The Council adjourned to Monday, at 10 o'clock.

FIFTH DAY.

MONDAY, APRIL 8TH, 1895.

The Council met at 10 A. M. The Warden and 30 Councillors present. Yesterday's minutes were read and adopted.

On motion of Councillors Bissett and McMullen, H. Tuffts was appointed Overseer of Poor in District 31, in place of Henry Lethbridge, resigned.

Councillor Kerr proposed to place a requisition for a new bridge at Lake View, near Rocky Lake, District 17, under the Bridge Act. Seconded by Councillor Lapierre. Councillor Wilson objected, as the Bridge would only accommodate a few people and could be deferred. He was desirous for some time past to have the bridge at Enfield made substantial, as it accommodated the great body of people from Hants and elsewhere, and must be kept up as being of much greater importance, and would cost a large amount.

The resolution was put and lost.

The condition of the Bedford Road was referred to by Councillor' Donaldson, who moved the following resolution, which was seconded by Councillor McCallum and passed :--

Whereas, it is proposed by a number of persons residing in the City of Halifar and along the Bedford Road to raise a sum of money for the improvement of said

Road, provided the expenditure thereof can be placed in commission. Therefore Resolved, That the Warden and Councillors for the Districts through which the Road passes, upon being satisfied that a sum not less than (\$500) First Hundred Dollars for that purpose has been raised, may entrust the maintenance of the Road from the City of Halifax to Sackville Bridge on said Bedford Road to a Board of Commissioners, one to be the Provincial Engineer or a person 100 a Board of Commissioners, one to be the Provincial Engineer or a person named or appointed by him, one to be elected by the Ratepayers, two to be mem-bers of the Ramblers Cycle Club, to be elected by the Club, together with the Councillors for Districts No. 14 and 15 The Commissioners by majority to have power to expend all monies, County money, Commutation money, sums raised by subscription, voted by County or City Council, by Government, by Ramblers Club, or raised by any other means. The Commission to hold at least one meeting a year, at which a Treasurer and Secretary must be elected.

Read, the Report of Committee on charges against Daniel McCabe, of District 17, which, on motion, was received and passed. 机化合物 化化合金

Afternoon Session.

MONDAY, APRIL 8TH, 1895.

The Council met at 2.30 P. M. Present, the Warden and 30 Councillors. Minutes of previous Session were read and accepted.

The letter from Judge Johnson was again read relating to the refusal of the Council to add to Salary of his Crier, C. McGinn. After consideration, it was moved by Councillors Bartlett and Burris—

That as a matter of economy, the Salary of Chas. McGinn, Crier of the County Court, be increased by One Hundred Dollars. All Fees to be retained by the County. Also, that those lately received by Mr. McGinn from the County be returned. Passed.

On motion of Councillors Donaldson and Bartlett-

James Rolfe was appointed Overseer of Roads in District 15, instead of Andrew Archibald.

Moved by Councillors Conrod and Henley-

That the Application of J. W. Watt be re-considered. Passed.

Moved by Councillors Henley and McCallum-

That J. W. Watt's Salary as Crier of Supreme Court be increased \$100 this; year. Passed.

Councillor Kirker, Chairman, presented the Report and Statistics of Poor for the year 1894, which was read in detail, and passed.

Councillor Bartlett referred to the application of Henry Hanson, Senior Crier of the Supreme Court, who considered that he was fully entitled to an increase of salary as Mr. Watt, on account of longer service and for some years a smaller salary. He moved, seconded by Councillor Donaldson-

That the application of H. Hanson be re-considered, and that his salary as Senior Crier be increased One Hundred Dollars.

The matter was debated for some time, and it was stated that Hanson received Court fees also. The motion was therefore rejected.

The Report of the Committee on Assessments, with a statement of deficits on Collections, 1894, was presented by

the Chairman, Councillor Madill. The Report and statement of deficits in Districts was read in detail, discussed and passed as a whole.

Councillor Henley submitted the Report of Committee on Roads and Bridges for 1894-5. It was read clause by clause. Also, the schedule of allotments to the several Districts of the Grant for 1895. The Chairman explained the basis upon which the money was distributed, and commented strongly on the continued neglect of several Councillors to report proper measurements of their District Roads and Bridges.

The Report on motion passed as a whole.

Moved by Councillors McMullen and Bissett-

That the Chairman of the Road and Bridge Committee hand in a list of the measurements of the Roads and Bridges to the Clerk; the same to be kept on file for future reference. Passed.

Moved by Councillors Donaldson and McCallum-

 $\vec{\gamma}$. That the Councillors be paid \$2.00 per day for attendance during the April session, with the usual travelling fees. Passed.

Moved by Councillors Burris and McMullen-

That the necessary number of copies of the minutes be printed and distributed among the Councillors. Passed.

A unanimous vote of thanks was passed to His Honor the Warden for his able and satisfactory management of the business of the session and conduct in the chair.

The Warden replied very courteously, and hoped to meet all the gentlemen who intended to offer for re-election at the next meeting of Council.

The Deputy-Warden took the chair, when it was moved by Councillor J. H. Taylor and—

Resolved, That the hearty thanks of this Council be tendered to our worthy Clerk and Treasurer, W. H. Wiswell. Passed unanimously.

. The Clerk thanked the Council very warmly for their kind expression of feeling respecting him. The Council then adjourned sine die.

REPORTS.

REPORT OF COMMITTEE ON POOR.

The Committee on Poor beg to report as follows :---

1.—It is the opinion of your Committee that the attending Physician be empowered and instructed to report monthly all temporary inmates fit to be discharged. On receipt of this Report, which should be made at a stated date in each month, the Superintendent should at once notify the Councillor or some Overseer of the Poor in the District responsible. On receiving an answer to this notice with authority for discharging from the Overseers of the District and a guarantee that the party to be discharged will not return at once to the City or the Farm, the Pauper can be then discharged. In the case of lying in the Overseers should furnish satisfactory information as to the disposal of the infant.

2.—Under the last amendment to the Poor Act, the Treasurer of a Municipality has to pay for the expense of a transient Pauper at the City or any other Poor Asylum and collect the amount, and the expense of removal of said Pauper from the District where he or she is shown to have a settlement. Under this enactment two Paupers from District 11, Halifax County, were paid for a year since and demand made by the Treasurer upon the Overseers of Poor of that District, who refuse to pay, repudiating the settlement. Suit has been brought to recover the amount from District 11, and the decision of the Stipendiary's Court was against the District. The Overseers of the District have appealed the case to the County Court. The Treasurer is consequently not in a position in the estimates of last vear or this year from which to reimburse the County.

mates of last year or this year from which to reinburse the County. 3.—A claim against District No. 22 for maintenance at the County Poor Farm for one Ann Keefe is rejudiated by the Overseers of that District, on the grounds that she should not have been admitted there.

4.—A claim for maintenance of Mrs. Harriet Smith, District 30, who was admitted to the County Poor Farm, is also disputed by the Overseers of said District on the same ground.

5.-Your Committee desire instructions as to what shall be done in these cases.

THE REPORT OF COMMITTEE ON ASSESSMENTS.

Your Committee beg to report respecting the Collections of Rates for 1894, and the Valuations returned by the Assessors for 1895, as follows:-

1.—That more care should be exercised by the Assessors in several Districts, in order to avoid errors, omissions and incorrect valuations in making up the Assessments. The County Clerk complains of numerous changes having to be made in the Rolls after their reception, by which the Voters' Lists, School Assessments, Government Returns, Statute Labor Lists, and Collectors' Rolls, made up from them at the regular times, are incomplete and misleading. From the same causes the deficits in Collections of County and Poor Rates are often greater than need be.

2.—Your Committee call special attention to the delay on the part of Collectors in taking out Warrants of Distress at the time fixed by Law and the By-Laws. By delaying too long in enforcing payment from dilatory

Ratepayers the Treasurer is prevented from an early issue of the Collectors' next Roll, and a large amount for deficits has to be added thereto each year.

3.—In a test case before the County Stipendiary, it is shown that these Warrants must be issued by a Justice of the Peace in the Districts where the defaulter's property lies, except in Districts where there is no resident J. P. In that event the County Stipendiary can issue the Warrant. 4.—We recommend that Legislation be asked for to remedy this mat-

ter, or provide means whereby the difficulty attending it may be obviated.

5.-Subjoined is a statement of Deficits to present date, which we are, pleased to report are in the aggregate much less than usual.
